SUMMARY—Revises statutory liability of corporate stockholders, directors and officers and increases fees for filing certain documents with secretary of state. (BDR 7-1547)

AN ACT relating to business associations; revising the statutory liability of the stockholders, directors and officers of a corporation; increasing the fees and revising certain requirements for filing certain documents with the secretary of state; requiring certain fees charged by the secretary of state for special services to be deposited in the state general fund; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 78 of NRS is hereby amended by adding thereto a
2 new section to read as follows:
3 ***1. Except as otherwise provided by specific statute, no stockholder,***
4 ***director or officer of a corporation is individually liable for a debt or***
5 ***liability of the corporation, unless the stockholder, director or officer acts***
6 ***as the alter ego of the corporation.***
7 ***2. A stockholder, director or officer acts as the alter ego of a***
8 ***corporation if:***
9 ***(a) The corporation is influenced and governed by the stockholder,***
10 ***director or officer;***
11 ***(b) There is such unity of interest and ownership that the corporation***
12 ***and the stockholder, director or officer are inseparable from each other;***
13 ***and***
14 ***(c) Adherence to the corporate fiction of a separate entity would***
15 ***sanction fraud or promote a manifest injustice.***

1 **3. The question of whether a stockholder, director or officer acts as**
2 **the alter ego of a corporation must be determined by the court as a**
3 **matter of law.**

4 **Sec. 1.5.** NRS 78.0295 is hereby amended to read as follows:

5 78.0295 1. A corporation may correct a document filed by the
6 secretary of state with respect to the corporation if the document contains
7 an inaccurate record of a corporate action described in the document or was
8 defectively executed, attested, sealed, verified or acknowledged.

9 2. To correct a document, the corporation shall:

10 (a) Prepare a certificate of correction which:

11 (1) States the name of the corporation;

12 (2) Describes the document, including, without limitation, its filing
13 date;

14 (3) Specifies the inaccuracy or defect;

15 (4) Sets forth the inaccurate or defective portion of the document in
16 an accurate or corrected

17 form; and

18 (5) Is signed by an officer of the corporation.

19 (b) Deliver the certificate to the secretary of state for filing.

20 (c) Pay a filing fee of ~~[\$75]~~ **\$150** to the secretary of state.

21 3. A certificate of correction is effective on the effective date of the
22 document it corrects except as to persons relying on the uncorrected
23 document and adversely affected by the correction. As to those persons, the
24 certificate is effective when filed.

48 statements, including financial statements and other financial data, that are
49 prepared or presented by:

- 1 (a) One or more directors, officers or employees of the corporation
2 reasonably believed to be reliable and competent in the matters prepared or

6 be within the preparer's or presenter's professional or expert competence;
7 or
- 8 (c) A committee on which the director or officer relying thereon does
9 not serve, established in accordance with NRS 78.125, as to matters within
10 the committee's designated authority and matters on which the committee
11 is reasonably believed to merit confidence,
12 but a director or officer is not entitled to rely on such information,
13 opinions, reports, books of account or statements if he has knowledge
14 concerning the matter in question that would cause reliance thereon to be
15 unwarranted.
- 16 3. Directors and officers, in deciding upon matters of business, are
17 presumed to act in good faith, on an informed basis and with a view to the
18 interests of the corporation.
- 19 4. Directors and officers, in exercising their respective powers with a
20 view to the interests of the corporation, may consider:
- 21 (a) The interests of the corporation's employees, suppliers, creditors and
22 customers;
- 23 (b) The economy of the state and nation;
- 24 (c) The interests of the community and of society; and
- 25 (d) The long-term as well as short-term interests of the corporation and
26 its stockholders, including the possibility that these interests may be best
27 served by the continued independence of the corporation.
- 28 5. Directors and officers are not required to consider the effect of a
29 proposed corporate action upon any particular group having an interest in
30 the corporation as a dominant factor.
- 31 6. The provisions of subsections 4 and 5 do not create or authorize any
32 causes of action against the corporation or its directors or officers.
- 33 7. *Except as otherwise provided in NRS 35.230, 90.660, 91.250,*
34 *452.200, 452.270, 668.045 and 694A.030, a director or officer is not*
35 *individually liable to the corporation or its stockholders for any damages*
36 *as a result of any act or failure to act in his capacity as a director or*
37 *officer unless it is proven that:*
- 38 *(a) His act or failure to act constituted a breach of his fiduciary duties*
39 *as a director or officer; and*
- 40 *(b) His breach of those duties involved intentional misconduct, fraud*

44 shall, on or before the first day of the second month after the filing of its
45 articles of incorporation with the secretary of state, file with the secretary
46 of state a list, on a form furnished by him, containing:
- 47 (a) The name of the corporation;
- 48 (b) The file number of the corporation, if known;

44 **Sec. 5.** NRS 78.155 is hereby amended to read as follows:

47 78.150 and has paid the appropriate fee for the filing, the canceled check
48 received by the corporation constitutes a certificate authorizing it to
49 transact its business within this state until the last day of the month in

2 calendar year. If the corporation desires a formal certificate upon its
3 payment of the initial or annual fee, its payment must be accompanied by a

12 **Sec. 7.** NRS 78.180 is hereby amended to read as follows:

13 78.180 1. Except as otherwise provided in subsections 3 and 4, the
14 secretary of state shall reinstate a corporation which has forfeited its right
15 to transact business pursuant to the provisions of this chapter and restore to
16 the corporation its right to carry on business in this state, and to exercise its
17 corporate privileges and immunities, if it:

18 (a) Files with the secretary of state the list required by NRS 78.150; and

19 (b) Pays to the secretary of state:

20 (1) The ~~annual~~ filing fee and penalty set forth in NRS 78.150 and
21 78.170 for each year or portion thereof during which it failed to file each
22 required annual list in a timely manner; and

23 (2) A fee of ~~(\$50)~~ **\$200** for reinstatement.

24 2. When the secretary of state reinstates the corporation, he shall:

31 delinquent fees and penalties have been paid, and the revocation of the
32 charter occurred only by reason of failure to pay the fees and penalties.

33 4. If a corporate charter has been revoked pursuant to the provisions of
34 this chapter and has remained revoked for a period of 5 consecutive years,
35 the charter must not be reinstated.

36 **Sec. 8.** NRS 78.300 is hereby amended to read as follows:

37 78.300 1. The directors of a corporation shall not make distributions
38 to stockholders except as provided by this chapter.

39 2. ~~But~~ **Except as otherwise provided in subsection 3 and NRS 78.138,**
40 **in** case of any ~~willful or grossly negligent~~ violation of the provisions of
41 this section, the directors under whose administration the violation
42 occurred ~~except those who caused their dissent to be entered upon the~~
43 ~~minutes of the meeting of the directors at the time, or who not then being~~
44 ~~present caused their dissent to be entered on learning of such action,~~ are
45 jointly and severally liable, at any time within 3 years after each violation,
46 to the corporation, and, in the event of its dissolution or insolvency, to its
47 creditors at the time of the violation, or any of them, to the lesser of the full

6 **Sec. 8.5.** NRS 78.390 is hereby amended to read as follows:

7 78.390 1. Every amendment adopted pursuant to the provisions of
8 NRS 78.385 must be made in the following manner:

9 (a) The board of directors must adopt a resolution setting forth the
10 amendment proposed and declaring its advisability, and either call a special
11 meeting of the stockholders entitled to vote on the amendment or direct
12 that the proposed amendment be considered at the next annual meeting of
13 the stockholders entitled to vote on the amendment.

14 (b) At the meeting, of which notice must be given to each stockholder
15 entitled to vote pursuant to the provisions of this section, a vote of the
16 stockholders entitled to vote in person or by proxy must be taken for and
17 against the proposed amendment. If it appears upon the canvassing of the
18 votes that stockholders holding shares in the corporation entitling them to
19 exercise at least a majority of the voting power, or such greater proportion
20 of the voting power as may be required in the case of a vote by classes or
21 series, as provided in subsections 2 and 4, or as may be required by the
22 provisions of the articles of incorporation, have voted in favor of the
23 amendment, an officer of the corporation shall sign a certificate setting
24 forth the amendment, or setting forth the articles of incorporation as
25 amended, and the vote by which the amendment was adopted.

26 (c) The certificate so signed must be filed with the secretary of state.

27 2. If any proposed amendment would adversely alter or change any
28 preference or any relative or other right given to any class or series of
29 outstanding shares, then the amendment must be approved by the vote, in
30 addition to the affirmative vote otherwise required, of the holders of shares
31 representing a majority of the voting power of each class or series
32 adversely affected by the amendment regardless of limitations or
33 restrictions on the voting power thereof.

34 3. Provision may be made in the articles of incorporation requiring, in
35 the case of any specified amendments, a larger proportion of the voting
36 power of stockholders than that required by this section.

37 4. Different series of the same class of shares do not constitute
38 different classes of shares for the purpose of voting by classes except when
39 the series is adversely affected by an amendment in a different manner than
40 other series of the same class.

41 5. The resolution of the stockholders approving the proposed
42 amendment may provide that at any time before the effective date of the
43 amendment, notwithstanding approval of the proposed amendment by the
44 stockholders, the board of directors may, by resolution, abandon the
45 proposed amendment without further action by the stockholders.

46 6. A certificate filed pursuant to subsection 1 becomes effective upon
47 filing with the secretary of state or upon a later date specified in the
48 certificate, which must not be later than 90 days after the certificate is filed.

1 7. If a certificate filed pursuant to subsection 1 specifies an effective
2 date and if the resolution of the stockholders approving the proposed
3 amendment provides that the board of directors may abandon the proposed
4 amendment pursuant to subsection 5, the board of directors may terminate
5 the effectiveness of the certificate by resolution and by filing a certificate
6 of termination with the secretary of state that:

7 (a) Is filed before the effective date specified in the certificate filed
8 pursuant to subsection 1;

9 (b) Identifies the certificate being terminated;

10 (c) States that, pursuant to the resolution of the stockholders, the board
11 of directors is authorized

12 to terminate the effectiveness of the certificate;

13 (d) States that the effectiveness of the certificate has been terminated;

14 (e) Is signed by an officer of the corporation; and

15 (f) Is accompanied by a filing fee of ~~\$75~~ **\$150**.

19 completed action, suit or proceeding, whether civil, criminal,
20 administrative or investigative, except an action by or in the right of the
21 corporation, by reason of the fact that he is or was a director, officer,
22 employee or agent of the corporation, or is or was serving at the request of
23 the corporation as a director, officer, employee or agent of another
24 corporation, partnership, joint venture, trust or other enterprise, against
25 expenses, including attorneys' fees, judgments, fines and amounts paid in
26 settlement actually and reasonably incurred by him in connection with the
27 action, suit or proceeding if he ~~acted~~ ;

28 **(a) Is not liable pursuant to NRS 78.138; or**

29 **(b) Acted** in good faith and in a manner which he reasonably believed to
30 be in or not opposed to the best interests of the corporation, and, with

48 including amounts paid in settlement and attorneys' fees actually and

10 that the court in which the action or suit was brought or other court of

13 indemnity for such expenses as the court deems proper.

15 corporation has been successful on the merits or otherwise in defense of

18 indemnify him against expenses, including attorneys' fees, actually and
19 reasonably incurred by him in connection with the defense.

40 3. For the purposes of computing the filing fees according to the
41 schedule in subsection 1, the amount represented by the total number of
42 shares provided for in the articles of incorporation is:

43 (a) The aggregate par value of the shares, if only shares with a par value
44 are therein provided for;

45 (b) The product of the number of shares multiplied by \$1, regardless of
46 any lesser amount prescribed as the value or consideration for which shares
47 may be issued and disposed of, if only shares without par value are therein

1 (c) The aggregate par value of the shares with a par value plus the

12 78.765 1. The fee for filing a certificate changing the number of
13 authorized shares pursuant to NRS 78.209 or a certificate of amendment to
14 articles of incorporation that increases the corporation's authorized stock or
15 a certificate of correction that increases the corporation's authorized stock
16 is the difference between the fee computed at the rates specified in NRS
17 78.760 upon the total authorized stock of the corporation, including the
18 proposed increase, and the fee computed at the rates specified in NRS

27 4. The fee for filing a certificate of termination pursuant to NRS

29 **Sec. 12.** NRS 78.767 is hereby amended to read as follows:

30 78.767 1. The fee for filing a certificate of restated articles of
31 incorporation that does not increase the corporation's authorized stock is
32 ~~150~~ **150**.

33 2. The fee for filing a certificate of restated articles of incorporation
34 that increases the corporation's authorized stock is the difference between
35 the fee computed pursuant to NRS 78.760 based upon the total authorized
36 stock of the corporation, including the proposed increase, and the fee
37 computed pursuant to NRS 78.760 based upon the total authorized stock of
38 the corporation, excluding the proposed increase. In no case may the
39 amount be less than ~~150~~ **150**.

40 **Sec. 13.** NRS 78.780 is hereby amended to read as follows:

43 computed at the rates specified in NRS 78.760 for filing articles of
44 incorporation.

45 2. The fee for filing a certificate of dissolution whether it occurs before
46 or after payment of capital and beginning of business is ~~60~~ **60**.
