SUMMARY—Makes various changes to provisions relating to use of design-build teams on public works projects. (BDR 28-99)

AN ACT relating to public works projects; authorizing certain public bodies to contract with a design-build team for certain public works projects; removing certain requirements for providing notice of certain hearings; removing certain requirements for advertising for preliminary proposals from design-build teams for certain projects; changing certain requirements for the contents of a request for preliminary proposals; authorizing a public body and the department of transportation to select finalists for submitting a final proposal within a certain period; requiring a public body and the department of transportation to consider the degree to which a preliminary proposal is responsive to certain requirements when selecting finalists; changing certain requirements for a request for final proposals; removing the date for expiration of provisions relating to the use of design-build teams on public works projects; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 338.1385 is hereby amended to read as follows:
2 338.1385 1. Except as otherwise provided in subsection ~~7 and~~
3 ~~NRS 338.1906 and 338.1907,~~ 8, this state, or a local government that
4 awards a contract for the construction, alteration or repair of a public work
5 in accordance with paragraph (a) of subsection 1 of NRS 338.1373, or a
6 public officer, public employee or other person responsible for awarding a
7 contract for the construction, alteration or repair of a public work who
8 represents the state or the local government, shall not:
9 (a) Commence such a project for which the estimated cost exceeds
10 \$100,000 unless it advertises in a newspaper of general circulation in this
11 state for bids for the project; or

1 (b) Divide such a project into separate portions to avoid the
2 requirements of paragraph (a).

3 2. Except as otherwise provided in subsection ~~77~~ 8, a public body that
4 maintains a list of properly licensed contractors who are interested in
5 receiving offers to bid on public works projects for which the estimated
6 cost is more than \$25,000 but less than \$100,000 shall solicit bids from not
7 more than three of the contractors on the list for a contract of that value for
8 the construction, alteration or repair of a public work. The public body
9 shall select contractors from the list in such a manner as to afford each
10 contractor an equal opportunity to bid on a public works project. A
11 properly licensed contractor must submit a written request annually to the
12 public body to remain on the list. Offers for bids which are made pursuant
13 to this subsection must be sent by certified mail.

14 3. Each advertisement for bids must include a provision that sets forth:

15 (a) The requirement that a contractor must be qualified pursuant to NRS
16 338.1379 to bid on the contract or must be exempt from meeting such
17 qualifications pursuant to NRS 338.1383; and

18 (b) The period during which an application to qualify as a bidder on the
19 contract must be submitted.

20 4. Approved plans and specifications for the bids must be on file at a
21 place and time stated in the advertisement for the inspection of all persons
22 desiring to bid thereon and for other interested persons. Contracts for the
23 project must be awarded on the basis of bids received.

24 5. Any bids received in response to an advertisement for bids may be
25 rejected if the person responsible for awarding the contract determines that:

26 (a) The bidder is not a qualified bidder pursuant to NRS 338.1379,
27 unless the bidder is exempt from meeting such qualifications pursuant to
28 NRS 338.1383;

29 (b) The bidder is not responsive;

30 (c) The quality of the services, materials, equipment or labor offered
31 does not conform to the approved plan or specifications; or

32 (d) The public interest would be served by such a rejection.

33 6. Before the state or a local government may commence a project
34 subject to the provisions of this section, based upon a determination that
35 the public interest would be served by rejecting any bids received in
36 response to an advertisement for bids, it shall prepare and make available
37 for public inspection a written statement containing:

38 (a) A list of all persons, including supervisors, whom the state or the
39 local government intends to assign to the project, together with their
40 classifications and an estimate of the direct and indirect costs of their labor;

41 (b) A list of all equipment that the state or the local government intends
42 to use on the project, together with an estimate of the number of hours each
43 item of equipment will be used and the hourly cost to use each item of
44 equipment;

45 (c) An estimate of the cost of administrative support for the persons
46 assigned to the project;

47 (d) An estimate of the total cost of the project; and

1 (e) An estimate of the amount of money the state or the local
2 government expects to save by rejecting the bids and performing the
3 project itself.

4 7. *In preparing the estimated cost of a project pursuant to*
5 *subsection 6, the state or a local government must include the fair market*
6 *value of, or, if known, the actual cost of, all materials, supplies, labor*
7 *and equipment to be used for the project.*

8 8. This section does not apply to:

9 (a) Any utility subject to the provisions of chapter 318 or 710 of NRS;

10 (b) Any work of construction, reconstruction, improvement and
11 maintenance of highways subject to NRS 408.323 or 408.327;

12 (c) Normal maintenance of the property of a school district;

13 (d) The Las Vegas Valley water district created pursuant to chapter 167,
14 Statutes of Nevada 1947, the Moapa Valley water district created pursuant
15 to chapter 477, Statutes of Nevada 1983 or the Virgin Valley water district
16 created pursuant to chapter 100, Statutes of Nevada 1993; or

17 (e) The design and construction of a public work for which a public
18 body contracts with a design-build team pursuant to NRS 338.1711 to
19 338.1727, inclusive.

20 **Sec. 2.** NRS 338.1389 is hereby amended to read as follows:

21 338.1389 1. Except as otherwise provided in NRS 338.1385 and
22 338.1711 to 338.1727, inclusive, a public body shall award a contract for a
23 public work to the contractor who submits the best bid.

24 2. Except as otherwise provided in subsection 8 or limited by
25 subsection 9, for the purposes of this section, a contractor who:

26 (a) Has been determined by the public body to be a qualified bidder
27 pursuant to NRS 338.1379 or is exempt from meeting such requirements
28 pursuant to NRS 338.1373 or 338.1383; and

29 (b) At the time he submits his bid, provides to the public body a copy of
30 a certificate of eligibility to receive a preference in bidding on public works
31 issued to him by the state contractors' board pursuant to subsection 3,
32 shall be deemed to have submitted a better bid than a competing contractor
33 who has not provided a copy of such a valid certificate of eligibility if the
34 amount of his bid is not more than 5 percent higher than the amount bid by
35 the competing contractor.

23 the contractor has in the joint venture.
24 5. A contractor who has received a certificate of eligibility to receive a
25 preference in bidding on public works from the state contractors' board
26 pursuant to subsection 3 shall, at the time for the annual renewal of his
27 contractors' license pursuant to NRS 624.283, submit to the board an
28 affidavit from a certified public accountant setting forth that the contractor
29 has, during the immediately preceding 12 months, paid the taxes required
30 pursuant to paragraph (a) of subsection 3 to maintain his eligibility to hold
31 such a certificate.
32 6. A contractor who fails to submit an affidavit to the board pursuant
33 to subsection 5 ceases to be eligible to receive a preference in bidding on
34 public works unless he reapplies for and receives a certificate of eligibility
35 pursuant to subsection 3.
36 7. If a contractor who applies to the state contractors' board for a
37 certificate of eligibility to receive a preference in bidding on public works
38 submits false information to the board regarding the required payment of
39 taxes, the contractor is not eligible to receive a preference in bidding on

7 11. A person or entity who believes that a contractor wrongfully holds
8 a certificate of eligibility to receive a preference in bidding on public works
9 may challenge the validity of the certificate by filing a written objection
10 with the public body to which the contractor has submitted a bid or
11 proposal on a contract for the construction of a public work. A written
12 objection authorized pursuant to this subsection must:

13 (a) Set forth proof or substantiating evidence to support the belief of the
14 person or entity that the contractor wrongfully holds a certificate of

19 and construction of a public work that is a discrete project if the public
20 body determines that:

21 (a) The public work is:

22 (1) A plant or facility for the treatment and pumping of water or the
23 treatment and disposal of wastewater or sewage, the estimated cost of
24 which exceeds \$100,000,000; or

25 (2) Any other type of public work, except a stand-alone underground
26 utility project, the estimated cost of which exceeds \$30,000,000; and

27 (b) Contracting with a design-build team will enable the public body to:

28 (1) Design and construct the public work at a cost that is significantly
29 lower than the cost that the public body would incur to design and
30 construct the public work using a different method;

31 (2) Design and construct the public work in a shorter time than would
32 be required to design and construct the public work using a different
33 method, if exigent circumstances require that the public work be designed
34 and constructed within a short time; or

35 (3) Ensure that the design and construction of the public work is

Except as otherwise provided in subsection 6, a local government that maintains a list of properly licensed contractors who are interested in receiving offers to bid on public works projects for which the estimated cost is more than \$25,000 but less than \$100,000 shall solicit bids from not more than three of the contractors on the list for a contract of that value for the construction, alteration or repair of a public work. The local government shall select contractors from the list in such a manner as to afford each contractor an equal opportunity to bid on a public works project. A properly licensed contractor must submit a written request annually to the local government to remain on the list. Offers for bids which are made pursuant to this subsection must be sent by certified mail.

3. Approved plans and specifications for the bids must be on file at a place and time stated in the advertisement for the inspection of all persons desiring to bid thereon and for other interested persons. Contracts for the project must be awarded on the basis of bids received.
