SUMMARY—Provides formula to calculate salaries of officers of Nevada highway patrol of
department of motor vehicles and public safety. (BDR 23-750)

AN ACT relating to the Nevada highway patrol; requiring the director of the department of
personnel to calculate the average salaries of certain law enforcement personnel;
requiring the proposed budget of the department of motor vehicles and public
safety to include salaries for officers of the Nevada highway patrol which are
based on those calculations; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 284 of NRS is hereby amended by adding thereto a
2 new section to read as follows:
3 1. *The director shall calculate the respective average salaries as of*
4 *July 1 of each even-numbered year of all police officers of equivalent*
5 *rank employed by:*
6 (a) *Law enforcement agencies of cities whose populations are 50,000*
7 *or more;*
8 (b) *Law enforcement agencies of counties whose populations are*
9 *100,000 or more; and*
10 (c) *Metropolitan police departments formed pursuant to chapter 280*
11 *of NRS in counties whose populations are 100,000 or more.*
12 2. *The director shall forward the figures of the average salaries*
13 *calculated pursuant to subsection 1 to the chief of the budget division of*
14 *the department of administration and the director of the department of*
15 *motor vehicles and public safety not later than July 15 of each even-*
16 *numbered year.*



1 **Sec. 2.** Chapter 353 of NRS is hereby amended by adding thereto a
2 new section to read as follows:

3 **1.** *In preparing the proposed biennial budget of the department of*
4 *motor vehicles and public safety, the director of the department shall*
5 *establish the respective salaries of the officers of the Nevada highway*
6 *patrol at amounts which:*

7 **(a)** *For the first year of the biennium, are equal to or greater than the*
8 *average salary of police officers of equivalent rank as calculated by the*
9 *director of the department of personnel pursuant to section 1 of this act;*
10 *and*

11 **(b)** *For the second year of the biennium, are equal to the respective*
12 *amounts proposed pursuant to paragraph (a), plus an adjustment for*
13 *inflation, if any. The amount of the adjustments must be determined by*
14 *multiplying the respective amounts proposed pursuant to paragraph (a)*
15 *by the percentage of inflation, if any. The Consumer Price Index*
16 *published by the United States Department of Labor for July preceding*
17 *each biennium must be used to determine the percentage of inflation.*

18 **2.** *In preparing the proposed executive budget, the chief shall ensure*
19 *that the salaries of the officers of the Nevada highway patrol, as included*
20 *in the proposed budget of the department of motor vehicles and public*
21 *safety, are established in accordance with the provisions of subsection 1.*

22 **Sec. 3.** NRS 353.150 is hereby amended to read as follows:

23 353.150 NRS 353.150 to 353.246, inclusive, *and section 2 of this act,*
24 may be cited as the State Budget Act.

25 **Sec. 4.** Not later than 10 days after the effective date of this act, the
26 director of the department of personnel shall:

27 1. Calculate the average salaries paid to police officers as of July 1,
28 2000, pursuant to section 1 of this act; and

29 2. Forward the figures of the average salaries calculated pursuant to
30 subsection 1 to:

31 (a) The chairman of the senate standing committee on finance;

32 (b) The chairman of the assembly standing committee on ways and
33 means; and

34 (c) The fiscal analysis division of the legislative counsel bureau.
