

SENATE BILL NO. 91—COMMITTEE ON COMMERCE AND LABOR

FEBRUARY 8, 2001

Referred to Committee on Commerce and Labor

SUMMARY—Makes various changes to provisions governing practice of medicine and respiratory care. (BDR 54-290)

AN ACT relating to medicine; changing the designation of physician's assistant; revising the scope of authority and duties of the board of medical examiners; providing for the issuance of special purpose licenses; requiring the board of medical examiners to regulate the practice of respiratory care; requiring practitioners of respiratory care to be licensed by the board of medical examiners; revising the qualifications and requirements relating to licensure of physicians and physicians' assistants; revising the duties and scope of authority of persons licensed by the board of medical examiners; making certain actions subject to disciplinary action by the board of medical examiners; revising provisions governing the imposition of disciplinary action against licensees; establishing and revising certain fees; increasing certain penalties; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 630 of NRS is hereby amended by adding thereto
- 2 the provisions set forth as sections 2 to 9, inclusive, of this act.
- 3 **Sec. 2. *"Practice of respiratory care" includes:***
- 4 ***1. Therapeutic and diagnostic use of medical gases, humidity and***
- 5 ***aerosols and the maintenance of associated apparatus;***
- 6 ***2. The administration of drugs and medications to the***
- 7 ***cardiopulmonary system;***
- 8 ***3. The provision of ventilatory assistance and control;***
- 9 ***4. Postural drainage and percussion, breathing exercises and other***
- 10 ***respiratory rehabilitation procedures;***
- 11 ***5. Cardiopulmonary resuscitation and maintenance of natural***
- 12 ***airways and the insertion and maintenance of artificial airways;***
- 13 ***6. Carrying out the written orders of a physician, physician assistant***
- 14 ***or an advanced practitioner of nursing relating to respiratory care;***



- 1 7. *Techniques for testing to assist in diagnosis, monitoring, treatment*
2 *and research related to respiratory care, including the measurement of*
3 *ventilatory volumes, pressures and flows, collection of blood and other*
4 *specimens, testing of pulmonary functions and hemodynamic and other*
5 *related physiological monitoring of the cardiopulmonary system; and*
6 8. *Training relating to the practice of respiratory care.*
7 **Sec. 3.** *“Practitioner of respiratory care” means a person who is:*
8 1. *Certified to engage in the practice of respiratory care by the*
9 *National Board for Respiratory Care or its successor organization; and*
10 2. *Licensed by the board.*
11 **Sec. 4.** *“Respiratory care” means the treatment, management,*
12 *diagnostic testing, control and care of persons with deficiencies and*
13 *abnormalities associated with the cardiopulmonary system. The term*
14 *includes inhalation and respiratory therapy.*
15 **Sec. 5.** *For the purposes of this chapter, any act that constitutes the*
16 *practice of medicine shall be deemed to occur at the place where the*
17 *patient is located at the time the act is performed.*
18 **Sec. 6.** *The practice of respiratory care must be performed under the*
19 *direction of or pursuant to a prescription from a physician licensed to*
20 *practice in this state, any other state, any territory of the United States or*
21 *the District of Columbia.*
22 **Sec. 7.** 1. *Every person who wishes to practice respiratory care in*
23 *this state must:*
24 (a) *Have a high school diploma or general equivalency diploma;*
25 (b) *Complete an educational program for respiratory care which has*
26 *been approved by the National Board for Respiratory Care or its*
27 *successor organization;*
28 (c) *Pass the examination as an entry-level or advanced practitioner of*
29 *respiratory care administered by the National Board for Respiratory Care*
30 *or its successor organization;*
31 (d) *Be certified by the National Board for Respiratory Care or its*
32 *successor organization; and*
33 (e) *Be licensed to practice respiratory care by the board and have paid*
34 *the required fee for licensure.*
35 2. *Except as otherwise provided in subsection 3, a person shall not:*
36 (a) *Practice respiratory care; or*
37 (b) *Hold himself out as qualified to practice respiratory care,*
38 *in this state without complying with the provisions of subsection 1.*
39 3. *Any person who has completed the educational requirements set*
40 *forth in paragraphs (a) and (b) of subsection 1 may practice respiratory*
41 *care pursuant to a program of practical training as an intern in*
42 *respiratory care for not more than 12 months after completing those*
43 *educational requirements.*
44 **Sec. 8.** *An application for a license as a practitioner of respiratory*
45 *care must include the social security number of the applicant.*
46 **Sec. 9.** *The board shall adopt regulations regarding the licensure of*
47 *practitioners of respiratory care, including, without limitation:*
48 1. *Educational and other qualifications of applicants;*



- 1 2. *Required academic programs which applicants must successfully*
- 2 *complete;*
- 3 3. *Procedures for applying for and issuing licenses;*
- 4 4. *Tests or examinations of applicants by the board;*
- 5 5. *The types of medical services that a practitioner of respiratory care*
- 6 *may perform, except that a practitioner of respiratory care may not*
- 7 *perform those specific functions and duties delegated or otherwise*
- 8 *restricted by specific statute to persons licensed as dentists, chiropractors,*
- 9 *podiatric physicians, optometrists, physicians, osteopathic physicians or*
- 10 *hearing aid specialists pursuant to this chapter or chapter 631, 633, 634,*
- 11 *635, 636 or 637A of NRS, as appropriate;*
- 12 6. *The duration, renewal and termination of licenses; and*
- 13 7. *The grounds and procedures for disciplinary actions against*
- 14 *practitioners of respiratory care.*
- 15 **Sec. 10.** NRS 630.003 is hereby amended to read as follows:
- 16 630.003 The legislature finds and declares that it is among the
- 17 responsibilities of state government to ensure, as far as possible, that only
- 18 competent persons practice medicine *and respiratory care* within this state.
- 19 For this purpose, the legislature delegates to the board of medical
- 20 examiners the duty of determining the initial and continuing competence of
- 21 doctors of medicine , *physician assistants and practitioners of respiratory*
- 22 *care* in this state. The powers conferred upon the board by this chapter
- 23 must be liberally construed to carry out this purpose.
- 24 **Sec. 11.** NRS 630.005 is hereby amended to read as follows:
- 25 630.005 As used in this chapter, unless the context otherwise requires,
- 26 the words and terms defined in NRS 630.010 to 630.025, inclusive, *and*

- 33 satisfactory by the board, is qualified to perform medical services under the
- 34 supervision of a supervising physician and who has been issued a license

- 44 public health and safety and the general welfare of the people of this state.
- 45 Any license issued pursuant to this chapter is a revocable privilege and no
- 46 holder of such a license acquires thereby any vested right.

- 25 (1) *Is enrolled in a clinical program of study in respiratory care*
26 *which has been approved by the board;*
- 27 (2) *Is employed by a medical facility, as defined in NRS 449.0151;*

- 29 (3) *Provides respiratory care to patients who are not in a critical*
30 *medical condition or, in an emergency, to patients who are in a critical*
31 *medical condition and a practitioner of respiratory care is not*
32 *immediately available to provide that care and the student is directed by a*
33 *physician to provide respiratory care under his supervision until a*
34 *practitioner of respiratory care is available;*
- 35 (g) *The practice of respiratory care by a person on himself or*
36 *gratuitous respiratory care provided to a friend or a member of a*
37 *person's family if the provider of the care does not represent himself as a*
38 *practitioner of respiratory care;*
- 39 (h) *A cardiopulmonary perfusionist who is under the supervision of a*
40 *surgeon or an anesthesiologist;*
- 41 (i) *A person who is employed by a physician and provides respiratory*
42 *care under the supervision of that physician;*
- 43 (j) *The maintenance of medical equipment for respiratory care that is*
44 *not attached to a patient; and*
- 45 (k) *A person who installs medical equipment for respiratory care that*
46 *is used in the home and gives instructions regarding the use of that*
47 *equipment if the person is trained to provide such services and is*
48 *supervised by a provider of health care who is acting within the*
49 *authorized scope of his practice.*

1 2. This chapter does not repeal or affect any statute of Nevada
2 regulating or affecting any other healing art.
3 3. This chapter does not prohibit:
4 (a) Gratuitous services outside of a medical school or medical facility
5 by a person who is not a physician , *physician assistant or practitioner of*
6 *respiratory care* in cases of emergency.
7 (b) The domestic administration of family remedies.

2 paragraph is not renewable.

3 *(e) A special purpose license to a physician who is licensed in another*
4 *state to permit the use of equipment that transfers information*
5 *concerning the medical condition of a patient in this state across state*
6 *lines electronically, telephonically or by fiber optics if the physician:*

7 *(1) Holds a full and unrestricted license to practice medicine in that*
8 *state;*

9 *(2) Has not had any disciplinary or other action taken against him*
10 *by any state or other jurisdiction; and*

11 *(3) Meets the requirement set forth in paragraph (d) of subsection 2*
12 *of NRS 630.160.*

13 2. *Except as otherwise provided in this section, the board may renew*
