SENATE CONCURRENT RESOLUTION—Endorsing the creation of business divisions of the district courts in the Second and Eighth Judicial Districts through the adoption of court rules developed by the Business Court Task Force.

1 WHEREAS, The State of Delaware has been recognized for its efficient
2 and professional Court of Chancery, which resolves commercial and
3 corporate matters and which has earned international prominence in the
4 areas of corporate, business and commercial law; and

5 WHEREAS, The creation of business courts modeled after the Court of
6 Chancery has proven successful in other states for facilitating the prompt
7 and final resolution of disputes, thereby eliminating the delay in litigation
8 found in courts of general jurisdiction; and

9 WHEREAS, The limited jurisdiction of such courts promotes greater
10 specialization to ensure that disputes are heard by judges with experience
11 and expertise in complex commercial and corporate matters; and

12 WHEREAS, The establishment of business courts as divisions of the
13 district courts in the Second and Eighth Judicial Districts will contribute to
14 the development and stability of corporate and business law, will ensure
15 consistency in decisions and expertise in the disposition of complex
16 commercial and corporate matters and will make this state a more
17 attractive location in which to organize and conduct business; and

18 WHEREAS, The members of the Business Court Task Force have,
19 through extensive deliberation and analysis, developed court rules
20 providing for the creation of business courts as divisions of the district
21 courts in the Second and Eighth Judicial Districts and prescribing their
22 jurisdiction and procedures; now, therefore, be it

24 CONCURRING, That the members of the 71st Session of the Nevada
