SENATE CONCURRENT RESOLUTION—Proclaiming September 15 through September 21, 2001, as Nevada Mediation Week.

1 WHEREAS, The resolution of disputes can be divisive, costly, time-
2 consuming and complex when achieved through litigation and formal court
3 proceedings in which parties are adversaries and subject to formalized
4 procedures; and

5 WHEREAS, Many persons desire alternatives to contentious litigation
6 conducted in the traditional setting of a courtroom; and

7 WHEREAS, Mediation is a form of alternative dispute resolution that
8 allows each party an opportunity to present his or her side of a dispute and,
9 with the help of a trained, impartial mediator, reach mutually satisfying
10 solutions; and

11 WHEREAS, Mediation offers an option for businesses, consumers,
12 families, landlords and tenants, neighborhoods and others to resolve
13 conflicts in an expeditious and cost-effective manner, as well as in a
14 manner that may preserve the relationship of the parties; and
