- 2 the passing of dedicated law enforcement officer Dennis Kollar on
- 3 April 19, 2001; and
- 4 WHEREAS, Dennis Michael Kollar was born in New Jersey and moved
- 5 with his family at 3 years of age to San Diego, California, where he lived
- 6 most of his life; and
- 7 WHEREAS, After graduating from high school, Dennis joined the United
- 8 States Army and served in the Vietnam War; and
- 9 WHEREAS, In 1969, Dennis joined the San Diego County Sheriff’s
- 10 Department and, known for his work ethic, quickly rose through the ranks,
- 11 leaving a legacy of service that included jail and patrol duty, the training of
- 12 other officers, internal affairs and the Narcotics Task Force; and
- 13 WHEREAS, Among his many distinctions, Dennis was the founding
- 14 Director of the Sheriff’s Academy at Southwestern College in



1 Chula Vista, California, which trained law enforcement officers at that
2 campus from 1984 to 1994; and

3 WHEREAS, Dennis retired from the San Diego County Sheriff's
4 Department as a captain after 25 years of dedicated service; and

5 WHEREAS, Opening a new administrative chapter in his law
6 enforcement career, Dennis moved to Nevada and spent the last 7 years in
7 Reno as Deputy Director for the Peace Officers' Standards and Training
8 Commission for this state; and

9 WHEREAS, Dennis was known for his wonderful sense of humor that
10 brought a smile to the face of anyone who needed it; and

11 WHEREAS, Dennis was an avid sports fan and a devoted father to his
12 three daughters, Renee, Colleen and Megan; and

13 WHEREAS, Dennis is survived by his daughters, his mother Catherine,
14 his sister and brother-in-law Mary Beth and Scott Ring, and their children,
15 Michael, Clinton, Emily, Nolan and Rebecca; now, therefore, be it
