PROPOSED AMENDMENT TO SENATE BILL NO. 132 MAY 23, 2003

SUMMARY—Establishes a joint study committee to conduct study relating to mold in residential and commercial buildings.

FISCAL NOTE: Effect on Local Government: No. Effect on the State: No.

Amend Senate Bill 132 by deleting sections 1-30 and inserting the following:

Section 1. 1. Study committee on residential and commercial mold contamination; duties; report

- 1. A joint study committee on residential and commercial mold contamination is hereby established, consisting of the following persons:
- a. The director of the Division of Industrial Relations or the director's designee.
- b. The commissioner of the department of insurance or the commissioner's designee.
- c. The Director of the State Environmental Commission.
- d. A person who represents residential building contractors and who is appointed by the speaker of the Assembly.
- e. A person who represents commercial building contractors; appointed by the president of the Senate.
- f. A person who represents subcontractors; appointed by the speaker of the Assembly.
- g. Two persons who represent homeowners. The speaker of the Assembly shall appoint one person and the president of the Senate shall appoint one person pursuant to this paragraph.
- h. A person who represents a provider of homeowner's insurance, appointed by the president of the Senate.
- i. One member from the Assembly who is appointed by the speaker of the Assembly.
- j. One member from the Senate who is appointed by the president of the Senate.
- k. A scientist who is trained in the health effects of mold appointed by the speaker of the Assembly.

- l. A registered professional engineer who specializes in residential and commercial design and who is appointed by the president of the Senate.
- m. A person who represents environmental consultants and who is appointed by the speaker of the Assembly.
- n. A person who represents analytical laboratories and who is appointed by the president of the Senate.
- Sec. 2. 1. The committee shall study financial, environmental, and health effects associated with contamination by molds in commercial and residential buildings and shall consider at least the following:
- a. Insurance coverage and liability issues for mold occurrences.
- b. Remediation methods and costs, including evaluation of costs that may be covered by insurance policies.
- c. Types of molds and standards for remediation of residential and commercial structures.
- 2. The member from the Assembly and the member from the Senate shall serve as chairpersons of the committee.
- 3. Members of the committee are not eligible for compensation or for reimbursement of expenses.
- 4. The committee may use the services of legislative staff as required.
- Sec. 3. The study committee shall make a report of its findings and shall submit its report, including any recommendations as to legislation or policy changes, by September 1, 2004, and shall provide a copy of this report to the Legislative Counsel Bureau, the Governor, the President of the Senate, and the Speaker of the Assembly.
- Sec. 4. This act becomes effective on July 1, 2003.
