

Nevada Arts Council

A division in the Department of Cultural Affairs, the Nevada Arts Council (NAC) was established as a state agency in 1967. A nine-member council, serving rotating terms of four years, oversees NAC policy and makes final decisions on grant allocations. Council members are appointed by the Governor of Nevada and are selected for their knowledge of and experience in the arts, and to ensure geographic and ethnic representation of all areas of the state. Staff develops and administers programs and projects that support the mission and goals of the agency.

The Nevada Arts Council complies with all local, state and federal laws and regulations concerning civil and human rights, including Title IV of the Civil Rights Act of 1964, Section 504 of the Rehabilitation Act of 1973, The Americans with Disabilities Act of 1990, Title IX of the Education Amendments of 1972 and the Age Discrimination Act of 1975. NAC ensures that its programs, grants, and employment practices are free of any discrimination based on race, color, national origin, disability, sex or age.

The Nevada Art Council is funded by the Nevada State Legislature, the National Endowment for the Arts, a federal agency, and other public and private sources.

Artists' Services Program

The Nevada Arts Council (NAC) encourages the work of Nevada artists of all disciplines through its Artists' Services Program. With a focus on the needs and concerns of the individual artist, the program components allow NAC to provide resources and technical assistance to, and communication with artists statewide.

Program Highlights 2001-2002

The work of four Nevada artists — Catherine Angel, Henderson; Robert Beckmann, Henderson; Paul Ford, Minden; and Christine Pinney Karkow, Reno — received accolades during **The De-Constructed West** exhibit at the Millennium Arts Center in Washington, D.C. Curated by Lowery Stokes Sims, director of the Studio Museum in Harlem, De-Constructed West featured 16 visual arts fellowship recipients from Idaho, Nevada, Utah, and Wyoming. The two-month winter exhibit was organized through the efforts of the four state arts councils in collaboration with the Millennium Arts Center.



Seven **Artist Feliowships** were awarded in Fiscal Year 2002, one more than usual, thanks to funding from the *Hilliard Endowment Fund* of Reno, which supported a third fellowship in Literary Art.

Created in 1988, Artist Fellowships provide financial support to Nevada's artists of merit. Since the program's inception, NAC has recognized the work of 86 actors, poets, sculptors, musicians, filmmakers, dancers, photographers, playwrights, choreographers, painters and writers, each with a \$5,000 fellowship award.

In addition to using the award to produce art during the fellowship year — spending more time in the studio, developing a marketing strategy or researching new techniques — each fellow provides a public presentation relevant to his or her discipline. The results of a fellowship year are shared with communities around the state through readings, exhibitions, performances and master classes that are free and open to the public.

Last spring panelists reviewed 178 applications — 85 in literary arts, 27 in performing arts and 66 in visual arts — and recommended seven artists to the Arts Council for FY02 fellowships. The review panels also recognized 14 finalists.

Night, the NAC's in-state traveling exhibition, provided a "canvas" for eight Nevada artists to create powerful and engaging works of art. Considering various aspects of the theme, including "night as a state of mind" and "night as a place in the heart," were Reno artists Michael Greenspan, Christine Karkow and Robert Morrison; Liedeke Bulder from Spring Creek, Gail Rappa from Tuscarora; and Fred Sigman with Charles Morgan, Yek Wong, and Almond Zigmund, all of Las Vegas. During FY02, the exhibit traveled to Carson City, Fallon, and Reno.

The Office eXhibition Series, **OXS**, featured visual artists in both Carson City and Las Vegas offices who have received recognition through various Nevada Arts Council programs. Represented were Las Vegas artists, Diane Bush, Ann Hoff, and Tom Umholtz; and Reno artists Christine Pinney Karkow, Erik Lauritzen, and Paula Morin.

At last year's **White House** holiday reception, four Nevadans were recognized for their unique ornaments created for the First Family's Christmas tree, along with artists from across the nation. Jill Atkins, Reno; Carol Folvary-Anderson, Carson City; Steven Liguori, Boulder City; and Dolores Nast, Las Vegas responded to Mrs. Bush's request to create miniature replicas of historic Nevada homes, illustrating the theme, "At Home for the Holidays."

Writers from Nevada and the western region presented 22 free readings, writing workshops, and lectures in communities throughout the state during the eighth season of **Tumblewords**, NAC's statewide literature project. Tumblewords was initiated in 1993 to increase awareness of literature as a vital art form by bringing together contemporary writers and new audiences. As well, Tumblewords increases the visibility of regional writers of note and Nevada contemporary writers who have been active in NAC programs or are recipients of grants and awards that acknowledge their artistic merit. Tumblewords is supported in part by the Western States Arts Federation.





Arts in Education Program

The Arts in Education (AIE) Program supports the goal of lifelong learning in the arts by promoting and expanding quality arts education opportunities for all Nevada citizens. Arts education helps students of all ages to develop essential life skills and problem-solving abilities that prepare them to succeed in our global, technology based society. The audiences of tomorrow are born in today's schools. Studies have shown that academic performance is enhanced with quality arts education programs. To encourage participation in the creative process, the components of the AIE Program include grants, statewide initiatives, and professional development opportunities.

Program Highlights 2001-2002


The Arts in Education Program went electronic in FY02 with **Culture Grants Online**. A project of the Western States Arts Federation, NAC's online grant application process was created with input from staff and constituents, and designed to help applicants create stronger and more competitive grants.



The Artist in Residence (AIR) Program places professional artists in schools, public institutions and communities for one week to four months at a time. These residencies enable students and others to participate in the creative process with artists in varied disciplines through workshops and other methods of direct engagement. Two examples of FY02 residencies are:

mlay Elementary sponsored a 10-day summer residency with visual artist Emily Silver, and two residencies during the school year with folk artist Norma Smokey and dancer Christian Swenson. Each artist worked with the teachers of this preschool through 5th grade school, as well as with students and community members.

M Lincoln County Arts Council sponsored residencies at six schools in three rural communities with storyteller John Beach, theater artist Deanna Duplechain, and musician Chris Bayer. All three artists focused on improving student writing skills.



Student response to artist residency with Sidne Teske, Battle Mountain


During the spring, eleven new artists were added to the **AIR roster** for FY 2003-2004. The roster provides AIR sponsors with a bank of 50 artists in the disciplines of creative writing, dance, folk arts, music, theater, storytelling, and visual arts. A panel of professional artists and educators reviewed applicant artists using criteria based on quality of work, the ability to share the creative process, and educational skills and experience.

Special Project Grants (SPG) for Schools and Organizations provide funding for first-time projects that integrate creative and innovative arts programming in school and non-school settings for populations of all ages. Examples of FY02 Special Projects include:

Reno's AREA-51 Dance Theatre created "Studio-51," a modern dance studio environment for atrisk teens intended to cultivate self-esteem, discipline and professional dance skills. Students participated in two modern dance classes per week for ten months, and received dancewear and transportation. The program culminated in a studio performance for family, friends and the community, and a performance in the "Conservatory of Movement's" recital, held in the Pioneer Center for the Performing Arts in Reno.

To enhance its reading program, Rex Bell Elementary in Las Vegas engaged author Dan Gutman as part of its project, "The Art of Baseball." Using a multidiscipline approach, students worked with Gutman to write baseball stories, learned about baseball themed music with the music teacher, and designed baseball cards with guidance from the art teacher.





Moapa Valley Arts Council rescued its school music programs by organizing a preparatory choir and two performing choirs, involving approximately 200 children, ages 5-14. Project goals were to provide a choral/vocal experience for students at critical stages of development; to cultivate community support for an elementary/middle school vocal program; to develop future arts audiences by fostering a greater appreciation for the arts through participation; and to develop a touring community children's choir to sustain the vocal program.



Professional Development Grants (PDG) for Educators and Teaching and Discovering the Arts (TADA) grants support professional development opportunities for teachers, artists who teach and arts administrators. Two of FY02 Professional Development projects were:

75 The arts resource person for elementary teachers at Reno's Smithridge Elementary School, Marye Anne Read, attended a one-week photography class to learn new techniques to share with her colleagues to enhance their literacy and art programs.

M Patricia Coyne attended the N.A.S.A. Space Camp to learn how to integrate science and theatre at Harley Harman Elementary School in Henderson.



The AIE program offers artists and educators varied professional development opportunities throughout the year—to network with other like-minded professionals, to attend skill-building workshops, and to discover new approaches to arts education. Last spring, seven AIE program and grant writing workshops were presented in Carson City, Reno, Las Vegas, Henderson, Elko, and Fallon. The Summer Arts Institute attracted participants from Winnemucca, Minden, Paradise Valley, Reno, and Las Vegas, who explored methods of integrating the arts into the K-12 curriculum and lesson plan development. Pre-conference workshops of Arts All Ways VI, featured arts education programs of the Nevada Museum of Art and the Guggenheim Museum, Las Vegas.

Nevadans continue to drive home the message of arts education by bolting the **Rich in Arts License Plates** to bumpers across the state. More than 3,500 arts license plates have been purchased, raising awareness for arts education and providing additional funding for arts education programs of the Nevada Arts Council and VSA arts of Nevada. The design by Beth Finta, a Las Vegas student, features Nevada flora and fauna in bright primary colors. Though other states have plates to support arts education, Nevada's remains the only one actually designed by a student.

AIE Grant Statistics FY02

Artist in Residence Program

\$25,290 in matching grants, sponsored 29 residencies involving 17 elementary schools, 5 middle schools, 4 high schools, 1 summer youth camp, and 1 Boys & Girls Club. The residencies involved more than 4,917 students in grades K-12 and 2,553 community members.

Special Project Grants for Schools and Organizations

\$34,326 in matching grants supported innovative arts education initiatives for 6 elementary schools, 1 university youth program, and 8 arts and cultural organizations.

Professional Development Grants for Educators

\$21,383 was awarded to 30 educators, 1 art therapist, 1 arts administrator and 4 artists in residence, from 4 school districts, 3 colleges, and 2 arts organizations, to attend conferences, create productions and exhibitions, conduct research, and work with artists to learn new skills and techniques.


Teaching and Discovering the Arts \$1,500 was awarded to the Art Educators of Nevada for their annual teacher conference.

Grants Program


The Grants Program reflects a significant commitment by the State of Nevada to support the creation of art, access to the arts, and life-long arts education for its citizens. NAC grants support nonprofit arts groups, public institutions, community service organizations, and individual artists to make cultural activities and experiences widely available to those who live in or visit Nevada. The reach of this program is expansive. Grant recipients can be found in every corner of the state, and sponsor activities such as concerts, exhibitions, festivals, and literary publications. Grant monies also support our opera, ballet, and theatre companies; symphonies, orchestras and choral groups, and local arts councils statewide. Though a NAC grant, ranging from \$450 to \$50,000, may be as little as 2% of a total project budget, the importance of these dollars reaches far beyond actual cash value, serving as a catalyst for other public and private support.

Program Highlights 2001-2002

The Grants Program awarded 113 grants totaling **\$786,854** to arts organizations during its annual spring panel hearings held at the Nevada State Library & Archives in Carson City. For the fourth year in a row, NAC received a record number of grant applications. 114 applicants in five categories requested a total of \$1,505,115 to support programs, projects and operations for FY02. This figure reflects a 34% increase over FY01 requests. Quality and merit of applications were noted by panelists through their scores — 41 were recommended to receive 80% or more of what was requested. Because the aggregate total of dollars recommended exceeded the allocated Grants Program budget by \$194,756, panelists unanimously voted to take a 25% cut across the board in the Project and Partners in Excellence grant categories, maintaining the integrity of the discussion and scoring.

In FY02, NAC was selected by Western States Arts Federation (WESTAF) along with the California Arts Council, to participate in the pilot online grants system, Culture Grants Online. The decision to convert all NAC grant categories in the Grants Program and Arts in Education Program from paper to electronic was made after a thorough investigation of the advantages of online applications. Culture Grants Online (CGO) is a technologically advanced system designed to accommodate changing constituent needs. Through its internal "checks and balances," CGO encourages applicants to develop stronger proposals that can compete in various state and federal funding environments. Throughout the year, staff gathered feedback from constituents and worked with WESTAF to refine CGO and enhance its usability.



In preparation for spring grant deadlines, NAC staff presented eight **grant writing workshops** in Carson City, Reno, Elko, Las Vegas, and Henderson to more than 150 participants. This year's workshops featured interactive demonstrations of the Culture Grants Online system, Artist Fellowship Program, general grant requirements, and specific application technical assistance.
