Voter Registration Application

Prescribed by Secretary of State, DEAN HELLER

GENERAL INFORMATION

This form may be used to register to vote in any county in Nevada. Return the completed form to the County Clerk/Registrar in your county (addresses and telephone numbers are listed at the bottom of this page). In order to vote in any specific election you must register 30 days prior to that election.

Confirmation of Registration

Your application cannot be processed unless it is complete. Your application must be mailed or returned to the County Clerk/Registrar's office within 10 days of completion. Your registration is effective as of the day it is postmarked if mailed or on the date received by the County Clerk/Registrar. **If you do not receive a Nevada Voter Registration Card in the mail within 10 days, please call your County Clerk/Registrar.**

Absent Ballots

If you wish to receive an absentee ballot by mail, contact your County Clerk/Registrar for details on absent ballot requests.

First Time Voters

You must vote in person at the next election if you use this form to register to vote by mail, unless you have your absent ballot request notarized or comply with other provisions of state law (NRS 293.272). You are exempt from this provision if you are disabled.

Notice

You are urged to return your application to register to vote to the County Clerk/Registrar in person or by mail. If you choose to give your completed application to another person to return to the County Clerk/Registrar on your behalf and the person fails to deliver the application to the County Clerk/Registrar, you will not be registered to vote. Please retain the receipt from your application to register to vote.

WARNING: Giving false information on this application is a felony and includes a civil penalty of up to \$20,000.

APPLICATION INSTRUCTIONS

ALL BLUE SHADED AREAS MUST BE COMPLETED BEFORE YOUR APPLICATION CAN BE PROCESSED.

Box 1—Name

Clearly print your full name in this order—First, Middle, Last.

Box 2—Address Where You Live

Do not use a post office box. You may not list your business address unless you actually live there.

Box 3—Mailing Address

If you get your mail at an address that is different from the address in Box 2, put your mailing address in this box.

Box 4—Date of Birth

Put your date of birth in this order—Month, Day, Year. *Be careful not to use today's date!*

Box 5—Place of Birth

Put the state or country where you were born.

Box 6—Identification Number

An identification number is a Social Security number, Nevada Driver's License number, or number from ID card issued by Nevada DMV or other State/Federal Agency. You may choose to leave this block blank. If left blank, a number will be issued to you by the County Clerk/Registrar.

Box 7—Telephone Number

Giving your telephone number is optional.

Box 8—Party Registration

Check only one box. If you register with a minor political party, or as a Nonpartisan (No Party) you will receive a Nonpartisan Ballot for the Primary Election.

Box 9—Affirmation

Review the information. Make sure that you meet the requirements and fully understand all of Box 9.

Box 10—Signature

Sign your full name or make your mark, and print today's date.

Box 11—Name / Address on Last Registration

Put your former full name and/or your former address from your previous registration.

Box 12—Name of Assistant

If you are assisting a person to register to vote and you are not a field registrar appointed by a County Clerk/Registrar or an employee of a voter registration agency, you **MUST** complete this box.


