RE: Response to Assemblyman Anderson on Vacancy Rates

Assemblyman Anderson requested information regarding the State Personnel vacancy rate in comparison to the Division. State Personnel reports that, for Fiscal Year 2002, (July 1, 2001 - June 30, 2002), the average state vacancy rate was 9.7%. The Division's average vacancy rate for the same time period was as follows:

Sworn Staff:	7%
Civilian/Support:	12.5%
Overall Avg:	9%

In order to compare our current vacancy rates to that of the State average, we would need current data from the Department of Personnel, which they are not able to provide at this time. The Division's current vacancy rates are as follows (July 1, 2002 - March 1, 2003 averages):

Sworn Staff:	5%
Civilian/Support:	22%
Overall Avg:	12.5%
