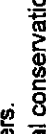
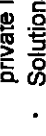

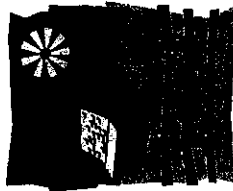
Programs & Services of Conservation Districts in Nevada
