7. Additional Application Requirements.

a.) Insurance. An applicant for a license must provide proof that he carries liability insurance or a self-insured bond in the following amounts: (NOTE: Other agencies – BLM, USFS, NPS may require higher limits, so check first!)

- 1.) At least \$100,000 for each person with a claim,
- 2.) At least \$300,000 for each occurrence, and
- 3.) At least \$25,000 for property damage.

b.) First Aid.

An applicant for a guide's license must provide proof of certification in a Red Cross Standard First Aid course or an equivalent approved by the Division with his original application for a license.

c.) Boating Safety Requirements.

An applicant for a guide's license must provide proof of his United States Coast Guard License, if required for the body of water where the guiding will take place. If a boat will be used to provide a service to a client and a United States Coast Guard License is not required, the applicant must provide proof that he has successfully obtained a minimum score of 80 percent on the boating safety examination in the Navigating Nevada booklet, which may be obtained free of charge from the Nevada Division of Wildlife, 1100 Valley Road, Reno, Nevada 89512.
