SUMMARY--Revises quarterly fee for license for restricted gaming operation.
(BDR 41-2208)

EXPLANATION--Matter in italics is new; matter in brackets [] is material to be omitted.

AN ACT relating to gaming; revising and increasing the quarterly fee for a restricted operation; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE
AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 463.373 is hereby amended to read as follows:
- 2 463.373 1. Before issuing a state gaming license to an applicant for a
- 3 restricted operation, the commission shall charge and collect from him for
- 4 each slot machine for each quarter year:
- 5 (a) A license fee of [\$35] *\$45 for each slot machine* if he will have at
- 6 least one but not more than five slot machines.
- 7 (b) A license fee of [\$55] *\$225 plus \$90 for each slot machine in excess*
- 8 *of five* if he will have at least six but not more than 15 slot machines.
- 9 2. The commission shall charge and collect the fee prescribed in
- 10 subsection 1:
- 11 (a) On or before the last day of the last month in a calendar quarter, for
- 12 the ensuing calendar quarter, from a licensee whose operation is continuing.
- 13 (b) In advance from a licensee who begins operation or puts additional
- 14 slot machines into play during a calendar quarter.
- 15 3. Except as *otherwise* provided in NRS 463.386, no proration of the fee
- 16 prescribed in subsection 1 may be allowed for any reason.
- 17 4. The operator of the location where slot machines are situated shall pay
- 18 the fee prescribed in subsection 1 upon the total number of slot machines
- 19 situated in that location, whether *or not* the machines are owned by one or
- 20 more licensee-owners.

NRS 463.373 Quarterly fee for state license for restricted operation.

1. Before issuing a state gaming license to an applicant for a restricted operation, the commission shall charge and collect from him for each slot machine for each quarter year:

(a) A license fee of \$61 for each slot machine if he will have at least one but not more than five slot machines.

(b) A license fee of \$305 plus \$106 for each slot machine in excess of five if he will have at least six but not more than 15 slot machines.

2. The commission shall charge and collect the fee prescribed in subsection 1:

(a) On or before the last day of the last month in a calendar quarter, for the ensuing calendar quarter, from a licensee whose operation is continuing.

(b) In advance from a licensee who begins operation or puts additional slot machines into play during a calendar quarter.

3. Except as otherwise provided in NRS 463.386, no proration of the fee prescribed in subsection 1 may be allowed for any reason.

4. The operator of the location where slot machines are situated shall pay the fee prescribed in subsection 1 upon the total number of slot machines situated in that location, whether or not the machines are owned by one or more licensee-owners.
