#### Discussion

Assembly Bill 170 provides that when a male, who is a citizen of the United States or an immigrant and is at least 18 years of age, but less than 26 years of age, applies for a driver's license, instruction permit, identification card, or a commercial driver's license with the Department of Motor Vehicles (DMV), he may authorize DMV to register him with the Selective Service System. The application form must include a box, which may be checked by an applicant to authorize DMV to register him with the Selective Service System. If an applicant indicates on the application that he wishes DMV to forward the necessary personal information to the Selective Service System, DMV will forward the information in an

Testimony from a representative of the Selective Service System indicated that the Selective Service System would pay for the public relations campaign, which has a fiscal note of \$52,500. # **Proposed Conceptual Amendments**

Carol Mills, Selective Service System, proposes amending Assembly Bill 170 to provide that DMV's application for a driver's license, instruction permit, identification card, or a commercial driver's license inform males at least 18 years of age, but less than 26 years of age, that by registering with Selective Service System, they will stay eligible for federal student loans, grants, job training benefits, most federal jobs, and United States citizenship for male immigrants seeking citizenship.
