

A division in the Department of Cultural Affairs, the Nevada Arts Council (NAC) was established as a state agency in 1967. A nine-member council, serving rotating terms of four years, oversees NAC policy and makes final decisions on grant allocations. Council members are appointed by the Governor, of Nevada and are selected for their knowledge of and experience in the arts, and to ensure geographic and ethnic representation of alliareas of the state. Staff develops and administers programs and projects that supports the mission and goals of the agency.



# Letter from the Chair & Executive Director

In a year filled with life-altering events, we are reminded each day of the potency of the creative spirit and the significance of artistic expression. These elements of the human experience serve as agents of unity, as conduits for cultural understanding, as healing forces beyond measure, and as languages of affirmation and joy.

Nancy Jackson, a Jackpot Grant recipient, so beautifully captures these thoughts in a letter written shortly after the events of September 11.

"In the first hours after the September 11 attacks, I was like most people: glued to the television, feeling stunned and full of despair. After seeing the same scenes over and over and over again, I realized I had to pull my sixteen year-old daughter and myself away for a while. She went to the piano and began playing a Bach Prelude and Fugue. Hearing that gave me pause. I was stopped not only by its beauty, but also by a sense of awe when I thought of how very long that piece of music, written in the early 1700's, had endured. The world has undergone so many crises since those notes were set to paper, and still, here it was. What that suggests to me is that art is an enduring thread that connects us through the ages. Though life has changed in so many drastic ways in the hundreds of years since that piece was written, artistic expressions continue to communicate a truth that supersedes the political climate of any given era. They survive war and hate, they neutralize cultural differences, and they provide a sense of the abiding goodness of human spirit and survival."



Throughout the year, Nevada's artists and arts organizations responded to the emotional and spiritual needs of communities statewide, as did their colleagues nationwide. The Nevada Arts Council is proud to have been a sponsor of a myriad of these life-affirming events, as we are proud to be a continuing partner in the development of both our newly emerging arts organizations and our most established cultural institutions.



In this Annual Report there is evidence of remarkable dedication, as Nevada's arts sector ensures an increasing quality of cultural experience for citizens in communities across the state. Grappling with the challenges of new economic realities, individuals and organizations have stepped up their commitment to bring art and audience together, and to put voice to the human experience. After reading this report, we have no doubt that you will come away with a feeling of pride in and admiration for the work of Nevada's cultural community.


