\*This average figure will reduce to **\$561.00 per day** if we are able to scheduled meetings to fill two consecutive days. (ref: "piggy backing"), and if we should be able to schedule three consecutive days of meetings the average would reduce to **\$535.34 per day**.

The reason for the reduction of the average day cost of consecutive meetings is the savings of airline costs, although we incur lodging costs for each night away, it is cheaper (less), than airline costs.

I hope this small piece of information will give you some guidance in your deliberations regarding our budget request for the Local Government Employee-Management Relations Board Agency (EMRB).

One of the major problems we are having, in scheduling Board Hearings in the North, is the lack of available meeting rooms.
