OVERVIEW

This budget includes general administration of the division, grants administration, resource development, elder rights and fiscal services. Funding is a combination of federal funds, state General Funds, Taxicab Authority funds, and Senior Ride coupon sales. The General Fund supports the division administration, provides the required state match requirement for federal funds, and supplements older volunteer programs and rural senior services. Federal funds are received from the Administration on Aging under Title III of the Older Americans Act, as well as from the Department of Labor under Title V, USDA, and the Social Services Block Grant Act (Title XX).
