Dear Committee Members:

I very much hope to be present in committee when AB 250 is heard, as both the issue of being proactive to be adequately prepared for a possible terrorist incident <u>and</u> the issue of protecting and preserving constitutional liberties are important to us. However, I'm trying to cover two committees this morning so if I am not present at the proper time, would you please accept this request into the record and consider it along with the other testimony you will hear this morning?

A great deal of work has been done to bring AB 250 to you with a definition of "act of terrorism" that has been refined to largely avoid potential misinterpretation. It sets a significant part of the framework for law enforcement readiness without infringing on constitutional liberties. It even includes a preamble to focus the intent clearly.

Attached is a brief amendment to clarify the definition of "weapon of mass destruction" in AB 250. Mr. Perkins has indicated he considers it a friendly amendment. We believe tightening this definition is a critical element for the proper understanding and interpretation of the law, and we ask you to consider it in your deliberations.

Proposed Amendment

Sec. 14, page 9, lines 23-25.

Sec. 14. "Weapon of mass destruction" means any weapon or device that is designed or intended to create a great risk of death or substantial bodily harm to more than one person large numbers of people.
