Please be advised that our directors voted to support a \$.05 cent per trip charge increase for Taxicab Authority funding.



I am writing in response to your proposed increase of the tripcharge tax paid by the cab companies to fund the operations of the Taxicab Authority and our regulation.

As you are aware we have requested rate increases twice since the September 11th tragedy and subsequent economic slowdown in order to cover ever increasing costs. Your proposed increase would cost Desert Cab approximately \$80,000.00 on an annual basis. I appreciate your dilemma in trying to run an agency in these challenging times. I propose that since legislative approval is necessary to adopt this increase that we change some other fees currently being charged to the cab companies in order to lessen the bite of the proposed 33% increase. We currently have to pay \$100.00 per medallion on an annual basis as well as \$10.00 per medallion for temporary and special event medallions. These charges cost Desert Cab approximately \$10,000.00 a year and are a bookkeeping nightmare. Perhaps you would consider eliminating these fees and bookkeeping as a compromise in these tough times.

Mr. Plunkett I want you to understand that I do support your much needed increase I am just trying to avoid going backwards after getting our much needed increase.

I believe the Taxicab Authority provides a much needed and healthy regulation of the taxi industry in Clark County. Both the Authority and the companies depend on each other for continued prosperity and I look forward to working with you and the agency not only at the legislature but into the future.

I thank you for soliciting my thoughts on the proposed increase and hope that you feel free to get my thoughts on any future changes you might be considering at the Authority.



of taxicabs, the allocations of permanent and temporary medallions, and the investigation of passenger complaints. The Agency employs 25 field investigators who patrol the area of jurisdiction to ensure the taxicabs are being operated safely and in accordance with the appropriate statutes and regulations. There are Faxicab Authority. These goals are accomplished through regulations requiring background checks of potential taxicab drivers, the quarterly safety inspection The Authority's goals are the continued welfare of the traveling public, the taxicab drivers and the taxicab companies operating within the jurisdiction of the 11 Airport Control Officers who patrol McCarran International Airport exclusively.

### KEY OBJECTIVES:

### Key Accomplishments:

- During the year 2002, the Authority increasingly investigated passenger complaints, conducted more quarterly safety insplections of taxicabs, and prosecuted driver violations more aggressively.
- Notices of Violation issued to taxicab drivers increased 62 percent to total 4,630 and response to taxicab accidents by our investigators totaled 3,870, an increase of 17 percent.
  - The Board issued a new Certificate of Public Convenience and Necessity to a taxicab company restricted to only operate west of Interstate 15 The allocation of medallions was increased by 5 percent to better serve the riding public, and fares were increased by 17 percent. in order to service the outlying areas.
