AN ACT relating to Oriental medicine; revising the qualifications
for members of the State Board of Oriental Medicine;
revising the requirements for a license to practice Oriental
medicine; and providing other matters properly relating
thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 634A.030 is hereby amended to read as
2 follows:

3 634A.030 1. The State Board of Oriental Medicine,
4 consisting of five members appointed by the Governor, is hereby
5 created.

6 2. ~~{The Governor shall appoint to the Board:~~
7 ~~—(a) Three members who are licensed pursuant to this chapter.~~
8 ~~—(b) Two members who are representatives of the general public.~~
9 ~~—3.} Each member of the Board shall, before entering upon the
10 duties of his office, take the oath of office prescribed by the
11 Constitution before someone qualified to administer oaths.~~

12 **Sec. 2.** NRS 634A.040 is hereby amended to read as follows:

26 **Sec. 3.** NRS 634A.120 is hereby amended to read as follows:
27 634A.120 1. Each applicant for a license to practice as a
28 doctor of Oriental medicine must pass:
29 (a) An examination in Oriental medicine that is administered by
30 a national organization approved by the Board; and
31 (b) A practical examination approved by the Board that tests the
32 applicant's knowledge and understanding of ~~the~~ :
33 ***(1) Basic medical science;***
34 ***(2) Acupuncture;***
35 ***(3) Herbal medicine;***
36 ***(4) Oriental medicine;***
37 ***(5) English proficiency; and***
38 ***(6) The*** laws and regulations of this state relating to health
39 and safety in the practice of Oriental medicine.
40 ***2. The Board may establish by regulation:***
41 ***(a) Additional subject areas to be included in the practical***
42 ***examination; and***
43 ***(b) Specific methods for the administration of the practical***
44 ***examination, including, but not limited to, written, oral,***
45 ***demonstrative, practical or any combination thereof.***



1 **3.** The Board shall contract for the preparation, administration
2 and grading of the practical examination.

3 ~~{2-}~~ **4.** Except as otherwise provided in subsection ~~{3-}~~ **5**, the
4 Board shall offer the practical examination at least two times each
5 year at a time and place established by the Board.

6 ~~{3-}~~ **5.** The Board may cancel a scheduled practical
7 examination if, within 60 days before the examination, the Board
8 has not received a request to take the examination.

9 ~~{4-}~~ **6.** A person who fails the practical examination may
10 retake the examination.

11 **Sec. 4.** Notwithstanding the amendatory provisions of sections
12 1 and 2 of this act, each person serving as a member of the State
13 Board of Oriental Medicine on October 1, 2003, may continue to
14 serve until the expiration of his term.
