SUMMARY—Revises provisions governing frequency of renewal of registration of certain vehicles. (BDR 43-1097)

AN ACT relating to the Department of Motor Vehicles; revising provisions governing the frequency of renewal of the registration of certain vehicles; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 482 of NRS is hereby amended by adding
2 thereto a new section to read as follows:
3 ***1. The owner of a vehicle, other than a motor vehicle***
4 ***registered pursuant to the provisions of NRS 706.801 to 706.861,***
5 ***inclusive, or a motor vehicle that has a declared gross weight in***
6 ***excess of 26,000 pounds, may choose to register his vehicle for a***
7 ***period of 24 months.***
8 ***2. The Department shall collect from a person who chooses to***
9 ***register his vehicle for a period of 24 months the amount of the***
10 ***governmental services tax and, if applicable, the supplemental***
11 ***governmental services tax assessed pursuant to chapter 371 of***
12 ***NRS that is equal to the total amount of such taxes that the owner***

1 of the vehicle would have otherwise been required to pay during
2 the 24-month period if the vehicle were registered annually.

3 3. The Department shall work in cooperation with the State
4 Environmental Commission and each local air pollution control
5 agency concerning the testing of emissions of vehicles that are
6 registered for a period of 24 months. The State Environmental
7 Commission may adopt such regulations as are necessary to
8 provide for the testing of emissions of such vehicles.

9 4. When the registration of any vehicle is transferred
10 pursuant to the provisions of NRS 482.3667, 482.379 or 482.399 to
11 a vehicle to be registered for a period of 24 months, the expiration
12 date of each regular license plate, special license plate or
13 substitute decal must, at the time of the transfer of registration, be
14 advanced for a period of 24 months beginning:

15 (a) The first day of the month after the transfer, if the vehicle
16 is transferred by an agent of the Department; or

17 (b) The day after the transfer in all other cases,
18 and a credit on the portion of the fee for registration and the
19 governmental services tax attributable to the remainder of the
20 current period of registration allowed pursuant to the applicable
21 provisions of NRS 482.3667, 482.379 and 482.399.

22 **Sec. 2.** NRS 482.206 is hereby amended to read as follows:

23 482.206 **Except as otherwise provided in section 1 of this act:**

24 1. ~~Except~~ **And except** as otherwise provided in this section,
25 every motor vehicle, except for a motor vehicle that is registered
26 pursuant to the provisions of NRS 706.801 to 706.861, inclusive, or
27 which is a motor vehicle with a declared gross weight in excess of
28 26,000 pounds, must be registered for a period of 12 ~~consecutive~~
29 months beginning the day after the first registration by the owner in
30 this state.

31 2. Every vehicle registered by an agent of the Department or a
32 registered dealer must be registered for 12 ~~consecutive~~ months
33 beginning the first day of the month after the first registration by the
34 owner in this state.

35 3. Upon the application of the owner of a fleet of vehicles, the
36 Director may permit him to register his fleet on the basis of a
37 calendar year.

38 4. When the registration of any vehicle is transferred pursuant
39 to the provisions of NRS 482.3667, 482.379 or 482.399, the
40 expiration date of each regular license plate, special license plate or
41 substitute decal must, at the time of the transfer of registration, be
42 advanced for a period of 12 ~~consecutive~~ months beginning:

43 (a) The first day of the month after the transfer, if the vehicle is
44 transferred by an agent of the Department; or

45 (b) The day after the transfer in all other cases,

1 and a credit on the portion of the fee for registration and the
2 governmental services tax attributable to the remainder of the
3 current period of registration allowed pursuant to the applicable
4 provisions of NRS 482.3667, 482.379 and 482.399.

5 **Sec. 3.** NRS 482.260 is hereby amended to read as follows:

6 482.260 1. When registering a vehicle, the Department and
7 its agents or a registered dealer shall:

8 (a) Collect the fees for license plates and registration as
9 provided for in this chapter.

10 (b) Collect the governmental services tax on the vehicle, as
11 agent for the county where the applicant intends to base the vehicle
12 for the period of registration, unless the vehicle is deemed to have
13 no base.

14 (c) Collect the applicable taxes imposed pursuant to chapters
15 372, 374, 377 and 377A of NRS.

16 (d) Issue a certificate of registration.

17 (e) If the registration is performed by the Department, issue the
18 regular license plate or plates.

19 (f) If the registration is performed by a registered dealer, provide
20 information to the owner regarding the manner in which the regular
21 license plate or plates will be made available to him.

22 2. Upon proof of ownership satisfactory to the Director, he
23 shall cause to be issued a certificate of ownership as provided in this
24 chapter.

25 3. ~~Every~~ *Except as otherwise provided in section 1 of this*
26 *act, every* vehicle being registered for the first time in Nevada must
27 be taxed for the purposes of the governmental services tax for a
28 12-month period.

29 4. The Department shall deduct and withhold 2 percent of the
30 taxes collected pursuant to paragraph (c) of subsection 1 and remit
31 the remainder to the Department of Taxation.

32 5. A registered dealer shall forward all fees and taxes collected
33 for the registration of vehicles to the Department.

34 **Sec. 4.** NRS 482.265 is hereby amended to read as follows:

35 482.265 1. The Department shall furnish to every owner
36 whose vehicle is registered two license plates for a motor vehicle
37 other than a motorcycle or power cycle, and one license plate for all
38 other vehicles required to be registered hereunder. Upon renewal of
39 registration, the Department may issue one or more license plate
40 stickers, tabs or other suitable devices in lieu of new license plates.

41 2. The Director ~~shall have the authority to~~ *may* require the
42 return to the Department of all number plates upon termination of
43 the lawful use thereof by the owner under this chapter.



1 3. Except as otherwise ~~specifically~~ provided *in subsection 4*
2 *or by specific* statute, for the issuance of each special license plate
3 authorized pursuant to this chapter:

4 (a) The fee to be received by the Department for the initial
5 issuance of the special license plate is \$35, exclusive of any
6 additional fee which may be added to generate ~~funds~~ *financial*
7 *support* for a particular cause or charitable organization;

8 (b) The fee to be received by the Department for the renewal of
9 the special license plate is \$10, exclusive of any additional fee
10 which may be added to generate financial support for a particular
11 cause or charitable organization; and

12 (c) The Department shall not design, prepare or issue a special
13 license plate unless, within 4 years after the date on which the
14 measure authorizing the issuance becomes effective, it receives at
15 least 250 applications for the issuance of that plate.

16 *4. Except as otherwise provided by specific statute, if the*
17 *special license plate is for a vehicle that is registered for a period*
18 *of 24 months pursuant to section 1 of this act, the fee for the*
19 *initial issuance of the special license plate is \$45 and the fee for*
20 *the renewal of the special license plate is \$20, exclusive or any*
21 *additional fee which may be added to generate financial support*
22 *for a particular cause or charitable organization.*

23 **Sec. 5.** NRS 482.266 is hereby amended to read as follows:

24 482.266 1. A person who desires to have regular or
25 personalized license plates that are substantially in the same color
26 and form as license plates manufactured before January 1, 1982,
27 must:

28 (a) Submit a written request for such license plates to the
29 Department in a manner and form prescribed by the Department;
30 and

31 (b) In addition to all other applicable registration fees, licensing
32 fees and governmental services taxes, pay the manufacturing fee
33 prescribed by the Department.

34 A person requesting license plates pursuant to this section must
35 comply with all requirements for registration and licensing pursuant
36 to this chapter. A request for license plates pursuant to this section
37 does not, by itself, constitute a request for special license plates
38 pursuant to ~~subsection~~ *subsections 3 and 4* of NRS 482.265.

39 2. After receiving a request and the full amount of the payment
40 due for license plates requested pursuant to subsection 1, the
41 Department shall manufacture the license plates using substantially
42 the same process, dies and materials as were used to manufacture
43 license plates before January 1, 1982. The Department shall deliver
44 license plates requested pursuant to this section to a person who
45 requests such license plates within 180 days after acceptance of the

1 written request or after receipt of payment therefor, whichever
2 occurs last.

3 3. The Department shall:

4 (a) Prescribe, by regulation, a manner and form for submitting a
5 written request pursuant to subsection 1. The form must include,
6 without limitation, an indication of whether the requester desires to
7 have the same letters and numbers on the license plates requested as
8 are on the license plates that are registered to him at the time of the
9 request.

10 (b) Determine the cost of manufacturing a license plate pursuant
11 to this section and prescribe a manufacturing fee, which must not
12 exceed \$25, to defray the cost of manufacturing license plates
13 pursuant to this section. The manufacturing fee must be:

14 (1) Collected by the Department;

15 (2) Deposited with the State Treasurer to the credit of the
16 Motor Vehicle Fund; and

17 (3) Allocated to the Revolving Account for the Issuance of
18 Special License Plates created pursuant to NRS 482.1805 to defray
19 the costs of manufacturing license plates pursuant to this section.

20 4. A person who requests license plates pursuant to this section
21 may keep the license plates which are registered to him at the time
22 of the request if the license plates requested contain the same letters
23 and numbers as the license plates which are registered to him at the
24 time of the request.

25 **Sec. 6.** NRS 482.280 is hereby amended to read as follows:

26 482.280 1. The registration of every vehicle expires at
27 midnight on the day specified on the receipt of registration, unless
28 the day specified falls on a Saturday, Sunday or legal holiday. If the
29 day specified on the receipt of registration is a Saturday, Sunday or
30 legal holiday, the registration of the vehicle expires at midnight on
31 the next judicial day. The Department shall mail to each holder of a
32 certificate of registration an application for renewal of registration
33 for the following period of registration. The applications must be
34 mailed by the Department in sufficient time to allow all applicants
35 to mail the applications to the Department and to receive new
36 certificates of registration and license plates, stickers, tabs or other
37 suitable devices by mail before the expiration of their registrations.
38 An applicant may present or submit the application to any agent or
39 office of the Department.

40 2. An application:

41 (a) Mailed or presented to the Department or to a county
42 assessor pursuant to the provisions of this section;

43 (b) Submitted to the Department pursuant to NRS 482.294; or

44 (c) Presented to an authorized inspection station or authorized
45 station pursuant to the provisions of NRS 482.281,

1 must include, if required, evidence of compliance with standards for
2 control of emissions.

3 3. The Department shall insert in each application mailed
4 pursuant to subsection 1:

5 (a) The amount of the governmental services tax to be collected
6 for the county pursuant to the provisions of NRS 482.260 ~~and~~ *and*
7 *section 1 of this act.*

8 (b) The amount set forth in a notice of nonpayment filed with
9 the Department by a local authority pursuant to NRS 484.444.

10 (c) A statement which informs the applicant that, pursuant to
11 NRS 485.185, he is legally required to maintain insurance during
12 the period in which the motor vehicle is registered.

13 4. An owner who has made proper application for renewal of
14 registration before the expiration of the current registration but who
15 has not received the license plate or plates or card of registration for
16 the ensuing period of registration is entitled to operate or permit the
17 operation of that vehicle upon the highways upon displaying thereon
18 the license plate or plates issued for the preceding period of
19 registration for such a time as may be prescribed by the Department
20 as it may find necessary for the issuance of the new plate or plates
21 or card of registration.

22 **Sec. 7.** NRS 482.3667 is hereby amended to read as follows:

23 482.3667 1. The Department shall establish, design and
24 otherwise prepare for issue personalized prestige license plates and
25 shall establish all necessary procedures not inconsistent with this
26 section for the application and issuance of such license plates.

27 2. The Department shall issue personalized prestige license
28 plates, upon payment of the prescribed fee, to any person who
29 otherwise complies with the laws relating to the registration and
30 licensing of motor vehicles or trailers for use on private passenger
31 cars, motorcycles, trucks or trailers.

32 3. ~~{Personalized}~~ *Except as otherwise provided in this section,*
33 *personalized* prestige license plates are valid for 12 months and are
34 renewable upon expiration. These plates may be transferred from
35 one vehicle or trailer to another if the transfer and registration fees
36 are paid as set out in this chapter. Any person transferring plates
37 must be allowed a 1/12 reduction in fees for each calendar month
38 remaining unused from the previous registration, applicable to the
39 fees which are for the registration year for which the plates are
40 being transferred.

41 4. *Personalized prestige plates issued to a person who*
42 *registers his motor vehicle for a period of 24 months pursuant to*
43 *section 1 of this act are valid for 24 months and are renewable*
44 *upon expiration. These plates may be transferred from one vehicle*
45 *or trailer to another if the transfer and registration fees are paid*

1 *as set forth in this chapter. Any person transferring such plates*
2 *must be allowed a prorated reduction in fees for each calendar*
3 *month remaining in the registration period for which the plates*
4 *are being transferred.*

5 5. In case of any conflict, the person who first made
6 application for personalized prestige license plates and has
7 continuously renewed them by payment of the required fee has
8 priority.

9 ~~15.1~~ 6. The Department may limit by regulation the number of
10 letters and numbers used and prohibit the use of inappropriate letters
11 or combinations of letters and numbers.

12 ~~16.1~~ 7. The Department shall not assign to any person not
13 holding the relevant office any letters and numbers denoting that the
14 holder holds a public office.

15 **Sec. 8.** NRS 482.367 is hereby amended to read as follows:

16 482.367 1. The Department shall charge and collect the
17 following fees for the issuance of personalized prestige license
18 plates, which fees are in addition to all other license fees and
19 applicable taxes:

20 (a) For the first issuance \$35

21 (b) For a renewal sticker 20

22 (c) For changing to another personalized prestige license
23 plate 35

24 *(d) If the vehicle is registered for a period of 24 months*
25 *pursuant to section 1 of this act:*

26 *(1) For the first issuance 55*

27 *(2) For a renewal sticker 40*

28 2. The additional fees collected by the Department for the
29 issuing of personalized prestige license plates must be deposited
30 with the State Treasurer to the credit of the Motor Vehicle Fund.

31 **Sec. 9.** NRS 482.3672 is hereby amended to read as follows:

32 482.3672 1. An owner of a motor vehicle who is a resident of
33 this state and who is regularly employed or engaged as an editor,
34 reporter or photographer by a newspaper or television or radio
35 station may, upon signed application on a form prescribed and
36 provided by the Department, accompanied by:

37 (a) The fee charged for personalized prestige license plates in
38 NRS 482.367 in addition to all other required registration fees and
39 taxes; and

40 (b) A letter from the news director, editor or publisher of the
41 periodical or station by whom he is employed,
42 be issued license plates upon which is inscribed PRESS with three
43 consecutive numbers.

1 2. Each person who is eligible for special license plates under
2 this section may apply for one set of plates. The plates may be used
3 only on a private passenger vehicle or a noncommercial truck.

4 3. When a person to whom special license plates have been
5 issued pursuant to this section leaves the service of the newspaper or
6 station which has provided the letter required by subsection 1, he
7 shall surrender any special plates in his possession to the
8 Department and is entitled to receive regular Nevada license plates.
9 Surrendered plates may be reissued or disposed of in a manner
10 authorized by the regulations of the Department.

11 4. The Department may adopt regulations governing the
12 issuance of special license plates to members of the press.

13 5. Special license plates issued pursuant to this section are
14 renewable upon the payment of \$10. *If the special license plates are*
15 *for a vehicle that is registered for a period of 24 months pursuant*
16 *to section 1 of this act, the fee for the renewal of the special*
17 *license plates is \$20.*

18 **Sec. 10.** NRS 482.3675 is hereby amended to read as follows:

19 482.3675 1. An owner of a motor vehicle who is a United
20 States citizen or a citizen of a foreign country residing in this state
21 and who holds from a foreign country a letter of appointment as an
22 honorary consul may, upon signed application on a form prescribed
23 and provided by the Department, accompanied by:

24 (a) The fee charged for personalized prestige license plates in
25 NRS 482.367 in addition to all other required registration fees and
26 taxes; and

27 (b) A copy of the letter of appointment from that
28 country,
29 be issued a set of license plates upon which is inscribed
30 CONSULAR CORPS with three consecutive numbers.

31 2. Each person who is eligible for special license plates under
32 this section may apply for one set of plates. The plates may be used
33 only on a private passenger vehicle or a noncommercial truck.

34 3. When a person to whom special license plates have been
35 issued pursuant to this section loses his status as an honorary consul,
36 he shall surrender any special plates in his possession to the
37 Department and is entitled to receive regular Nevada license plates.
38 Surrendered plates may be reissued or disposed of in a manner
39 authorized by the regulations of the Department.

40 4. The Department may adopt regulations governing the
41 issuance of special license plates to honorary consuls of foreign
42 countries. The Department shall include on the form for application
43 a notice to the applicant that the issuance of such license plates does
44 not confer any diplomatic immunity.

1 5. Special license plates issued pursuant to this section are
2 renewable upon the payment of \$10. *If the special license plates are*
3 *for a vehicle that is registered for a period of 24 months pursuant*
4 *to section 1 of this act, the fee for the renewal of the special*
5 *license plates is \$20.*

6 **Sec. 11.** NRS 482.3747 is hereby amended to read as follows:
7 482.3747 1. The Department, in cooperation with the Board
8 of Regents and the athletic departments of the University of Nevada,
9 Reno, and the University of Nevada, Las Vegas, shall design,
10 prepare and issue collegiate license plates, using any appropriate
11 colors and designs to represent each university.

12 2. The Department may issue collegiate license plates for any
13 passenger car or light commercial vehicle upon application by any
14 person who is entitled to license plates pursuant to NRS 482.265
15 and who otherwise complies with the requirements for registration
16 and licensing pursuant to this chapter. A person may request that
17 personalized prestige license plates issued pursuant to NRS
18 482.3667 be combined with collegiate license plates if that person
19 pays the fees for the personalized prestige license plates in addition
20 to the fees for the collegiate license plates pursuant to subsections 3
21 and 4.

22 3. The fee for the collegiate license plates is \$35, in addition to
23 all other applicable registration and license fees and governmental
24 services taxes. Collegiate license plates are renewable upon the
25 payment of \$10. *If the collegiate license plates are for a vehicle*
26 *that is registered for a period of 24 months pursuant to section 1*
27 *of this act, the additional fee for the initial issuance of the*
28 *collegiate license plates is \$45 and the fee for the renewal of the*
29 *collegiate license plates is \$20.*

30 4. In addition to all fees for the license, registration and
31 governmental services taxes, a person who requests a collegiate
32 license plate shall pay for the initial issuance of a plate an additional
33 fee of \$25 and for each renewal of the plate an additional fee of \$20
34 for academic and athletic scholarships to students of the University
35 of Nevada, Reno, and the University of Nevada, Las Vegas. *If the*
36 *collegiate license plates are for a vehicle that is registered for a*
37 *period of 24 months pursuant to section 1 of this act, the*
38 *additional fee for the initial issuance of the collegiate license*
39 *plates is \$45 and the additional fee for the renewal of the*
40 *collegiate license plates is \$40.*

41 5. The Department shall deposit the fees collected pursuant to
42 subsection 4 with the State Treasurer for credit to the Collegiate
43 License Plate Account in the State General Fund created pursuant to
44 NRS 396.384.



1 6. If, during ~~[a registration year.]~~ *the period of registration*, the
2 holder of collegiate plates issued pursuant to the provisions of this
3 section disposes of the vehicle to which the plates are affixed, he
4 may retain the plates and:

5 (a) Affix them to another vehicle which meets the requirements
6 of this section if the transfer and registration fees are paid as set out
7 in this chapter; or

8 (b) Within 30 days after removing the plates from the vehicle,
9 return them to the Department.

10 **Sec. 12.** NRS 482.3748 is hereby amended to read as follows:

11 482.3748 1. Except as otherwise provided in this section, the
12 Department, in cooperation with the Grand Lodge of Free and
13 Accepted Masons of the State of Nevada, shall design, prepare and
14 issue license plates that indicate affiliation with the Grand Lodge of
15 Free and Accepted Masons using any colors and designs which the
16 Department deems appropriate. The Department shall not design,
17 prepare or issue the license plates unless it receives at least 250
18 applications for the issuance of those plates.

19 2. The Department shall issue license plates that indicate
20 affiliation with the Grand Lodge of Free and Accepted Masons for a
21 passenger car or a light commercial vehicle upon application by a
22 person who is entitled to license plates pursuant to NRS 482.265
23 and who otherwise complies with the requirements for registration
24 and licensing pursuant to this chapter. A person may request that
25 personalized prestige license plates issued pursuant to NRS
26 482.3667 be combined with license plates that indicate affiliation
27 with the Grand Lodge of Free and Accepted Masons if that person
28 pays the fees for the personalized prestige license plates in addition
29 to the fees for the license plates that indicate affiliation with the
30 Grand Lodge of Free and Accepted Masons.

31 3. An application for the issuance or renewal of license plates
32 that indicate affiliation with the Grand Lodge of Free and Accepted
33 Masons is void unless it has been stamped or otherwise validated by
34 the Grand Lodge of Free and Accepted Masons. The Grand Lodge
35 of Free and Accepted Masons may charge a fee for validating an
36 application.

37 4. The fee payable to the Department for license plates that
38 indicate affiliation with the Grand Lodge of Free and Accepted
39 Masons is \$35, in addition to all other applicable registration and
40 license fees and governmental services taxes. The license plates are
41 renewable upon the payment to the Department of \$10 in addition to
42 all other applicable registration and license fees and governmental
43 services taxes. *If the license plates are for a vehicle that is*
44 *registered for a period of 24 months pursuant to section 1 of this*

2 *is \$45 and the fee for the renewal of the license plates is \$20.*

3 5. If, during ~~[a registration year,]~~ *the period of registration*, the
4 holder of license plates issued pursuant to the provisions of this
5 section disposes of the vehicle to which the plates are affixed, he
6 may retain the plates and:

7 (a) Affix them to another vehicle that meets the requirements of
8 this section if the transfer and registration fees are paid as set out in
9 this chapter; or

10 (b) Within 30 days after removing the plates from the vehicle,
11 return them to the Department.

12 6. For the purposes of this section, "Grand Lodge of Free and
13 Accepted Masons" means the Grand Lodge of Free and Accepted
14 Masons of the State of Nevada, or its successor, and any recognized
15 sister jurisdiction or organization of the Grand Lodge of Free and
16 Accepted Masons.

17 **Sec. 13.** NRS 482.3749 is hereby amended to read as follows:

18 482.3749 1. The Department shall, in cooperation with the
19 Nevada Commission on Sports and using any colors and designs
20 that the Department deems appropriate, design, prepare and issue
21 license plates which indicate status as a hall of fame athlete. The
22 design of the license plates must include the words "hall of fame."

23 2. The Department shall issue license plates that indicate status
24 as a hall of fame athlete for a passenger car or a light commercial
25 vehicle upon application by a person who is entitled to license plates
26 pursuant to NRS 482.265 and who otherwise complies with the
27 requirements for registration and licensing pursuant to this chapter.
28 A person may request that personalized prestige license plates
29 issued pursuant to NRS 482.3667 be combined with license plates
30 that indicate status as a hall of fame athlete if that person pays the
31 fees for the personalized prestige license plates in addition to the
32 fees for the license plates that indicate status as a hall of fame
33 athlete.

34 3. An application for the issuance or renewal of license plates
35 that indicate status as a hall of fame athlete is void unless it is
36 accompanied by documentation which, in the determination of the
37 Department, provides reasonable proof of identity and status as a
38 hall of fame athlete.

39 4. In addition to all other applicable registration and license
40 fees and governmental services taxes:

41 (a) A person who requests license plates that indicate status as a
42 hall of fame athlete shall pay a fee to the Department of \$35.

43 (b) License plates that indicate status as a hall of fame athlete
44 are renewable upon the payment to the Department of \$10.

TEXT OF REPEALED SECTION

371.070 Reduction for registration after beginning of year for registration. Upon vehicles registered for the first time in this state after the beginning of the registration year, the amount of the governmental services tax must be reduced one-twelfth for each month which has elapsed since the beginning of such year.
