**INTRODUCTION, FIRST READING AND REFERENCE**

By the Committee on Commerce and Labor:

Senate Bill No. 44—AN ACT relating to trade practices; revising provisions regulating organizations for buying goods or services at a discount; authorizing a parent business entity to serve as a trustee, under certain circumstances, for trust accounts maintained by its affiliate organizations; requiring such a parent to post additional security for the

protection of buyers who are members of the affiliate organizations; providing an alternative method for trustees of such affiliate organizations to withdraw money from certain trust accounts; revising provisions that authorize a buyer who is a member of an organization to rescind his contract if the organization moves its place of business beyond a certain distance; and providing other matters properly relating thereto.

Senator Hardy moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By the Committee on Taxation:

Senate Bill No. 45—AN ACT relating to taxation; eliminating the requirement that a tax receiver must provide the State Controller with a copy of a written protest filed by a property owner concerning property taxes; and providing other matters properly relating thereto.

Senator McGinness moved that the bill be referred to the Committee on Taxation.

Motion carried.

By Senator McGinness:

Senate Bill No. 46—AN ACT relating to the Public Employees' Retirement System; increasing the maximum assumed monthly wage of a volunteer firefighter for the purpose of determining the contribution to be paid into the Public Employees' Retirement Fund and the Public Employees' Retirement Administrative Fund; and providing other matters properly relating thereto.

Senator McGinness moved that the bill be referred to the Committee on Finance.

Motion carried.

By Senator Wiener:

Senate Bill No. 47—AN ACT relating to professions; authorizing the Board of Athletic Trainers to issue a provisional license to an applicant for a license as an athletic trainer pending receipt of the report of the criminal history of the applicant from the Federal Bureau of Investigation; revising other provisions governing the applications for licensure; requiring the Board of Athletic Trainers to study and make recommendations concerning the regulation of personal trainers and other fitness instructors; and providing other matters properly relating thereto.

Senator Wiener moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By the Committee on Government Affairs:

Senate Bill No. 48—AN ACT relating to state financial administration; making various changes relating to the payment of the costs and fees associated with the collection of a debt owed to the State; and providing other matters properly relating thereto.

Senator Hardy moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By Senator Hardy:

Senate Bill No. 49—AN ACT relating to motor vehicles; increasing the period during which a temporary permit for a short-term lessor to operate certain unregistered vehicles remains valid; and providing other matters properly relating thereto.

Senator Hardy moved that the bill be referred to the Committee on Transportation and Homeland Security.

Motion carried.

By the Committee on Finance:

Senate Bill No. 50—AN ACT making an appropriation to the Office of Veterans' Services for expenses relating to the establishment of an Office of Coordinator of Services for Veterans in Nye and Esmeralda Counties; and providing other matters properly relating thereto.

Senator Raggio moved that the bill be referred to the Committee on Finance.

Motion carried.
