

**ASSEMBLY BILL NO. 114—ASSEMBLYMEN MARVEL, SIBLEY,
ALLEN, CARPENTER, GRADY, HETTRICK AND SEALE (BY REQUEST)**

SUMMARY—Revises provisions governing sale of mobile and manufactured homes and commercial coaches.
(BDR 43-1162)

AN ACT relating to manufactured housing; authorizing a licensed real estate broker and his licensed salesman under certain circumstances to sell used mobile homes and used manufactured homes without obtaining certain additional licensure; removing the duty of the Administrator of the Manufactured Housing Division of the Department of Business and Industry to prescribe the form of the contract that must be used for the sale of a manufactured home, mobile home or commercial coach; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law prohibits a person from engaging in the business of selling manufactured homes, mobile homes or commercial coaches without applying for and obtaining a license from the Manufactured Housing Division of the Department of Business and Industry. (NRS 489.076, 489.311) Existing law, however, provides an exception to this requirement that allows a licensed real estate broker to obtain a limited dealer's license to sell a used manufactured or mobile home when the sale is in connection with the sale of real property and the home is located on the property. The Manufactured Housing Division is required to adopt regulations for the issuance of such a limited dealer's license. (NRS 489.331)

This bill removes the requirement that the Manufactured Housing Division adopt regulations for the issuance of limited dealer's licenses and exempts licensed real estate brokers and their licensed salesmen from any additional licensing requirements for such sales of a used manufactured or mobile home.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 489.331 is hereby amended to read as follows:

2 489.331 [1. The Division shall adopt regulations for the
3 issuance of limited dealer's licenses authorizing licensed real estate
4 brokers to sell used manufactured homes and used mobile homes
5 when the sale is in connection with the sale of a fee simple interest
6 in real property and the used manufactured home or used mobile
7 home is situated on the real property sold. The regulations must not
8 be more strict than the regulations in effect which pertain to licenses
9 for other dealers. An applicant for a limited dealer's license is not
10 required to have sufficient space to display used manufactured
11 homes or used mobile homes at his established place of business.

12 2. If a] A licensed real estate broker [holds a limited dealer's
13 license, he] and his licensed salesmen may, *without applying for or
14 obtaining any license issued pursuant to the provisions of this
15 chapter*, sell used manufactured homes and used mobile homes
16 when the sale is in connection with the sale of a fee simple interest
17 in real property and the used manufactured home or used mobile
18 home is situated on the real property sold.

19 **Sec. 2.** NRS 489.7152 is hereby repealed.

TEXT OF REPEALED SECTION

**489.7152 Form of contract to be used for sale of
manufactured home, mobile home or commercial coach.** The
Administrator shall prescribe, by regulation, the form of the contract
that must be used for the sale of a manufactured home, mobile home
or commercial coach.
