SUMMARY—Revises provisions regarding expenditures of school districts. (BDR 34-882)

EXPLANATION – Matter in ***bolded italics*** is new; matter between brackets [omitted material] is material to be omitted.

AN ACT relating to education; requiring school districts to expend a minimum amount of money each year for certain extracurricular activities; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law requires school districts to expend a minimum amount of money
2 each year for textbooks, instructional supplies and instructional hardware, as
3 determined in a formula prescribed by the Department of Education. (NRS
4 387.206) Existing law also requires each school district to expend a minimum
5 amount of money for library books, computer software, instructional equipment
6 and maintenance and repair based upon the district's 3-year average of expenditures
7 for those items. (NRS 387.207)

8 This bill requires each school district to expend a minimum amount of money
9 each year for extracurricular activities. The amount each school district is required
10 to expend is based upon its 3-year average of expenditures for extracurricular
11 activities. This bill prescribes the extracurricular activities to which the minimum
12 expenditure requirements apply and authorizes the Department to prescribe
13 additional activities and programs by regulation.

14 This bill also provides that if a school district fails to expend the minimum
15 amount of money for extracurricular activities, the Department must reduce the
16 basic support allocation to the school district in an amount that is equal to the
17 difference between the actual expenditure and the required minimum expenditure.
18 A school district may appeal a determination to reduce basic support if the district
19 incurred unexpected expenditures for the year.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 387 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *1. Except as otherwise provided in this section, during each
4 school year a school district shall expend for extracurricular
5 activities an amount of money, expressed as an amount per pupil,
6 that is at least equal to the average of the total amount of money
7 that was expended per year by the school district for
8 extracurricular activities during the immediately preceding 3
9 years.*

10 *2. On or before January 1 of each year, the Department shall
11 determine whether each school district has expended, during the
12 immediately preceding fiscal year, the required minimum amount
13 of money as determined pursuant to subsection 1.*

14 *3. Except as otherwise provided in subsections 4 and 5, if the
15 Department determines pursuant to subsection 2 that a school
16 district has not expended the required minimum amount of money,
17 a reduction must be made from the basic support allocation
18 otherwise payable to that school district in an amount that is equal
19 to the difference between the actual expenditure for
20 extracurricular activities and the minimum required expenditure
21 as determined pursuant to subsection 1. A reduction in the amount
22 of the basic support allocation pursuant to this subsection:*

23 *(a) Does not reduce the amount that the school district is
24 required to expend on extracurricular activities during the current
25 fiscal year; and*

26 *(b) Must not exceed the amount of basic support that was
27 provided to the school district for the fiscal year during which the
28 minimum expenditure amount was not satisfied.*

29 *4. A school district is not required to satisfy the expenditures
30 required by this section for a school year during which:*

31 *(a) The total number of pupils who are enrolled in public
32 schools within the school district has declined from the
33 immediately preceding school year; or*

34 *(b) The total revenue available in the general fund of the
35 school district has declined from the immediately preceding school
36 year.*

37 *5. A school district may appeal a determination of the
38 Department to reduce the basic support allocation of the school
39 district if the school district incurred unexpected expenditures for
40 the fiscal year during which the minimum expenditure amount*

1 was not satisfied. Such an appeal must be made to the
2 Superintendent of Public Instruction.

3 **6. The Department:**

4 (a) Shall adopt regulations prescribing the process for appeals
5 to the Superintendent of Public Instruction pursuant to
6 subsection 5;

7 (b) May adopt regulations identifying extracurricular activities
8 in addition to those prescribed pursuant to subsection 7 for which
9 the minimum expenditure required by this section applies; and

10 (c) May adopt regulations as necessary to carry out the
11 provisions of this section.

12 **7. For the purposes of this section, “extracurricular**
13 **activities” means a Junior Reserve Officer Training Corps**
14 **program, interscholastic athletic activities and events, physical**
15 **education, the arts, including music, drama, speech and the visual**
16 **arts, and programs designed for gifted and talented pupils. The**
17 **term is limited to the activities and programs set forth in this**
18 **subsection unless the Department adopts regulations prescribing**
19 **additional programs and activities pursuant to subsection 6.**

20 **Sec. 2.** NRS 387.205 is hereby amended to read as follows:

21 387.205 1. Subject to the limitations set forth in NRS
22 387.206 and 387.207, **and section 1 of this act**, money on deposit in
23 the county school district fund or in a separate account, if the board
24 of trustees of a school district has elected to establish such an
25 account pursuant to the provisions of NRS 354.603, must be used
26 for:

27 (a) Maintenance and operation of the public schools controlled
28 by the county school district.

29 (b) Payment of premiums for Nevada industrial insurance.

30 (c) Rent of schoolhouses.

31 (d) Construction, furnishing or rental of teacherages, when
32 approved by the Superintendent of Public Instruction.

33 (e) Transportation of pupils, including the purchase of new
34 buses.

35 (f) Programs of nutrition, if such expenditures do not curtail the
36 established school program or make it necessary to shorten the
37 school term, and each pupil furnished lunch whose parent or
38 guardian is financially able so to do pays at least the actual cost of
39 the lunch.

40 (g) Membership fees, dues and contributions to an
41 interscholastic activities association.

42 (h) Repayment of a loan made from the State Permanent School
43 Fund pursuant to NRS 387.526.

1 2. Subject to the limitations set forth in NRS 387.206 and
2 387.207, ***and section 1 of this act***, money on deposit in the county
3 school district fund, or in a separate account, if the board of trustees
4 of a school district has elected to establish such an account pursuant
5 to the provisions of NRS 354.603, when available, may be used for:

- 6 (a) Purchase of sites for school facilities.
7 (b) Purchase of buildings for school use.
8 (c) Repair and construction of buildings for school use.

9 **Sec. 3.** This act becomes effective:

- 10 1. Upon passage and approval for the purpose of adopting
11 regulations and performing any other preparatory administrative
12 tasks that are necessary to carry out the provisions of this act; and
13 2. On July 1, 2005, for all other purposes.
