SUMMARY—Requires collection and reporting of certain information concerning employers of applicants for Medicaid or Children’s Health Insurance Program. (BDR 38-984)

AN ACT relating to public welfare; requiring that an application for Medicaid or the Children’s Health Insurance Program include certain information relating to the employer of the applicant or the employer of a person who provides financial support for the applicant; requiring the biennial reporting by the Department of Human Resources of such information with respect to certain employers and the cost to the State of providing assistance to such applicants; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

- 1 Existing law requires the Department of Human Resources to administer all
- 2 State public welfare programs, including Medicaid and the Children’s Health
- 3 Insurance Program. (NRS 422.270)
- 4 This bill requires each applicant for Medicaid or the Children’s Health
- 5 Insurance Program to disclose the name and business address of his employer in the
- 6 application for assistance. If the applicant is unemployed, he must disclose the
- 7 name and business address of the employer of each person who provides him with
- 8 any financial support.
- 9 This bill requires the Department of Human Resources to prepare biennial
- 10 reports for submission to the Governor and to the Legislature. The reports must



11 include: (1) a listing of employers with 25 or more employees that were identified  
12 in the applications for assistance; and (2) the cost to the State of providing such  
13 assistance. The reports must be made available for public inspection, but must not  
14 include identifying information related to any particular applicant for or recipient of  
15 assistance.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** Chapter 422 of NRS is hereby amended by adding  
2 thereto a new section to read as follows:

3       ***1. Each application for Medicaid or the Children's Health***  
4 ***Insurance Program must include:***

5       ***(a) If the applicant is employed at the time the application is***  
6 ***made, the name and business address of each of his employers; or***

7       ***(b) If the applicant is not employed at the time the application***  
8 ***is made, the name and business address of each employer of every***  
9 ***person who provides any financial support for the applicant.***

10       ***2. The Department shall, on or before January 31 of each***  
11 ***odd-numbered year, based on the information provided pursuant***  
12 ***to subsection 1, prepare and submit to the Governor and to the***  
13 ***Director of the Legislative Counsel Bureau for transmittal to the***  
14 ***Legislature a report listing all employers identified pursuant to***  
15 ***subsection 1 that, during the immediately preceding 2 calendar***  
16 ***years, employed 25 or more employees in this State who received,***  
17 ***or provided financial support for a person who received,***  
18 ***assistance under Medicaid or the Children's Health Insurance***  
19 ***Program. The report must include the following information for***  
20 ***each such employer:***

21       ***(a) The name and business address of the employer;***

22       ***(b) The total number of its employees who received, or***  
23 ***provided financial support for a person who received, assistance***  
24 ***under Medicaid or the Children's Health Insurance Program***  
25 ***during the immediately preceding 2 calendar years; and***

26       ***(c) The cost to the State of providing such assistance.***

27       ***3. The report required by subsection 2 must include only***  
28 ***aggregate information for statistical purposes and exclude any***  
29 ***identifying information related to any particular applicant for or***  
30 ***recipient of assistance under Medicaid or the Children's Health***  
31 ***Insurance Program.***

32       ***4. The report required by subsection 2 is a public record and***  
33 ***must be open for inspection pursuant to NRS 239.010.***
