

ASSEMBLY BILL NO. 175—COMMITTEE ON HEALTH AND HUMAN SERVICES

MARCH 7, 2005

Referred to Concurrent Committees on Health and Human Services and Ways and Means

SUMMARY—Makes appropriations for various improvements to mental health services, mental health courts and community triage centers. (BDR S-1359)

AN ACT making appropriations for mental health services, mental health courts and community triage centers; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. 1. There is hereby appropriated from the State General Fund to the Division of Mental Health and Developmental Services of the Department of Human Resources for Southern Nevada Adult Mental Health Services: For the Fiscal Year 2005-2006..... \$552,827 For the Fiscal Year 2006-2007..... \$1,191,450 2. The money appropriated by subsection 1 must be used to increase over the biennium the number of community residential placements by 90. 3. Any balance of the sums appropriated by subsection 1 remaining at the end of the respective fiscal years must not be committed for expenditure after June 30 of the respective fiscal years and must be reverted to the State General Fund on or before September 15, 2006, and September 21, 2007, respectively.



1       **Sec. 2.** 1. There is hereby appropriated from the State  
2 General Fund to the Division of Mental Health and Developmental  
3 Services of the Department of Human Resources for Southern  
4 Nevada Adult Mental Health Services:

5             For the Fiscal Year 2005-2006..... \$5,000,000  
6             For the Fiscal Year 2006-2007..... \$5,000,000

7       2. The money appropriated by subsection 1 must be used by  
8 the Division to purchase additional acute psychiatric crisis  
9 placements if the capacity of the Division to provide those services  
10 is exhausted.

11       3. The Division shall not expend any money appropriated by  
12 subsection 1 until the Division has issued a request for proposals for  
13 the selection of one or more appropriate contractors to provide the  
14 placements.

15       4. Any balance of the sums appropriated by subsection 1  
16 remaining at the end of the respective fiscal years must not be  
17 committed for expenditure after June 30 of the respective fiscal  
18 years and must be reverted to the State General Fund on or before  
19 September 15, 2006, and September 21, 2007, respectively.

20       **Sec. 3.** 1. There is hereby appropriated from the State  
21 General Fund to the Division of Mental Health and Developmental  
22 Services of the Department of Human Resources for Southern  
23 Nevada Adult Mental Health Services to support a Mental Health  
24 Court in Clark County:

25             For the Fiscal Year 2005-2006..... \$737,093  
26             For the Fiscal Year 2006-2007..... \$1,210,757

27       2. The money appropriated by subsection 1 must be used to  
28 support the Mental Health Court in Clark County to provide for  
29 additional staff and supported living arrangements for  
30 approximately 75 additional persons.

31       3. Any balance of the sums appropriated by subsection 1  
32 remaining at the end of the respective fiscal years must not be  
33 committed for expenditure after June 30 of the respective fiscal  
34 years and must be reverted to the State General Fund on or before  
35 September 15, 2006, and September 21, 2007, respectively.

36       **Sec. 4.** 1. There is hereby appropriated from the State  
37 General Fund to the Division of Mental Health and Developmental  
38 Services of the Department of Human Resources for Northern  
39 Nevada Adult Mental Health Services to increase the support for the  
40 Mental Health Court in Washoe County:

41             For the Fiscal Year 2005-2006..... \$382,643  
42             For the Fiscal Year 2006-2007..... \$816,236

43       2. The money appropriated by subsection 1 must be used to  
44 provide for additional staff required to provide services and  
45 supported living arrangements.



1 3. Any balance of the sums appropriated by subsection 1  
2 remaining at the end of the respective fiscal years must not be  
3 committed for expenditure after June 30 of the respective fiscal  
4 years and must be reverted to the State General Fund on or before  
5 September 15, 2006, and September 21, 2007, respectively.

6 **Sec. 5.** 1. There is hereby appropriated from the State  
7 General Fund to the Division of Mental Health and Developmental  
8 Services of the Department of Human Resources for rural clinics to  
9 support a Mental Health Court in Carson City:

10	For the Fiscal Year 2005-2006.....	\$100,000
11	For the Fiscal Year 2006-2007.....	\$100,000

12 2. The money appropriated by subsection 1 must be used for  
13 additional staff and supported living arrangements.

14 3. Any balance of the sums appropriated by subsection 1  
15 remaining at the end of the respective fiscal years must not be  
16 committed for expenditure after June 30 of the respective fiscal  
17 years and must be reverted to the State General Fund on or before  
18 September 15, 2006, and September 21, 2007, respectively.

19 **Sec. 6.** 1. There is hereby appropriated from the State  
20 General Fund to the Division of Mental Health and Developmental  
21 Services of the Department of Human Resources for Southern  
22 Nevada Adult Mental Health Services for the support of a  
23 community triage center:

24	For the Fiscal Year 2005-2006.....	\$900,000
25	For the Fiscal Year 2006-2007.....	\$900,000

26 2. The Division shall not expend any of the money  
27 appropriated by subsection 1 until the Division has:

28 (a) Issued a request for proposals for the selection of one or  
29 more appropriate contractors to operate the center.

30 (b) Received matching amounts of money from both local  
31 governments and hospitals. The Division shall not expend more of  
32 the money appropriated by subsection 1 than is matched by both  
33 local governments and hospitals but the money provided by local  
34 governments and hospitals may be combined so that the maximum  
35 expended by the Division equals one-half of the combined total of  
36 the amount provided by the local governments and hospitals for the  
37 community triage center.

38 3. Any balance of the sums appropriated by subsection 1  
39 remaining at the end of the respective fiscal years must not be  
40 committed for expenditure after June 30 of the respective fiscal  
41 years and must be reverted to the State General Fund on or before  
42 September 15, 2006, and September 21, 2007, respectively.

43 **Sec. 7.** 1. There is hereby appropriated from the State  
44 General Fund to the Division of Mental Health and Developmental

5 2. The Division shall not expend any of the money  
6 appropriated by subsection 1 until the Division has:

7 (a) Issued a request for proposals for the selection of one or  
8 more appropriate contractors to operate the center.

9 (b) Received matching amounts of money from both local  
10 governments and hospitals. The Division shall not expend more of  
11 the money appropriated by subsection 1 than is matched by both  
12 local governments and hospitals but the money provided by local  
13 governments and hospitals may be combined so that the maximum  
14 expended by the Division equals one-half of the combined total of  
15 the amount provided by the local governments and hospitals for the  
16 community triage center.

17 3. Any balance of the sums appropriated by subsection 1  
18 remaining at the end of the respective fiscal years must not be  
19 committed for expenditure after June 30 of the respective fiscal  
20 years and must be reverted to the State General Fund on or before  
21 September 15, 2006, and September 21, 2007, respectively.

22 **Sec. 8.** This act becomes effective on July 1, 2005.
