AN ACT relating to fuels; revising provisions relating to alternative fuels; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law regulates alternative fuels, which are fuels designed to reduce
2 pollutants from motor vehicles. (Chapter 486A of NRS) Existing law requires that
3 alternative fuels comply with the regulations adopted by the federal Environmental
4 Protection Agency pursuant to standards established in the federal Clean Air Act
5 Amendments of 1990. (NRS 486A.030)

6 This bill provides a technical correction to clarify that alternative fuels must
7 comply only with any applicable regulations adopted by the federal Environmental
8 Protection Agency pursuant to the standards established in the federal Clean Air
9 Act Amendments of 1990.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 486A.030 is hereby amended to read as
2 follows:

3 486A.030 “Alternative fuel” means any fuel which complies
4 with the standards and requirements established by the Commission.
5 The term includes:

- 6 1. Ultra low-sulfur diesel fuel;
7 2. Reformulated gasoline;
8 3. Diesel fuel that meets the requirements imposed by the
9 California Air Resources Board; and

1 4. Finished diesel fuel that:

2 (a) Meets ASTM International ~~(ASTM)~~ specification D975;

3 and

4 (b) Includes at least 5 percent but not more than 20 percent
5 biodiesel fuel blend stock for distillate fuels meeting ASTM
6 ***International*** specification D6751,

7 ↳ which comply with ~~[the]~~ ***any applicable*** regulations adopted by
8 the United States Environmental Protection Agency pursuant to the
9 standards for the control of emissions from motor vehicles
10 established in the Clean Air Act Amendments of 1990, Public Law
11 101-549, November 15, 1990.

12 **Sec. 2.** NRS 486A.030 is hereby amended to read as follows:

13 486A.030 “Alternative fuel” means any fuel which complies

17 2. Finished diesel fuel that:

18 (a) Meets ASTM International ~~(ASTM)~~ specification D975;

21 biodiesel fuel blend stock for distillate fuels meeting ASTM

28 **Sec. 3.** 1. Section 1 of this act becomes effective on
29 October 1, 2005, and expires by limitation on December 31, 2006.
30 2. Section 2 of this act becomes effective on January 1, 2007.
