

ASSEMBLY BILL NO. 314—ASSEMBLYMEN MCCLEARY, MCCLAIN,
HOLCOMB, MANENDO, MORTENSON, SEALE AND SIBLEY

MARCH 21, 2005

Referred to Committee on Elections, Procedures, Ethics,
and Constitutional Amendments

SUMMARY—Makes various changes to provisions governing
eligibility for election and appointment to certain
public positions and offices. (BDR 24-436)

EXPLANATION – Matter in *bolded italics* is new; matter between brackets [omitted material] is material to be omitted.

AN ACT relating to public officers; requiring elected public officers
and members of public boards who are appointed by the
Governor, the Legislature or members of the Legislature
to have resided in the State, district, county, township or
other area prescribed by law to which the office pertains
for at least 90 days immediately preceding the date of the
close of filing of declarations of candidacy or preceding
the appointment; and providing other matters properly
relating thereto.

Legislative Counsel's Digest:

Under existing law, including various city charters, the minimum period that a person must have been a resident before becoming a candidate for public office varies depending on the type of public office. (NRS 293.1755, 293C.200)

This bill requires, with some exceptions, that a candidate for any public office must be a resident of the district or other area he wishes to represent for at least 90 days before the last day to file a declaration or acceptance of candidacy for the office.

Existing law establishes various qualifications for persons appointed to office by the Governor or the Legislature. (Chapters 218 and 223 of NRS, NRS 232A.020)

This bill requires, with some exceptions, that a person appointed by the Governor or the Legislature to a new term or to fill a vacancy on a board, commission, committee, council, authority or similar body must have resided in Nevada or, if required, in the district or other area he represents for at least 90 days before appointment to the office.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. NRS 293.1755 is hereby amended to read as follows:

293.1755 1. ~~[In addition to any other requirement]~~ *Except as otherwise* provided by law, no person may be a candidate for any office unless, for at least the ~~[30]~~ 90 days immediately preceding the date of the close of filing of declarations of candidacy or acceptances of candidacy for the office which he seeks, he has, in accordance with NRS 281.050, actually, as opposed to constructively, resided in the State, district, county, township or other area prescribed by law to which the office pertains and, if elected, over which he will have jurisdiction or which he will represent.

2. Any person who knowingly and willfully files an acceptance of candidacy or declaration of candidacy which contains a false statement in this respect is guilty of a gross misdemeanor.

3. The provisions of this section do not apply to candidates for the office of district attorney.

Sec. 2. NRS 293.177 is hereby amended to read as follows:

293.177 1. Except as otherwise provided in NRS 293.165, a name may not be printed on a ballot to be used at a primary election unless the person named has filed a declaration of candidacy or an acceptance of candidacy, and has paid the fee required by NRS 293.193 not earlier than the first Monday in May of the year in which the election is to be held nor later than 5 p.m. on the second Friday after the first Monday in May.

2. A declaration of candidacy or an acceptance of candidacy required to be filed by this section must be in substantially the following form:

23 prohibiting corrupt and fraudulent practices in campaigns and
24 elections in this State; that I will qualify for the office if elected
25 thereto, including, but not limited to, complying with any limitation
26 prescribed by the Constitution and laws of this State concerning the
27 number of years or terms for which a person may hold the office;

1 3. The address of a candidate which must be included in the
2 declaration of candidacy or acceptance of candidacy pursuant to
3 subsection 2 must be the street address of the residence where he
4 actually, as opposed to constructively, resides in accordance with
5 NRS 281.050, if one has been assigned. The declaration or
6 acceptance of candidacy must not be accepted for filing if:

7 (a) The candidate's address is listed as a post office box unless a
8 street address has not been assigned to his residence; or

9 (b) The candidate does not present to the filing officer:

10 (1) A valid driver's license or identification card issued by a
11 governmental agency that contains a photograph of the candidate
12 and the candidate's address; or

13 (2) A current utility bill, bank statement, paycheck, or
14 document issued by a governmental entity, including, without
15 limitation, a check, which indicates the candidate's name and
16 address.

17 4. By filing the declaration or acceptance of candidacy, the
18 candidate shall be deemed to have appointed the filing officer for
19 the office as his agent for service of process for the purposes of a
20 proceeding pursuant to NRS 293.182. Service of such process must
21 first be attempted at the appropriate address as specified by the
22 candidate in the declaration or acceptance of candidacy. If the
23 candidate cannot be served at that address, service must be made by
24 personally delivering to and leaving with the filing officer duplicate
25 copies of the process. The filing officer shall immediately send, by
26 registered or certified mail, one of the copies to the candidate at his
27 specified address, unless the candidate has designated in writing to
28 the filing officer a different address for that purpose, in which case
29 the filing officer shall mail the copy to the last address so
30 designated.

31 5. If the filing officer receives credible evidence indicating that
32 a candidate has been convicted of a felony and has not had his civil
33 rights restored by a court of competent jurisdiction, the filing
34 officer:

35 (a) May conduct an investigation to determine whether the
36 candidate has been convicted of a felony and, if so, whether he has
37 had his civil rights restored by a court of competent jurisdiction; and

38 (b) Shall transmit the credible evidence and the findings from
39 such investigation to the Attorney General, if the filing officer is the
40 Secretary of State, or to the district attorney, if the filing officer is a
41 person other than the Secretary of State.

42 6. The receipt of information by the Attorney General or
43 district attorney pursuant to subsection 5 must be treated as a
44 challenge of a candidate pursuant to subsections 4 and 5 of NRS



1 293.182. If the ballots are printed before a court of competent
2 jurisdiction makes a determination that a candidate has been
3 convicted of a felony and has not had his civil rights restored by a
4 court of competent jurisdiction, the filing officer must post a notice
5 at each polling place where the candidate's name will appear on the
6 ballot informing the voters that the candidate is disqualified from
7 entering upon the duties of the office for which the candidate filed
8 the declaration of candidacy or acceptance of candidacy.

9 **Sec. 3.** NRS 293C.185 is hereby amended to read as follows:

10 293C.185 1. Except as otherwise provided in NRS 293C.115
11 and 293C.190, a name may not be printed on a ballot to be used at a
12 primary city election ~~H~~ unless the person named has filed a
13 declaration of candidacy or an acceptance of candidacy and has paid
14 the fee established by the governing body of the city not earlier than
15 70 days before the primary city election and not later than 5 p.m. on
16 the 60th day before the primary city election.

22 declaration or acceptance of candidacy pursuant to subsection 2
23 must be the street address of the residence where he actually, as
24 opposed to constructively, resides in accordance with NRS 281.050,
25 if one has been assigned. The declaration or acceptance of
26 candidacy must not be accepted for filing if:

27 (a) The candidate's address is listed as a post office box unless a
28 street address has not been assigned to his residence; or

29 (b) The candidate does not present to the filing officer:

30 (1) A valid driver's license or identification card issued by a
31 governmental agency that contains a photograph of the candidate
32 and the candidate's address; or

12 (b) Shall transmit the credible evidence and the findings from
13 such investigation to the city attorney.

14 6. The receipt of information by the city attorney pursuant to
15 subsection 5 must be treated as a challenge of a candidate pursuant
16 to subsections 4 and 5 of NRS 293C.186. If the ballots are printed
17 before a court of competent jurisdiction makes a determination that
18 a candidate has been convicted of a felony and has not had his civil
19 rights restored by a court of competent jurisdiction, the city clerk
20 must post a notice at each polling place where the candidate's name
21 will appear on the ballot informing the voters that the candidate is
22 disqualified from entering upon the duties of the office for which the
23 candidate filed the declaration of candidacy or acceptance of
24 candidacy.

37 240.015 1. Except as otherwise provided in this section, a
38 person appointed as a notary public must:

39 (a) During the period of his appointment, be a citizen of the
40 United States or lawfully admitted for permanent residency in the
41 United States as verified by the *United States Citizenship and*
42 *Immigration* ~~[and Naturalization Service.]~~ *Services.*

43 (b) Be a resident of this State.

44 (c) Be at least 18 years of age.



(d) Possesses his civil rights.

2. If a person appointed as a notary public ceases to be lawfully admitted for permanent residency in the United States during his appointment, he shall, within 90 days after his lawful admission has expired or is otherwise terminated, submit to the Secretary of State evidence that he is lawfully readmitted for permanent residency as verified by the *United States Citizenship and Immigration [and Naturalization Service.] Services*. If the person fails to submit such evidence within the prescribed time, his appointment expires by operation of law.

3. The Secretary of State may appoint a person who resides in an adjoining state as a notary public if the person:

(a) Maintains a place of business in the State of Nevada; or

(b) Is regularly employed at an office, business or facility located within the State of Nevada by an employer licensed to do business in this State.

➤ If such a person ceases to maintain a place of business in this State or regular employment at an office, business or facility located within this State, the Secretary of State may suspend his appointment. The Secretary of State may reinstate an appointment suspended pursuant to this subsection if the notary public submits to the Secretary of State, before his term of appointment as a notary public expires, an affidavit which contains the information required pursuant to subsection 2 of NRS 240.030.

Sec. 9. NRS 248.005 is hereby amended to read as follows:

248.005 1. ~~[No]~~ *In addition to any other requirement or restriction provided by law, no* person is eligible to the office of sheriff unless:

(a) He will have attained the age of 21 years on the date he would take office if so elected; and

(b) He is a qualified elector.

2. A person who has been convicted of a felony in this State or any other state is not qualified to be a candidate for or elected or appointed to the office of sheriff regardless of whether he has been restored to his civil rights.

Sec. 10. NRS 258.005 is hereby amended to read as follows:

258.005 1. ~~[No]~~ *In addition to any other requirement or restriction provided by law, no* person is eligible to the office of constable unless:

(a) He will have attained the age of 21 years on the date he would take office if so elected or appointed; and

(b) He is a qualified elector.

2. A person who has been convicted of a felony in this State or any other state is not qualified to be a candidate for or elected or



1 appointed to the office of constable regardless of whether he has
2 been restored to his civil rights.

3 **Sec. 11.** Section 2.010 of the Charter of Carson City, being
4 chapter 213, Statutes of Nevada 1969, as last amended by chapter
5 118, Statutes of Nevada 1985, at page 474, is hereby amended to
6 read as follows:

7 Sec. 2.010 Board of Supervisors: Qualifications;
8 election; term of office.

9 1. The legislative power of Carson City is vested in a
10 Board of Supervisors consisting of five Supervisors,
11 including the Mayor.

12 2. The Mayor must be:

13 (a) An actual and bona fide resident of Carson City for at
14 least 6 months immediately preceding ~~this election.~~ *the date*
15 *of the close of the filing of declarations of candidacy for this*
16 *office.*

17 (b) A qualified elector within Carson City.

18 3. Each Supervisor must be:

19 (a) An actual and bona fide resident of Carson City for at
20 least 6 months immediately preceding ~~this election.~~ *the date*
21 *of the close of the filing of declarations of candidacy for this*
22 *office.*

23 (b) A qualified elector within the ward which he
24 represents.

25 (c) A resident of the ward which he represents, except
26 that changes effected in the boundaries of a ward pursuant to
27 the provisions of section 1.060 do not affect the right of any
28 elected Supervisor to continue in office for the term for which
29 he was elected.

30 4. All Supervisors, including the Mayor, must be voted
31 upon by the registered voters of Carson City at large and shall
32 serve for terms of 4 years.

33 **Sec. 12.** Section 4.030 of the Charter of Carson City, being
34 chapter 213, Statutes of Nevada 1969, as last amended by chapter
35 96, Statutes of Nevada 1997, at page 182, is hereby amended to read
36 as follows:

37 Sec. 4.030 Municipal Court: Judges.

38 1. The justices of the peace of Carson City are ex officio
39 judges of the Municipal Court of Carson City which consists
40 of at least two departments.

41 2. The Board of Supervisors may by ordinance establish
42 a third department of the Municipal Court. The judge of this
43 department must be:



(a) A resident of Carson City for a continuous 6-month period immediately preceding ~~this election.~~ *the date of the close of the filing of declarations of candidacy for this office.*

(b) A qualified elector.

3. If a third department of the Municipal Court is established, the municipal judge elected for that department serves for a term of 6 years.

4. The Board may appoint a municipal judge for a part-time or temporary position. The Board shall establish the hours of service for this position.

5. The salary of the judges of the Municipal Court must be fixed by the Board and be paid in the same manner as provided for other elected officers.

Sec. 13. Section 2.010 of the Charter of the City of Henderson, being chapter 266, Statutes of Nevada 1971, as last amended by chapter 596, Statutes of Nevada 1995, at page 2206, is hereby amended to read as follows:

Sec. 2.010 City Council: Qualifications; election; term of office; salary.

1. The legislative power of the City is vested in a City Council consisting of four Councilmen and the Mayor.

2. The Mayor must be:

(a) A bona fide resident of the territory which is established by the boundaries of the City for the 12 months immediately preceding the last day for filing a declaration of candidacy for the office.

(b) A qualified elector within the City.

3. Each Councilman must be:

(a) A bona fide resident of the territory which is established by the boundaries of the City for the 12 months immediately preceding the last day for filing a declaration of candidacy for the office.

(b) A qualified elector within the ward which he represents.

4. All Councilmen, including the Mayor, must be voted upon by the registered voters of the City at large and shall serve for terms of 4 years.

The person shall serve the remainder of the term of the member whose absence required his appointment. If the Board fails, neglects or refuses to fill a vacancy within 30 days after a vacancy occurs, the Board of County Commissioners of Clark County shall fill the vacancy.

5. A vacancy in the office of a member who is appointed to the Board must be filled by appointment of the governing body who made the previous appointment. The person so appointed must be a resident and elector of the District and, before taking office, qualify in the manner prescribed in subsection 3. The person shall serve the remainder of the term of the member whose absence required his appointment.
