

ASSEMBLY BILL NO. 315—ASSEMBLYMEN PIERCE, PARKS,
BUCKLEY, GIUNCHIGLIANI AND MCCLAIN

SUMMARY—Enacts provisions relating to event recording devices in motor vehicles. (BDR 43-894)

AN ACT relating to motor vehicles; requiring disclosure of the existence of certain event recording devices in motor vehicles under certain circumstances; restricting the use of information retrieved from an event data recording device under certain circumstances; providing a penalty; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 484 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *1. A manufacturer of a new motor vehicle which is sold or
4 leased in this State and which is equipped with an event recording
5 device shall disclose that fact in the owner's manual for the
6 vehicle. The disclosure must include, if applicable, a statement
7 that the event recording device:*

8 *(a) Records the direction and rate of speed at which the motor
9 vehicle travels;*

10 *(b) Records a history of where the motor vehicle travels;*

11 *(c) Records steering performance;*

12 *(d) Records brake performance, including, without limitation,
13 whether the brakes were applied before an accident;*

1 (e) Records the status of the driver's safety belt; and
2 (f) If an accident involving the motor vehicle occurs, is able to
3 transmit information concerning the accident to a central
4 communications system.

5 2. Except as otherwise provided in this section, data recorded
6 by an event recording device may not be downloaded or otherwise
7 retrieved by a person other than the registered owner of the
8 vehicle. Data recorded by an event recording device may be
9 downloaded or otherwise retrieved by a person other than the
10 registered owner of the vehicle:

11 (a) If the registered owner of the vehicle consents to the
12 retrieval of the data.

13 (b) Pursuant to the order of a court of competent jurisdiction.

14 (c) If the data is retrieved for the purpose of conducting
15 research to improve motor vehicle safety, including, without
16 limitation, conducting medical research to determine the reaction
17 of a human body to motor vehicle accidents, provided that the
18 identity of the registered owner or driver is not disclosed in
19 connection with the retrieval of that data. The disclosure of a
20 vehicle identification number pursuant to this paragraph does not
21 constitute the disclosure of the identity of the registered owner or
22 driver of the vehicle.

23 (d) If the data is retrieved by a new vehicle dealer or a
24 garageman to diagnose, service or repair the motor vehicle.

25 (e) Pursuant to an agreement for subscription services for
26 which disclosure required by subsection 4 has been made.

27 3. A person who retrieves data from an event recording
28 device pursuant to paragraph (c) of subsection 2 shall not disclose
29 that data to any person other than a person who is conducting
30 research specified in that paragraph.

31 4. If a motor vehicle is equipped with an event recording
32 device that is able to record or transmit any information described
33 in subparagraph (2) or (6) of paragraph (a) of subsection 6 and
34 that ability is part of a subscription service for the motor vehicle,
35 the fact that the information may be recorded or transmitted must
36 be disclosed in the agreement for the subscription service.

37 5. Any person who violates the provisions of this section is
38 guilty of a misdemeanor.

39 6. As used in this section:

40 (a) "Event recording device" means a device which is installed
41 by the manufacturer of a motor vehicle and which, for the
42 purposes of retrieving data after an accident involving the motor
43 vehicle;

44 (1) Records the direction and rate of speed at which the
45 motor vehicle travels;

1 (2) *Records a history of where the motor vehicle travels;*
2 (3) *Records steering performance;*
3 (4) *Records brake performance, including, without*
4 *limitation, whether the brakes were applied before an accident;*
5 (5) *Records the status of the driver's safety belt; or*
6 (6) *If an accident involving the motor vehicle occurs, is*
7 *able to transmit information concerning the accident to a central*
8 *communications system.*

9 (b) *"Garageman"* has the meaning ascribed to it in
10 *NRS 487.545.*

11 (c) *"New vehicle dealer"* has the meaning ascribed to it
12 *NRS 482.078.*

13 (d) *"Owner"* means:

14 (1) *A person having all the incidents of ownership,*
15 *including the legal title of the motor vehicle, whether or not he*
16 *lends, rents or creates a security interest in the motor vehicle;*

17 (2) *A person entitled to possession of the motor vehicle as*
18 *the purchaser under a security agreement; or*

19 (3) *A person entitled to possession of the motor vehicle as a*
20 *lessee pursuant to a lease agreement if the term of the lease is*
21 *more than 3 months.*

22 **Sec. 2.** The provisions of this act apply to all motor vehicles
23 that are manufactured on or after January 1, 2006.

24 **Sec. 3.** This act becomes effective on January 1, 2006.
