AN ACT relating to insurance; providing for the regulation of medical discount plans; providing the tax rate on premiums for risk retention groups; providing for the regulation of credit personal property insurance; allowing certain health insurers to offer, subject to regulation by the Commissioner of Insurance, policies of health insurance that have high deductibles and are in compliance with certain federal requirements for establishing health savings accounts; decreasing certain fees for risk retention groups; authorizing an insurer to invest in bonds or notes secured by second liens upon real property under certain circumstances; setting forth the circumstances under which a producer of insurance may pay a commission for selling, soliciting, procuring or negotiating insurance in this State; authorizing the Nevada Insurance Guaranty Association to perform certain acts requested by the Commissioner of Insurance; providing that coverage under a conversion health benefit plan must be renewed by the carrier that issued it under certain circumstances; providing for the regulation of consumer credit insurance; providing for the establishment and regulation of sponsored captive insurers; providing for the establishment and regulation of



branch captive insurers; providing penalties; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Title 57 of NRS is hereby amended by adding thereto a new chapter to consist of the provisions set forth as sections 2 to 16, inclusive, of this act.

Sec. 2. *As used in this chapter, unless the context otherwise requires, the words and terms defined in sections 2.3 to 4, inclusive, of this act have the meanings ascribed to them in those sections.*

Sec. 2.3. *“Administrator” means a person authorized pursuant to NRS 683A.0805 to 683A.0893, inclusive, to conduct business in this State as an administrator.*

Sec. 2.5. *“Affiliate of an insurer” means a person who directly, or indirectly through one or more intermediaries, controls, is controlled by or is under common control with an insurer.*

Sec. 2.7. *“Insurer” means any insurer, fraternal benefit society, nonprofit corporation for hospital, medical and dental services, organization for dental care, health maintenance organization or prepaid limited health service organization authorized pursuant to this title to conduct business in this State.*

Sec. 3. *“Medical discount plan” means a business arrangement or program evidenced by a membership agreement, contract, card, certificate, device or mechanism in which a person, in exchange for fees, dues, charges or any other form of consideration, offers to provide or provides health care or medical services at a discount from providers of health care who are participating in the business arrangement or program or whom the person advertises as or claims to be participating in the business arrangement or program.*

Sec. 4. *“Provider of health care” has the meaning ascribed to it in NRS 629.031.*

Sec. 5. *Notwithstanding any other provision of law, the Commissioner has exclusive jurisdiction to regulate medical discount plans in this State.*

Sec. 6. 1. *Except as otherwise provided in this section, it is unlawful for any person to offer, market, sell or engage in business as a medical discount plan in this State without first registering the medical discount plan pursuant to the provisions of this chapter.*



2. An insurer is not required to register any medical discount plan pursuant to the provisions of this chapter unless the insurer offers, markets or sells the medical discount plan in this State for separate consideration.

3. If an affiliate of an insurer offers, markets, sells or engages in business as a medical discount plan in this State, the affiliate is required to register the medical discount plan pursuant to the provisions of this chapter.

4. The provisions of this chapter do not apply to any medical discount plan that offers or provides discounts only on prescriptions.

Sec. 7. 1. An application for registration to engage in business as a medical discount plan must be submitted on a form prescribed by the Commissioner. The form must be signed by an officer or an authorized representative of the applicant. Except as otherwise provided in this section, the application must be accompanied by:

(a) A registration fee of \$500.

(b) A copy of the organizational documents of the applicant, if any.

(c) A list of names, addresses, positions of employment and biographical information of each person who is responsible for conducting the business activities of the medical discount plan of the applicant, including, but not limited to, all members of the board of directors, board of trustees, officers and managers. The list must set forth the extent and nature of any contracts or other agreements between any person who is responsible for conducting the business activities of the applicant and the medical discount plan, including disclosure of any possible conflicts of interest.

(d) A complete biographical statement, on a form prescribed by the Commissioner, describing the facilities, employees and services that will be offered by the applicant.

(e) A copy of all forms used for contracts between the applicant and networks of providers of health care regarding the provision of health care or medical services to members.

(f) A copy of the most recent financial statements of the applicant, audited by an independent certified public accountant.

(g) A description of the method of marketing proposed by the applicant.

(h) A description of the procedures for making a complaint to be established and maintained by the applicant.

(i) Any other information required by the Commissioner.

2. Each person who registers a medical discount plan must renew the registration annually before the registration expires.



1 *Except as otherwise provided in this section, an application to*
2 *renew the registration must include:*

3 *(a) An annual renewal fee of \$500; and*

4 *(b) Any information set forth in subsection 1 that the*
5 *Commissioner requires to be included in the application.*

6 *3. An administrator or insurer that registers a medical*
7 *discount plan is not required to pay the fees for registering or*
8 *renewing the registration of the medical discount plan pursuant to*
9 *this section.*

10 *4. The Commissioner shall, by regulation, designate the*
11 *provisions of subsection 1 that shall be deemed satisfied by an*
12 *administrator, insurer or affiliate of an insurer that has complied*
13 *with substantially similar requirements pursuant to other*
14 *provisions of this title.*

15 **Sec. 8.** *A person who is responsible for conducting the*
16 *business activities of a medical discount plan may not:*

17 *1. Use the word "insurance" or "enrollment" in any*
18 *advertising or marketing material, brochures or discount cards for*
19 *the medical discount plan unless approved by the Commissioner;*

20 *2. Use in any advertising or marketing material, brochures or*
21 *discount cards for the medical discount plan the terms "coverage,"*
22 *"copay," "preexisting conditions," "guaranteed issue," "PPO,"*
23 *"preferred provider organization" or any other term that could*
24 *reasonably mislead a person into believing the medical discount*
25 *plan is a policy of health insurance;*

26 *3. Pay a provider of health care any fee for providing any*
27 *health care or medical services; or*

28 *4. Collect or accept money from a member of the medical*
29 *discount plan for payment to a provider of health care for specific*
30 *health care or medical services that the provider has provided or*
31 *will provide to the member unless the registration for the medical*
32 *discount plan is held by an administrator or insurer.*

33 **Sec. 9.** *1. The following disclosures must be made in*
34 *writing to any prospective member of a medical discount plan and*
35 *must be in clear language and prominently displayed in any*
36 *advertisements, marketing materials and brochures relating to a*
37 *medical discount plan:*

38 *(a) That the medical discount plan is not a policy of health*
39 *insurance;*

40 *(b) That the medical discount plan provides discounts from*
41 *providers of health care who provide health care or medical*
42 *services to members;*

43 *(c) That the medical discount plan does not make payments*
44 *directly to the providers of health care;*



1 (d) That the member will be required to pay for all health care
2 or medical services but will receive a discount from those
3 providers of health care who have contracted with the medical
4 discount plan;

5 (e) The corporate name of the person offering the medical
6 discount plan and the location and address of each office for the
7 medical discount plan; and

8 (f) A telephone number where the member may obtain
9 information and answers to questions or complaints.

10 2. The disclosures required pursuant to this section may be
11 provided orally or electronically if written disclosures are provided
12 not later than the earlier of:

13 (a) Ten business days after the prospective member elects to
14 accept the medical discount plan; or

15 (b) The date on which any other written material is provided
16 by the medical discount plan to the member.

17 **Sec. 10.** The disclosures required by this chapter must be
18 printed in type that is not smaller than 12-point type.

19 **Sec. 11.** 1. Each medical discount plan must at all times
20 maintain a net worth of \$100,000.

21 2. The Commissioner shall not issue a registration or renewal
22 of a registration for a medical discount plan unless the person
23 registering or renewing the registration certifies that the medical
24 discount plan has a net worth of at least \$100,000.

25 **Sec. 12.** A person is subject to the imposition of an
26 administrative penalty pursuant to this chapter if, in the course of
27 the business of the person, the person:

28 1. Solicits, markets, advertises, promotes or sells to a person
29 in this State a medical discount plan or a membership in
30 connection with a medical discount plan unless the medical
31 discount plan is registered pursuant to this chapter.

32 2. Fails to provide any disclosure required pursuant to
33 section 9 of this act.

34 3. Fails to make available to an applicant for membership or
35 to a member, through a toll-free telephone number, upon the
36 request of the applicant or member, a complete and accurate list of
37 all participating providers of health care who have contracted with
38 the medical discount plan and who are located in the applicant's
39 or member's local area, or within a radius of 50 miles, and a list of
40 the health care or medical services for which the discounts are
41 applicable. The list must be made available, upon the request of
42 the applicant, at the time the applicant purchases a membership
43 and must be updated not less than once every 6 months.



1 4. Violates subsection 1 or 2 of section 8 of this act or
2 otherwise uses advertising or marketing material, brochures or
3 discount cards that are misleading, deceptive or fraudulent.

4 5. Offers discounted products or services to the applicant or
5 member that are not authorized by a contract with each provider
6 of health care listed in conjunction with the medical discount
7 plan.

8 6. Fails to allow the applicant or member to cancel the
9 membership in the medical discount plan.

10 7. If appropriate, fails to refund any required portion of
11 membership fees paid to the medical discount plan by the
12 applicant or member within 30 days after the applicant or member
13 provides timely notification of the cancellation of the membership
14 to the person administering the medical discount plan.

15 **Sec. 13.** A person who violates any provision of this chapter
16 or an order or regulation of the Commissioner issued or adopted
17 pursuant thereto may be assessed an administrative penalty by the
18 Commissioner of not more than \$2,000 for each act or violation,
19 not to exceed an aggregate amount of \$10,000 for violations of a
20 similar nature. For the purposes of this section, violations shall be
21 deemed to be of a similar nature if the violations consist of the
22 same or similar conduct, regardless of the number of times the
23 conduct occurred.

24 **Sec. 14.** 1. Except as otherwise provided in this subsection,
25 the Commissioner may conduct examinations to enforce the
26 provisions of this chapter pursuant to the provisions of NRS
27 679B.230 to 679B.300, inclusive, at such times as he deems
28 necessary. For the purposes of this chapter, the Commissioner is
29 not required to comply with the requirement in NRS 679B.230 that
30 insurers be examined not less frequently than every 5 years.

31 2. A person who is responsible for conducting the business
32 activities of a medical discount plan shall, upon the request of the
33 Commissioner, make available to the Commissioner for inspection
34 any accounts, books and records concerning the medical discount
35 plan which are reasonably necessary to enable the Commissioner
36 to determine whether the medical discount plan is in compliance
37 with the provisions of this chapter.

38 **Sec. 15.** 1. A medical discount plan must maintain records
39 of the transactions governed by this chapter. The records must
40 include:

41 (a) A copy of each type of contract that the medical discount
42 plan issues, sells or offers for sale;

43 (b) The name and address of each member of the medical
44 discount plan;



1 (c) A copy of each contract that the medical discount plan
2 enters into with providers of health care for purposes of providing
3 members with health care or medical services at a discount; and

4 (d) A copy of the annual certification of net worth and
5 supporting documentation.

6 2. Except as otherwise provided in this subsection, each
7 medical discount plan must retain all records for at least 7 years.
8 A medical discount plan which intends to discontinue doing
9 business in this State must provide the Commissioner with
10 satisfactory proof that it has discharged its duties to the members
11 in this State and must not destroy its records without the prior
12 approval of the Commissioner.

13 3. The records required to be maintained pursuant to this
14 section may be stored on a computer disc or other storage device
15 for a computer from which the records may be readily printed.

16 Sec. 16. The Commissioner may adopt regulations to carry
17 out the provisions of this chapter.

18 Sec. 17. Title 57 of NRS is hereby amended by adding thereto
19 a new chapter to consist of the provisions set forth as sections 18 to
20 61, inclusive, of this act.

21 Sec. 18. As used in this chapter, unless the context otherwise
22 requires, the words and terms defined in sections 19 to 40,
23 inclusive, of this act have the meanings ascribed to them in those
24 sections.

25 Sec. 19. "Closed-end credit" means a credit transaction that
26 is not open-end credit.

27 Sec. 20. "Collateral" means personal property in which a
28 purchase money security interest is retained or personal property
29 that is pledged as security for the satisfaction of a debt.

30 Sec. 21. "Compensation" means any valuable consideration,
31 direct or indirect, paid by or on behalf of the insurer, or by any
32 subsidiary or parent, or subsidiary of the parent of the insurer, or
33 by any other person to or on behalf of any group policyholder or
34 producer or withheld from an insurer by any group policyholder
35 or producer, and includes:

36 1. Paid or credited commissions or contingent commissions.

37 2. Fees for services, consulting fees or any other fee paid or
38 credited within or outside this State in direct relation to the volume
39 of premiums produced or written in this State.

40 3. The use of electronic data processing equipment or
41 services, except for devices provided in lieu of books and charts of
42 rates and refunds usable only for that purpose.

43 4. The furnishing of supplies, except forms approved by the
44 Commissioner, the usual forms for claims and reports, envelopes



1 *for transmitting claims and brochures, and books and charts of*
2 *rates and refunds.*

3 5. *Providing rental equipment of any type.*

4 6. *Advertising.*

5 7. *Providing telephone service without charge or at a charge*
6 *less than the usual cost.*

7 8. *Participation in a profit-sharing plan.*

8 9. *Dividends and refunds or credits based on experience*
9 *ratings.*

10 10. *An allowance for expenses.*

11 11. *Participation in stock plans or bonuses.*

12 12. *Any form of credit, including the use of money.*

13 13. *Commissions for reinsurance, ceded or assumed.*

14 14. *Reinsurance with a nonauthorized insurer owned or*
15 *controlled by a creditor or producer or with a nonauthorized*
16 *insurer in which a creditor or producer is a stockholder.*

17 15. *Any commission or fee, inducement or intention to*
18 *induce, or any other consideration arising from the sale of*
19 *insurance or other product or service, except credit personal*
20 *property insurance as part of the transaction in which the*
21 *indebtedness is arranged or the application for the credit personal*
22 *property insurance is made.*

23 **Sec. 22.** *“Credit agreement” means the written document*
24 *that sets forth the terms of the credit transaction and includes the*
25 *security agreement.*

26 **Sec. 23.** *“Credit personal property insurance” means a*
27 *policy, endorsement, rider, binder, certificate, or other instrument*
28 *or evidence of insurance written in connection with a credit*
29 *transaction that:*

30 1. *Covers perils to the goods purchased through a credit*
31 *transaction or used as collateral for a credit transaction and that*
32 *concerns the interest of a creditor in the purchased goods or*
33 *pledged collateral either in whole or in part; or*

34 2. *Covers perils to goods purchased in connection with an*
35 *open-end credit transaction.*

36 **Sec. 24.** *“Credit transaction” means any transaction for*
37 *which the terms of repayment of money loaned or loan*
38 *commitment made, or payment of goods, services or properties*
39 *sold or leased, is to be made at a future date.*

40 **Sec. 25.** *“Creditor” means the lender of money or vendor or*
41 *lessor of goods, services, property, rights or privileges for which*
42 *payment is arranged through a credit transaction, and includes:*

43 1. *The successor to the right, title or interest of;*

44 2. *An affiliate, associate or subsidiary of;*



- 1 3. Any director, officer or employee of; or
- 2 4. Any other person in any way associated with,
- 3 ↪ any such lender, vendor or lessor.

4 **Sec. 26.** *"Creditor-placed insurance" means single-interest*
5 *insurance or dual-interest insurance that is purchased by the*
6 *creditor, as the named insured, after a credit transaction:*

7 1. *According to the terms of the credit agreement as a result*
8 *of the debtor's failing to provide required insurance, the cost for*
9 *which is charged to the debtor; and*

10 2. *For coverage against loss, expense or damage to personal*
11 *property used as collateral as a result of fire, theft, collision or*
12 *other risk of loss that would impair the interest of the creditor or*
13 *adversely affect the value of the collateral.*

14 **Sec. 27.** *"Debtor" means a borrower of money or a*
15 *purchaser or lessee of goods, services, property, rights or*
16 *privileges for which payment is arranged through a credit*
17 *transaction.*

18 **Sec. 28.** *"Dual-interest insurance" means credit personal*
19 *property insurance covering the interest of the creditor or seller*
20 *and any portion of the interest of the borrower in goods purchased*
21 *through the credit transaction or pledged as collateral for the*
22 *credit transaction.*

23 **Sec. 29.** *"Experience" means earned premiums and incurred*
24 *losses during the experience period.*

25 **Sec. 30.** *"Experience period" means the most recent period*
26 *of time that is not more than 3 years and for which earned*
27 *premiums and incurred losses are reported.*

28 **Sec. 31.** *"Finance charge" means any charge payable*
29 *directly or indirectly as an incident to or condition of an extension*
30 *of credit, including, without limitation, interest, time-price*
31 *differentials, amounts payable under a discount system of*
32 *additional charges, service, transaction or carrying charges, loan*
33 *fees, points or similar charges, appraisal fees or charges incurred*
34 *for investigating the creditworthiness of the consumer. The term*
35 *does not include charges as a result of default, taxes, license fees,*
36 *delinquency charges or filing fees.*

37 **Sec. 32.** *"Gross debt" means the sum of the remaining*
38 *payments owed to a creditor by a debtor.*

39 **Sec. 33.** *"Identifiable charge" means a charge for credit*
40 *personal property insurance that is made to debtors who have that*
41 *insurance and not made to debtors who do not have that*
42 *insurance. The term includes a charge for insurance that is*
43 *disclosed in the credit agreement or other instrument furnished to*
44 *the debtor which sets forth the financial elements of the credit*
45 *transaction and any difference in the finance, interest, service or*



1 *other similar charge made to debtors who are in similar*
2 *circumstances except for the insured or noninsured status of the*
3 *debtor.*

4 **Sec. 34.** *“Incurred losses” means total claims and claim*
5 *adjustment expenses paid during the experience period plus any*
6 *change in claim and claim adjustment expense reserves.*

7 **Sec. 35.** *“Loss ratio” means incurred losses divided by the*
8 *sum of earned premiums.*

9 **Sec. 36.** *“Net debt” means the amount required to liquidate*
10 *the remaining debt in a single lump-sum payment, excluding all*
11 *unearned interest and other unearned finance charges.*

12 **Sec. 37.** *“Nonfiling insurance” means insurance that*
13 *indemnifies the creditor for loss of its interest in the collateral due*
14 *to failure to perfect a security interest in the collateral.*

15 **Sec. 38.** *“Open-end credit” means credit extended by a*
16 *creditor under an agreement in which:*

17 1. *The creditor reasonably contemplates repeated*
18 *transactions;*

19 2. *The creditor periodically imposes a finance charge on any*
20 *outstanding unpaid balance; and*

21 3. *The amount of credit that may be extended to the debtor*
22 *during the term of the agreement up to any limit set by the creditor*
23 *is generally made available to the extent that any outstanding*
24 *balance is repaid.*

25 **Sec. 39.** *“Reverse competition” means competition among*
26 *insurers that regularly takes the form of insurers competing for*
27 *the favor of a person who controls or may control the placement of*
28 *insurance with insurers that tends to increase insurance premiums*
29 *or prevents a decrease in insurance premiums in order to give*
30 *greater compensation to a person who controls or may control the*
31 *placement of insurance with insurers.*

32 **Sec. 40.** *“Single-interest insurance” means credit personal*
33 *property insurance covering only the interest of the seller or*
34 *creditor in goods purchased through a credit transaction or*
35 *pledged as collateral in a credit transaction.*

36 **Sec. 41.** *All credit personal property insurance, including*
37 *guaranteed asset protection insurance, written in connection with*
38 *credit transactions for personal, family or household purposes is*
39 *subject to the provisions of this chapter, except:*

40 1. *Credit transactions involving extensions of credit primarily*
41 *for business or commercial purposes;*

42 2. *Insurance written in connection with a credit transaction*
43 *that is secured by a real estate mortgage or deed of trust;*

44 3. *Creditor-placed insurance;*

45 4. *Title insurance;*



1 5. *Nonfiling insurance;*

2 6. *Insurance purchased by a creditor after repossession or a*
3 *similar event in which the creditor acquired possession of the*
4 *property; and*

5 7. *Insurance for which an identifiable charge is not made to*
6 *or collected from the debtor.*

7 **Sec. 42.** *For credit personal property insurance sold in*
8 *conjunction with a closed-end credit transaction, an insurer shall*
9 *not:*

10 1. *Issue credit personal property insurance unless the amount*
11 *financed exceeds \$300;*

12 2. *Issue credit personal property insurance in an amount that*
13 *exceeds the amount of the underlying credit transaction; and*

14 3. *Sell credit personal property insurance with a term that*
15 *exceeds the scheduled term of the underlying credit transaction.*

16 **Sec. 43.** *Credit personal property insurance must:*

17 1. *At a minimum, include the coverage in the standard fire*
18 *policy with coverage attachment and extended coverage*
19 *endorsement; and*

20 2. *Cover a substantial risk of loss of or damage to the*
21 *property related to the credit transaction.*

22 **Sec. 44.** *1. An insurer shall not:*

23 (a) *Require the bundling of other credit insurance coverage*
24 *with the purchase of credit personal property insurance; and*

25 (b) *Use gross debt in any manner to determine the premiums*
26 *for credit personal property insurance.*

27 2. *A debtor must have a choice to purchase credit personal*
28 *property insurance separately from other credit insurance*
29 *coverage.*

30 **Sec. 45.** *1. Before a debtor elects to purchase credit*
31 *personal property insurance in connection with a credit*
32 *transaction, the following information must be disclosed to the*
33 *debtor in writing:*

34 (a) *That the purchase of credit personal property insurance*
35 *from the creditor is not mandatory and is not a condition for*
36 *obtaining credit approval;*

37 (b) *If more than one type of credit insurance is made available*
38 *to the debtor, whether the debtor may purchase credit personal*
39 *property insurance separately from any other credit insurance;*

40 (c) *The conditions of eligibility;*

41 (d) *That if the debtor has other insurance that covers the risk,*
42 *the debtor may not want or need credit personal property*
43 *insurance;*

44 (e) *That the debtor may cancel the insurance at any time, or if*
45 *evidence of insurance is required for the extension of credit, upon*



1 *proof of insurance that is acceptable to the creditor, and obtain a*
2 *refund of or credit for:*

3 *(1) If the cancellation is not more than 30 days after the*
4 *debtor receives the individual policy or certificate of insurance,*
5 *any premium paid by the debtor; or*

6 *(2) If the cancellation is more than 30 days after the debtor*
7 *receives the individual policy or certificate of insurance, any*
8 *unearned premium paid by the debtor;*

9 *(f) A brief description of the coverage, including a description*
10 *of the amount, term, extensions, limitations, perils and exclusions,*
11 *the insured event, any waiting or elimination period, any*
12 *deductible, any applicable waiver of premium, the person who*
13 *would receive any benefits, and the premium or premium rate for*
14 *the credit personal property insurance; and*

15 *(g) If the premium or charge for the insurance is financed, it*
16 *will be subject to finance charges at the rate applicable to the*
17 *credit transaction.*

18 **2. The disclosures required pursuant to subsection 1:**

19 *(a) If made in connection with credit personal property*
20 *insurance offered at the same time as the extension of credit or*
21 *offered through direct mail advertisements, must be made in*
22 *writing and presented to the customer in a clear and conspicuous*
23 *manner; or*

24 *(b) If made in connection with credit personal property*
25 *insurance offered after the extension of credit other than through*
26 *direct mail advertisements, may be provided orally or*
27 *electronically if written disclosures are provided not later than the*
28 *earlier of:*

29 *(1) Ten days after the debtor elects to accept the coverage;*
30 *or*

31 *(2) The date any other written material is provided by the*
32 *creditor to the debtor.*

33 **Sec. 46.** *An offer to extend coverage for an open-end credit*
34 *transaction must include, at the time of the invitation to contract,*
35 *a written disclosure or, if the solicitation is made by telephone and*
36 *the written disclosure is mailed to the debtor not later than 10 days*
37 *after enrollment, an oral summary of the written disclosure. The*
38 *written disclosure must be in not smaller than 12-point type and be*
39 *in substantially the following form:*

40
41 *This coverage may duplicate existing coverage if you*
42 *have a residential property insurance policy. It applies to*
43 *any item of covered property on which you owe a debt. This*
44 *coverage is primary, so it is the first source to be used in the*
45 *event of a loss on property it covers. You may cancel this*



coverage at any time by calling the insurer during business hours at the telephone number provided to you or by writing to the insurer. We are charging you a premium that may be based on subjects for which a claim cannot be made, such as services, meals or other consumables, entertainment, finance or service fees, loan interest, delivery charges or other insurance premiums.

Sec. 47. 1. All credit personal property insurance must be evidenced by an individual policy or a certificate of insurance that is delivered to the debtor.

2. The individual policy or certificate of insurance must, in addition to other requirements of law, include:

(a) The name and address of the home office of the insurer;

(b) The name of each debtor or, on a certificate of insurance, the identity by name or otherwise of each debtor;

(c) The amount of the premium or payment of the debtor or, for open-end credit, the premium rate, basis of the calculation of premiums and balance to which the premium rate applies;

(d) A complete description of the coverage or coverages, including the amount, term and any exceptions, limitations and exclusions of coverage;

(e) A statement that all benefits must be paid to the creditor to reduce or extinguish the unpaid debt or to repair or replace the property and that if the benefits exceed the unpaid debt, any excess benefit must be paid to the debtor;

(f) If the scheduled term of the insurance is less than the scheduled term of the credit transaction, a statement indicating that fact set forth on the face of the individual policy or certificate of insurance in not less than 10-point bold type; and

(g) If the policy is related to open-end credit, a statement that the debtor will, at least once each year, receive the statement as required pursuant to subsection 3.

3. For credit personal property insurance related to open-end credit, the creditor must provide to the debtor at least once each year with the account statement a statement in the following form in at least 12-point type:

You are paying a premium for credit personal property insurance based on the outstanding balance of this account. You may cancel this coverage at any time by calling the insurer during business hours at the telephone number provided to you or by writing to the insurer. You are being charged a premium that may be based on subjects for which a claim cannot be made, such as services, meals or other



consumables, entertainment, finance or service fees, loan interest, delivery charges or other insurance premiums.

Sec. 48. 1. Except as otherwise provided in subsection 2, the individual policy or certificate of insurance must be delivered to the debtor upon acceptance of the insurance by the insurer.

2. An individual policy or certificate of insurance made in connection with an open-end credit agreement or any credit personal property insurance requested by the debtor after the date the debt is incurred must be delivered to the debtor not more than 30 days after the debtor requested the insurance.

Sec. 49. 1. Except as otherwise provided in sections 50 and 51 of this act, all policies, certificates of insurance, applications for insurance, enrollment forms, endorsements and riders delivered or issued for delivery in this State and the schedules of premium rates related thereto must be filed with the Commissioner.

2. An item filed with the Commissioner pursuant to subsection 1 may not be issued until 60 days after it is filed with the Commissioner or until the written prior approval of the Commissioner is obtained.

3. The Commissioner shall, not more than 60 days after an item is submitted to him pursuant to subsection 1, disapprove the item if the benefits are not reasonable in relation to the premium charged or if the item contains provisions that are unjust, unfair, inequitable, misleading or deceptive or encourage misrepresentation of the coverage or are contrary to any provision of the Code or any regulation adopted pursuant to the Code. If the Commissioner does not disapprove an item filed pursuant to subsection 1 in accordance with this subsection, the item shall be deemed to be approved.

4. If the Commissioner notifies an insurer that an item is disapproved pursuant to subsection 3, the insurer shall not use the item. The notice must include the reason for the disapproval and state that a hearing will be granted not more than 30 days after the insurer submits a written request for a hearing to the Commissioner, unless postponed by mutual consent or by order of the Commissioner.

5. The Commissioner may hold a hearing to withdraw approval of an item submitted pursuant to subsection 1 not less than 20 days after providing a written notice of the hearing to the insurer. The written notice must include one of the reasons described in subsection 3 for the proposed withdrawal of approval of the item. An insurer shall not use an item if approval of the item is withdrawn pursuant to this subsection.

36 *on a debtor to provide indemnity for payments or a debt becoming*

40 *4. If a premium is assessed to the debtor on a monthly basis*
41 *and is based on the actual net debt, the amount payable at the time*
42 *of loss must not be less than the actual net debt on the date of*
43 *death. If the premium is based on a balance that does not include*
44 *accrued past due interest, the amount payable at the time of loss*



1 *must not be less than the actual net debt less any accrued interest*
2 *that is more than 2 months past due.*

3 5. *Insurance on agricultural loan commitments that do not*
4 *exceed 1 year in duration may be written for not more than the*
5 *amount of the loan on a nondecreasing or level term plan.*

6 6. *Insurance on educational loan commitments may be*
7 *written for the net unpaid debt plus any unused commitment.*

8 7. *Coverage may be written for less than the net debt through*

16 **Sec. 103.** 1. The term of any consumer credit insurance
17 must not extend beyond the date of termination specified in the
18 policy. The date of termination of the insurance must not occur
19 more than 15 days after the scheduled maturity date of the debt to
20 which it relates unless:

21 (a) The date is extended at no additional cost to the debtor; or

22 (b) The date is extended pursuant to a written agreement
23 signed by the debtor and relates to a variable rate credit
24 transaction or a deferral, renewal, refinancing or consolidation of

20 (f) A brief description of the coverage, including a description
21 of the amount, term, exceptions, limitations and exclusions, the
22 insured event, any waiting or elimination period, any deductible,
23 any applicable waiver of premium, the person who would receive
24 any benefits, and the premium or premium rate for the consumer
25 credit insurance; and

26 (g) If the premium or insurance charge is financed, that it will
27 be subject to finance charges at the rate applicable to the credit
28 transaction.

29 2. The disclosures required pursuant to subsection 1:

30 (a) If made in connection with consumer credit insurance
31 offered at the same time as the extension of credit or offered
32 through direct mail advertisements, must be made in writing and
33 presented to the customer in a clear and conspicuous manner; or

34 (b) If made in connection with consumer credit insurance
35 offered after the extension of credit other than through direct mail
36 advertisements, may be provided orally or electronically if written
37 disclosures are provided not later than the earlier of:

38 (1) Ten days after the debtor elects to accept the coverage;
39 or

40 (2) The date any other written material is provided to the
41 debtor.

42 **Sec. 105. 1. All consumer credit insurance must be**
43 **evidenced by an individual policy or a group certificate that is**
44 **delivered to the debtor.**



1 2. *The individual policy or group certificate must, in addition*
2 *to other requirements of law, include:*

3 (a) *The name and address of the home office of the insurer;*

4 (b) *The name of each debtor or, on a certificate of insurance,*
5 *the identity by name or otherwise of each debtor;*

6 (c) *The amount of the premium or payment of the debtor*
7 *stated separately for each type of coverage or as a package or, for*

1 (e) A statement that upon acceptance by the insurer, the
2 insurance will become effective as described in section 102 of this

4 2. The application or notice of insurance provided pursuant
5 to subsection 1 must:

6 (a) Refer exclusively to consumer credit insurance; and

7 (b) Be separate from the loan, sale or other credit statement,
8 instrument or agreement unless the information required
9 pursuant to subsection 1 is prominently set forth in the statement,
10 instrument or agreement.

11 3. The application or notice of insurance provided pursuant
12 to subsection 1 may be used to meet the requirements of sections
13 104 and 105 of this act if it includes the information required by
14 those sections.

15 **Sec. 107.** 1. If a named insurer does not accept the
16 insurance and another insurer accepts the insurance, the insurer
17 shall provide an individual policy or group certificate that includes
18 the name and address of the home office of the insurer who

- (e) For a sponsored captive insurer, not less than \$200,000.*

2. Except as otherwise provided by the Commissioner pursuant to subsection 3, the capital required to be maintained pursuant to this section must be in the form of cash or an irrevocable letter of credit.

3. The Commissioner may prescribe additional requirements relating to capital based on the type, volume and nature of the insurance business that is transacted by the captive insurer and requirements regarding which capital, if any, may be in the form of an irrevocable letter of credit.

4. A letter of credit used by a captive insurer as evidence of capital required pursuant to this section must:

- (a) Be issued by a bank chartered by this State or a bank that is a member of the United States Federal Reserve System and has been approved by the Commissioner; and
- (b) Include a provision pursuant to which the letter of credit is automatically renewable each year, unless the issuer gives written notice to the Commissioner and the captive insurer at least 90 days before the expiration date.

(b) Include a provision pursuant to which the letter of credit is automatically renewable each year, unless the issuer gives written notice to the Commissioner and the captive insurer at least 90 days before the expiration date.
