

ASSEMBLY BILL NO. 349—ASSEMBLYWOMAN GANSERT

SUMMARY—Makes appropriation for development and implementation of improvements in information technology and administrative capabilities of Division of Water Resources of State Department of Conservation and Natural Resources. (BDR S-1265)

AN ACT making an appropriation to the Interim Finance Committee for allocation to the State Engineer for development and implementation of improvements in information technology and administrative capabilities; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
- 2 General Fund to the Interim Finance Committee the sum of
- 3 \$5,000,000 for allocation to the State Engineer for development and
- 4 implementation of improvements in information technology and
- 5 administrative capabilities of the Division of Water Resources of the
- 6 State Department of Conservation and Natural Resources.
- 7 2. The State Engineer may submit a request to the Interim
- 8 Finance Committee for the allocation of all or any part of the money
- 9 appropriated by subsection 1 at any time. Any such request must
- 10 include a plan for the development and implementation of
- 11 improvements in information technology and administrative
- 12 capabilities of the Division of Water Resources.

1 3. Upon receipt of a request from the State Engineer for the
2 allocation of money appropriated by subsection 1, the Interim
3 Finance Committee shall consider the request and may require any
4 additional information that it determines is necessary to make a final
5 decision.

6 4. Upon considering a request submitted by the State Engineer,
7 and any additional information requested, the Interim Finance
8 Committee shall determine whether to allocate all or any portion of
9 the money appropriated by subsection 1. The Interim Finance
10 Committee is not required to approve the entire funding in any
11 request or to allocate the entire amount appropriated. If the Interim
12 Finance Committee makes an allocation of money pursuant to this
13 section, it shall require such documentation and reporting as it
14 deems necessary. Any change from the plans for the development
15 and implementation of improvements in information technology and
16 administrative capabilities that were submitted with the request for
17 the allocation must be approved by the Interim Finance Committee
18 before money is committed for expenditure on the portion that is
19 changed.

20 5. Any remaining balance of the appropriation made by
21 subsection 1 must not be committed for expenditure after June 30,
22 2007, and must be reverted to the State General Fund on or before
23 September 21, 2007.

24 **Sec. 2.** This act becomes effective on July 1, 2005.
