**SUMMARY**—Requires Legislative Auditor to conduct performance audits of College of Agriculture, Biotechnology and Natural Resources at University of Nevada, Reno, and School of Dental Medicine at University of Nevada, Las Vegas. (BDR S-493)

AN ACT relating to the University and Community College System of Nevada; requiring the Legislative Auditor to conduct performance audits of the College of Agriculture, Biotechnology and Natural Resources at the University of Nevada, Reno, and the School of Dental Medicine at the University of Nevada, Las Vegas; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

- 1      Existing law gives the Legislative Auditor the duty and authority to perform  
2      audits of state agencies on a rotating basis. (NRS 218.737-218.893)  
3      This bill requires the Legislative Auditor to conduct performance audits of the  
4      College of Agriculture, Biotechnology and Natural Resources at the University of  
5      Nevada, Reno, and the School of Dental Medicine at the University of Nevada, Las  
6      Vegas. The bill requires that the audit reports be submitted to the Audit  
7      Subcommittee of the Legislative Commission on or before the first day of the 2007  
8      Legislative Session.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** 1. The Legislative Auditor shall conduct a  
2 performance audit of the following entities within the University  
3 and Community College System of Nevada:

4             (a) The College of Agriculture, Biotechnology and Natural  
5 Resources at the University of Nevada, Reno; and

6             (b) The School of Dental Medicine at the University of Nevada,  
7 Las Vegas.

8       2. The audit of the College of Agriculture, Biotechnology and  
9 Natural Resources must include, without limitation, an examination  
10 of the financial and administrative practices of the College,  
11 including:

12             (a) The accuracy and reliability of its information and reports;

13             (b) The effectiveness of its system of management controls;

14             (c) The extent to which its operations are conducted in  
15 accordance with applicable law and regulations; and

16             (d) The extent to which its operations are conducted in  
17 accordance with contractual obligations.

18       3. The audit of the School of Dental Medicine must include,  
19 without limitation, an examination of the financial activities and  
20 treatment programs of the School, including:

21             (a) An analysis of information relating to treatments, including:  
22                 (1) A comparison of scheduled procedures with actual  
23 procedures performed;

24                 (2) A comparison of the number of patient visits  
25 recommended for the completion of an established treatment plan  
26 with the actual number of such patient visits;

27                 (3) The number of patients examined and treated by dental  
28 students;

29                 (4) The number of extractions performed and the ages of  
30 patients undergoing the extractions; and

31                 (5) The use of local dental practitioners to provide dental  
32 services through the School, including the number of hours worked  
33 by such providers, the number of patients treated and the services  
34 provided.

35             (b) An analysis of information relating to patients and the costs  
36 of services provided, including:

37                 (1) For patients who are recipients of Medicaid, the number  
38 of patients treated, their age and sex and the types of treatments  
39 provided;

40                 (2) For patients who are not recipients of Medicaid, the  
41 number of patients treated, their income levels, the types of



1 treatments provided, and whether they are covered by insurance  
2 plans;

3       (3) The cost of providing services to patients who are eligible  
4 to receive Medicaid and the amount of Medicaid reimbursements  
5 received; and

6       (4) The cost of providing services to patients who are not  
7 recipients of Medicaid and the amounts of insurance and other  
8 payments received.

9       (c) An analysis of the "Crackdown on Cancer" program  
10 operated by the School, including:

11           (1) The number of students screened;

12           (2) The number of eligible students not screened;

13           (3) Methods used to ensure the accuracy of the screening  
14 numbers reported, including the methods used to eliminate  
15 duplicates;

16           (4) The cost of the various components of the screening  
17 program; and

18           (5) The number of screenings that result in the detection of  
19 lesions and the number of students that receive treatment for this  
20 condition.

21       (d) An analysis of financial operations and financial planning,  
22 including:

23           (1) Overall cost of operations;

24           (2) Overall revenues, including appropriations made from the  
25 State General Fund;

26           (3) The extent to which the School plans to finance future  
27 operations with appropriations made from the State General Fund;  
28 and

29           (4) The adequacy of financial planning, including an  
30 evaluation of policies to ensure that programs are self-sustaining.

31       4. The Legislative Auditor shall prepare a written report of  
32 each performance audit and present the report to the Audit  
33 Subcommittee of the Legislative Commission not later than  
34 February 5, 2007.

35       5. The provisions of NRS 218.737 to 218.893, inclusive, apply  
36 to each performance audit conducted pursuant to this section.

37       **Sec. 2.** 1. Upon the request of the Legislative Auditor, the  
38 University and Community College System of Nevada shall transfer  
39 from its budget to the Audit Division of the Legislative Counsel  
40 Bureau:

41           (a) The sum of \$50,000 to conduct the audit of the College of  
42 Agriculture, Biotechnology and Natural Resources at the University  
43 of Nevada, Reno required in section 1 of this act.

1       (b) The sum of \$50,000 to conduct the audit of the School of  
2 Dental Medicine at the University of Nevada, Las Vegas required in  
3 section 1 of this act.

4       2. Any remaining balance of the sums transferred pursuant to  
5 subsection 1 must not be committed for expenditure after  
6 February 5, 2007, and reverts to the University and Community  
7 College System of Nevada as soon as all payments of money  
8 committed have been made.

9       **Sec. 3.** This act becomes effective on July 1, 2005.
