**SUMMARY**—Increases compensation of members of boards of trustees of school districts. (BDR 34-1173)

AN ACT relating to school districts; increasing the monthly salaries of members of boards of trustees of school districts; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1      **Section 1.** NRS 386.320 is hereby amended to read as follows:  
2      386.320    1. ~~If the total pupil enrollment in the school district for the immediately preceding school year is less than 1,000:~~  
3      ~~(a) The clerk and president of the board of trustees may each receive a salary of \$85 for each board of trustees meeting they attend, not to exceed \$170.~~ **Each member of the board of trustees of a school district in a county whose population is 100,000 or more is entitled to receive a salary of \$1,200** a month.  
4      ~~(b) The other trustees may each receive a salary of \$80 for each board of trustees meeting they attend, not to exceed \$160 a month.~~  
5      ~~(c) The board of trustees of such a school district may hire a stenographer to take the minutes of the meetings of the board of trustees, and the stenographer may be paid a reasonable fee for each meeting attended.~~  
6      2. ~~If the total pupil enrollment in the school district for the immediately preceding school year is 1,000 or more:~~

1       (a) The clerk and president of the board of trustees may each  
2 receive a salary of \$85 for each board of trustees meeting they  
3 attend, not to exceed \$510] *Each member of the board of trustees*  
4 *of a school district in a county whose population is less than*  
5 *100,000 is entitled to receive a salary in an amount set by a vote of*  
6 *the members of the board of trustees of that school district. The*  
7 *salary set pursuant to this subsection must not be less than \$600 a*  
8 *month but must not exceed \$1,200* a month.

9       (b) The other trustees may each receive a salary of \$80 for each  
10 board of trustees meeting they attend, not to exceed \$480 a month.

11       (c) The board of trustees *of such a school district* may hire a  
12 stenographer to take the minutes of the meetings of the board of  
13 trustees, and the stenographer may be paid a reasonable fee for each  
14 meeting attended.

15       **Sec. 2.** The provisions of NRS 354.599 do not apply to any  
16 additional expenses of a local government that are related to the  
17 provisions of this act.

18       **Sec. 3.** This act becomes effective on July 1, 2005.
