AN ACT relating to elections; requiring the form adopted by the
Secretary of State for the reporting of campaign
contributions and expenses or expenditures to include a
space to list cash on hand; and providing other matters
properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 294A.373 is hereby amended to read as
2 follows:
3 294A.373 1. The Secretary of State shall design a single form
4 to be used for all reports of campaign contributions and expenses or
5 expenditures that are required to be filed pursuant to NRS
6 294A.120, 294A.125, 294A.140, 294A.150, 294A.200, 294A.210,
7 294A.220, 294A.270, 294A.280, 294A.360 and 294A.362.
8 2. *In addition to the information required by NRS 294A.120,*
9 *294A.125, 294A.140, 294A.150, 294A.200, 294A.210, 294A.220,*
10 *294A.270, 294A.280, 294A.360 and 294A.362, the form designed*
11 *by the Secretary of State pursuant to this section must include a*
12 *space to list the amount of cash on hand at the beginning of the:*
13 (a) *Reporting period; and*
14 (b) *Reporting year.*



1 **3.** The form designed by the Secretary of State pursuant to this
2 section must only request information specifically required by
3 statute.

4 ~~3.~~ **4.** Upon request, the Secretary of State shall provide a
5 copy of the form designed pursuant to this section to each person,
6 committee, political party and group that is required to file a report
7 described in subsection 1.

8 **5.** *The Secretary of State shall reject a report of campaign*
9 *contributions and expenses or expenditures that is filed pursuant*
10 *to NRS 294A.120, 294A.125, 294A.140, 294A.150, 294A.200,*
11 *294A.210, 294A.220, 294A.270, 294A.280, 294A.360 or 294A.362*
12 *that is incomplete. If the Secretary of State determines that a*
13 *report is incomplete he shall notify the person or entity that filed*
14 *the report that the report is rejected. A rejected report shall not be*
15 *considered to be filed with the Secretary of State.*

16 **Sec. 2.** This act becomes effective on January 1, 2006.
