AN ACT making an appropriation to the Clark County Public Education Foundation and the Nevada Public Education Foundation of Washoe County for new programs and expansion of outreach efforts; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     **Section 1.** There is hereby appropriated from the State  
2 General Fund to the Clark County Public Education Foundation,  
3 Inc., the sum of \$250,000 for new programs and the expansion of  
4 outreach efforts.
- 5     **Sec. 2.** Upon acceptance of the money appropriated by section  
6 1 of this act, the Clark County Public Education Foundation, Inc.,  
7 shall:
- 8         1. Prepare and transmit a report to the Interim Finance  
9 Committee on or before December 15, 2006, that describes each  
10 expenditure made from the money appropriated by section 1 of this  
11 act from the date on which the money was received by the Clark  
12 County Public Education Foundation, Inc., through December 1,  
13 2006; and



1       2. Upon request of the Legislative Commission, make available  
2 to the Legislative Auditor any of the books, accounts, claims,  
3 reports, vouchers or other records of information, confidential or  
4 otherwise of the Clark County Public Education Foundation, Inc.,  
5 regardless of their form or location, that the Legislative Auditor  
6 deems necessary to conduct an audit of the use of the money  
7 appropriated pursuant to section 1 of this act.

8       **Sec. 3.** Any remaining balance of the appropriation made by  
9 section 1 of this act must not be committed for expenditure after  
10 June 30, 2007, and must be reverted to the State General Fund on or  
11 before September 21, 2007.

12       **Sec. 4.** There is hereby appropriated from the State General  
13 Fund to the Nevada Public Education Foundation of Washoe  
14 County the sum of \$150,000 for new programs and the expansion of  
15 outreach efforts.

16       **Sec. 5.** Upon acceptance of the money appropriated by section  
17 4 of this act, the Nevada Public Education Foundation shall:

18       1. Prepare and transmit a report to the Interim Finance  
19 Committee on or before December 15, 2006, that describes each  
20 expenditure made from the money appropriated by section 4 of this  
21 act from the date on which the money was received by the Nevada  
22 Public Education Foundation through December 1, 2006; and

23       2. Upon request of the Legislative Commission, make available  
24 to the Legislative Auditor any of the books, accounts, claims,  
25 reports, vouchers or other records of information, confidential or  
26 otherwise of the Nevada Public Education Foundation, regardless of  
27 their form or location, that the Legislative Auditor deems necessary  
28 to conduct an audit of the use of the money appropriated pursuant to  
29 section 4 of this act.

30       **Sec. 6.** Any remaining balance of the appropriation made by  
31 section 4 of this act must not be committed for expenditure after  
32 June 30, 2007, and must be reverted to the State General Fund on or  
33 before September 21, 2007.

34       **Sec. 7.** This act becomes effective upon passage and approval.
