

ASSEMBLY BILL NO. 460—COMMITTEE ON WAYS AND MEANS

SUMMARY—Makes appropriations to Clark County Public Education Foundation and Washoe County School District Educational Foundation, Inc., for new programs and expansion of outreach efforts. (BDR S-826)

AN ACT making an appropriation to the Clark County Public Education Foundation and the Washoe County School District Educational Foundation, Inc., for new programs and expansion of outreach efforts; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** There is hereby appropriated from the State
- 2 General Fund to the Clark County Public Education Foundation,
- 3 Inc., the sum of \$250,000 for new programs and the expansion of
- 4 outreach efforts.
- 5 **Sec. 2.** Upon acceptance of the money appropriated by section
- 6 1 of this act, the Clark County Public Education Foundation, Inc.,
- 7 shall:
- 8 1. Prepare and transmit a report to the Interim Finance
- 9 Committee on or before December 15, 2006, that describes each
- 10 expenditure made from the money appropriated by section 1 of this
- 11 act from the date on which the money was received by the Clark
- 12 County Public Education Foundation, Inc., through December 1,
- 13 2006; and



1 2. Upon request of the Legislative Commission, make available  
2 to the Legislative Auditor any of the books, accounts, claims,  
3 reports, vouchers or other records of information, confidential or  
4 otherwise of the Clark County Public Education Foundation, Inc.,  
5 regardless of their form or location, that the Legislative Auditor  
6 deems necessary to conduct an audit of the use of the money  
7 appropriated pursuant to section 1 of this act.

8 **Sec. 3.** Any remaining balance of the appropriation made by  
9 section 1 of this act must not be committed for expenditure after  
10 June 30, 2007, and must be reverted to the State General Fund on or  
11 before September 21, 2007.

12 **Sec. 4.** There is hereby appropriated from the State General  
13 Fund to the Washoe County School District Educational  
14 Foundation, Inc., the sum of \$150,000 for new programs and the  
15 expansion of outreach efforts.

16 **Sec. 5.** Upon acceptance of the money appropriated by section  
17 4 of this act, the Washoe County School District Educational  
18 Foundation, Inc., shall:

19 1. Prepare and transmit a report to the Interim Finance  
20 Committee on or before December 15, 2006, that describes each  
21 expenditure made from the money appropriated by section 4 of this  
22 act from the date on which the money was received by the Washoe  
23 County School District Educational Foundation, Inc., through  
24 December 1, 2006; and

25 2. Upon request of the Legislative Commission, make available  
26 to the Legislative Auditor any of the books, accounts, claims,  
27 reports, vouchers or other records of information, confidential or  
28 otherwise of the Washoe County School District Educational  
29 Foundation, Inc., regardless of their form or location, that the  
30 Legislative Auditor deems necessary to conduct an audit of the use  
31 of the money appropriated pursuant to section 4 of this act.

32 **Sec. 6.** Any remaining balance of the appropriation made by  
33 section 4 of this act must not be committed for expenditure after  
34 June 30, 2007, and must be reverted to the State General Fund on or  
35 before September 21, 2007.

36 **Sec. 7.** This act becomes effective upon passage and approval.
