
ASSEMBLY BILL NO. 461—COMMITTEE ON WAYS AND MEANS

MARCH 28, 2005

Referred to Committee on Ways and Means

SUMMARY—Makes appropriation to Department of Education for programs of performance pay and enhanced compensation for recruitment, retention and mentoring of teachers. (BDR S-1391)

AN ACT relating to education; making an appropriation to the Department of Education for distribution to school districts that adopt programs of performance pay and enhanced compensation for the recruitment, retention and mentoring of teachers; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
2 General Fund to the Department of Education the sum of
3 \$10,000,000 for grants of money to school districts that adopt a
4 program of performance pay and enhanced compensation for the
5 recruitment, retention and mentoring of teachers pursuant to this
6 section.
7 2. To receive a grant of money, the board of trustees of a
8 school district may submit an application to the Department of
9 Education that:
10 (a) Sets forth a program of performance pay and enhanced
11 compensation for the recruitment, retention and mentoring of
12 teachers adopted by the school district and negotiated pursuant to



1 chapter 288 of NRS, which includes one or more of the following
2 components:

3 (1) Skills-based pay pursuant to which teachers develop
4 certain skills verified through licensure, certification or some other
5 method.

6 (2) A “career ladder” program, pursuant to which teachers
7 who perform at or above specified standards receive an increase in
8 compensation. Each step requires additional growth, professional
9 development, expertise and additional responsibilities, including,
10 without limitation, mentoring.

11 (3) Market-based pay, pursuant to which one-time bonuses
12 are paid to retain teachers who provide instruction in high-need
13 subject areas such as mathematics, science and special education
14 and to retain teachers who teach in at-risk schools.

15 (b) Includes the amount of money necessary to pay the enhanced
16 compensation pursuant to the program.

17 (c) Includes the number of teachers who are estimated to be
18 eligible for enhanced compensation pursuant to the program.

19 3. To the extent money is available from the appropriation
20 made by subsection 1, the Department of Education shall provide
21 grants of money to school districts with approved applications based
22 upon the amount of money that is necessary to carry out each
23 program. If an insufficient amount of money is available to pay for
24 each program, the money from the appropriation must be distributed
25 pro rata based upon the number of teachers who are estimated to be
26 eligible to participate in the program in each school district with an
27 approved application.

28 **Sec. 2.** Any remaining balance of the appropriation made by
29 section 1 of this act must not be committed for expenditure after
30 June 30, 2007, and must be reverted to the State General Fund on or
31 before September 21, 2007.

32 **Sec. 3.** This act becomes effective on July 1, 2005.
