

ASSEMBLY BILL NO. 464—COMMITTEE ON WAYS AND MEANS

MARCH 28, 2005

Referred to Concurrent Committees on  
Commerce and Labor and Ways and Means

SUMMARY—Makes various changes regarding manufacture, sale  
and use of tobacco products. (BDR 32-1028)

AN ACT relating to tobacco; making various changes regarding the  
sale, delivery and taxation of cigarettes; revising the  
duties, rights and licensing requirements of  
manufacturers, wholesale dealers and retail dealers of  
cigarettes; providing additional procedures for statutory  
enforcement; increasing certain criminal penalties and  
providing additional civil and criminal penalties; and  
providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

**Section 1.** Chapter 370 of NRS is hereby amended by adding  
thereto the provisions set forth as sections 2 to 28, inclusive, of this  
act.

**Sec. 2.** *“Cigarette package” means the individual pack, box  
or other container that contains a cigarette. The term does not  
include a container that itself contains other containers, such as a  
carton of cigarettes.*

**Sec. 3.** *“Counterfeit cigarettes” means any cigarettes or  
cigarette packages:*

- 1. Bearing false manufacturing labels;*
- 2. Bearing counterfeit stamps; or*
- 3. Meeting any combination of the descriptions contained in  
subsections 1 and 2.*



1     **Sec. 4.** *“Counterfeit stamp” means any stamp that:*

2     1. *Falsely depicts a stamp approved by the Department or a*  
3 *tax stamp authorized pursuant to the laws of any other state*  
4 *governing the taxation of cigarettes; or*

5     2. *Was not sold by the Department or its agents or pursuant*  
6 *to the laws of any other state governing the taxation of cigarettes.*

7     **Sec. 5.** 1. *“Delivery sale” means any sale of cigarettes,*  
8 *whether the seller is located within or outside of the borders of this*  
9 *State, to a consumer in this State for which:*

10     (a) *The purchaser submits the order for the sale by means of a*  
11 *telephonic or other method of voice transmission, the mail or any*  
12 *other delivery service, or the Internet or any other on-line service;*  
13 *or*

14     (b) *The cigarettes are delivered by mail or the use of another*  
15 *delivery service.*

16     2. *For the purpose of this section, any sale of cigarettes to a*  
17 *natural person in this State who does not hold a current license as*  
18 *a wholesale or retail dealer constitutes a sale to a consumer.*

19     **Sec. 6.** *“Delivery service” means any person engaged in the*  
20 *commercial delivery of letters, packages or other containers.*

21     **Sec. 7.** *“License” means a license issued pursuant to NRS*  
22 *370.001 to 370.430, inclusive, and sections 2 to 28, inclusive, of*  
23 *this act, that authorizes the holder to conduct business as a*  
24 *manufacturer or a wholesale or retail dealer.*

25     **Sec. 8.** *“Licensee” means the holder of a license.*

26     **Sec. 9.** *“Manufacturer” means any person who:*

27     1. *Manufactures, fabricates, assembles, processes or labels a*  
28 *finished cigarette; or*

29     2. *Imports, whether directly or indirectly, a finished cigarette*  
30 *into the United States for sale or distribution in this State.*

31     **Sec. 10.** *“Place of business” means, for a person engaged in*  
32 *business as:*

33     1. *A wholesale dealer, any location from which cigarettes are*  
34 *distributed or where cigarettes are warehoused, stored or affixed*  
35 *with stamps; or*

36     2. *A retail dealer, any store, stand, outlet or other location*  
37 *through which cigarettes are distributed or sold to a consumer.*

38     **Sec. 11.** *“Secretary” means the Secretary of the United*  
39 *States Department of the Treasury.*

40     **Sec. 12.** *“Shipping container” means a container in which*  
41 *cigarettes are shipped in connection with a delivery sale.*

42     **Sec. 13.** *“Shipping documents” means bills of lading, airbills*  
43 *or any other documents used to evidence an undertaking by a*  
44 *delivery service to deliver letters, packages or other containers.*



1     **Sec. 14.** *“Stamp” means the indicia required to be placed on*  
2 *a cigarette package that evidences payment of the taxes on*  
3 *cigarettes imposed pursuant to NRS 370.0751 and 370.165.*

4     **Sec. 15.** *1. No license may be issued, maintained or*  
5 *renewed:*

6         *(a) If the applicant for the license or any combination of*  
7 *persons directly or indirectly owning, in the aggregate, more than*  
8 *10 percent of the ownership interests in the applicant:*

9             *(1) Owes \$500 or more in delinquent cigarette taxes;*

10            *(2) Had a license as a manufacturer or as a wholesale or*  
11 *retail dealer revoked by the Department within the past 2 years;*

12            *(3) Has been convicted of a crime relating to the sale of*  
13 *stolen or counterfeit cigarettes or stamps or the receipt of stolen*  
14 *cigarettes;*

15            *(4) Is a manufacturer who has:*

16                 *(I) Imported any cigarettes into the United States in*  
17 *violation of 19 U.S.C. § 1681a; or*

18                 *(II) Imported or manufactured any cigarettes that do not*  
19 *fully comply with the Federal Cigarette Labeling and Advertising*  
20 *Act, 15 U.S.C. §§ 1331 et seq.; or*

21            *(5) Is a nonparticipating manufacturer who is not in full*  
22 *compliance with subsection 2 of NRS 370A.140.*

23         *(b) Unless the applicant for the license certifies in writing,*  
24 *under penalty of perjury, that the applicant will comply fully with*  
25 *the provisions of chapter 370A of NRS.*

26     **2.** *As used in this section:*

27         *(a) “Manufacturer of tobacco products” has the meaning*  
28 *ascribed to it in NRS 370A.060.*

29         *(b) “Nonparticipating manufacturer” means any*  
30 *manufacturer of tobacco products that is not a participating*  
31 *manufacturer.*

32         *(c) “Participating manufacturer” has the meaning ascribed to*  
33 *it in NRS 370A.080.*

34     **Sec. 16.** *The Department shall create and maintain on its*  
35 *Internet website and otherwise make available for public*  
36 *inspection a list of all:*

37         *1. Currently valid licenses and the identity of the licensees*  
38 *holding those licenses; and*

39         *2. Indian tribes on whose reservations or colonies cigarettes*  
40 *or other products made from tobacco are sold and, pursuant to*  
41 *NRS 370.515, from which the Department does not collect the tax*  
42 *imposed by this chapter on such cigarettes or other products made*  
43 *from tobacco sold on the reservations or colonies.*

44     ↪ *The Department shall update the list at least once each month.*



1     **Sec. 17. 1.** *Except as otherwise provided in subsection 2 or*  
2 *a regulation of the Department:*

3     (a) *No person, other than a wholesale dealer that receives*  
4 *unstamped cigarette packages directly from a person who holds a*  
5 *current permit to engage in business as a manufacturer or*  
6 *importer of cigarettes issued pursuant to 26 U.S.C. § 5713, may*  
7 *possess an unstamped cigarette package.*

8     (b) *Any person who ships unstamped cigarette packages into*  
9 *this State other than to a wholesale dealer who holds a current*  
10 *license shall first file with the Department a notice of that*  
11 *shipment.*

12     2. *Subsection 1 does not apply to any common or contract*  
13 *carrier who is transporting cigarettes in compliance with the*  
14 *provisions of NRS 370.295.*

15     **Sec. 18. 1.** *The Department may adopt regulations*  
16 *establishing:*

17     (a) *Reporting requirements for manufacturers and wholesale*  
18 *dealers; and*

19     (b) *Procedures for the electronic submission of reports*  
20 *required pursuant to any reporting requirements established*  
21 *under paragraph (a).*

22     2. *Any regulations adopted pursuant to subsection 1 relating*  
23 *to reporting requirements for manufacturers must provide for*  
24 *submission to the Department of periodic reports of:*

25     (a) *The quantity of cigarette packages that were distributed or*  
26 *shipped to another manufacturer or to a wholesale dealer within*  
27 *the borders of this State during the reporting period, and the name*  
28 *and address of each person to whom those products were*  
29 *distributed or shipped;*

30     (b) *The quantity of cigarette packages that were distributed or*  
31 *shipped to another facility of the same manufacturer within the*  
32 *borders of this State during the reporting period; and*

33     (c) *The quantity of cigarette packages that were distributed or*  
34 *shipped within the borders of this State to Indian tribes or*  
35 *instrumentalities of the Federal Government during the reporting*  
36 *period, and the name and address of each person to whom those*  
37 *products were distributed or shipped.*

38     3. *Any regulations adopted pursuant to subsection 1 relating*  
39 *to reporting requirements for wholesale dealers must provide for*  
40 *submission to the Department of periodic reports of:*

41     (a) *The inventory of stamped and unstamped cigarette*  
42 *packages held by the wholesale dealer for sale or distribution*  
43 *within the borders of this State on hand at the beginning of the*  
44 *reporting period;*



1       (b) *The inventory of cigarette packages held by the wholesale*  
2 *dealer for sale or distribution outside of the borders of this State*  
3 *on hand at the beginning of the reporting period;*

4       (c) *The quantity of stamped cigarette packages held for sale or*  
5 *distribution within the borders of this State that were received by*  
6 *the wholesale dealer from another person during the reporting*  
7 *period, and the name and address of each person from whom*  
8 *those products were received;*

9       (d) *The quantity of cigarette packages held for sale or*  
10 *distribution outside of the borders of this State that were received*  
11 *by the wholesale dealer from another person during the reporting*  
12 *period, and the name and address of each person from whom*  
13 *those products were received;*

14       (e) *The quantity of cigarette packages to which Nevada stamps*  
15 *were affixed that were distributed or shipped to another wholesale*  
16 *dealer or to a retail dealer within the borders of this State during*  
17 *the reporting period, and the name and address of each person to*  
18 *whom those products were distributed or shipped;*

19       (f) *The quantity of cigarette packages to which Nevada stamps*  
20 *were affixed that were distributed or shipped to another facility of*  
21 *the same wholesale dealer within the borders of this State during*  
22 *the reporting period;*

23       (g) *The quantity of stamped cigarette packages that were*  
24 *distributed or shipped within the borders of this State to Indian*  
25 *tribes or instrumentalities of the Federal Government during the*  
26 *reporting period, and the name and address of each person to*  
27 *whom those products were distributed or shipped;*

28       (h) *The quantity of cigarette packages held for distribution*  
29 *outside of the borders of this State that were distributed or shipped*  
30 *outside of the borders of this State during the reporting period;*

31       (i) *The inventory of stamped and unstamped cigarette*  
32 *packages held for sale or distribution within the borders of this*  
33 *State on hand at the end of the reporting period;*

34       (j) *The inventory of cigarette packages held for sale or*  
35 *distribution outside of the borders of this State on hand at the end*  
36 *of the reporting period;*

37       (k) *The number of each type of stamp on hand at the*  
38 *beginning of the reporting period;*

39       (l) *The number of each type of stamp purchased or received*  
40 *during the reporting period;*

41       (m) *The number of each type of stamp applied during the*  
42 *reporting period; and*

43       (n) *The number of each type of stamp on hand at the end of*  
44 *the reporting period.*



1     4. Any reports required by regulations adopted pursuant to  
2 subsection 1 must be:

- 3     (a) Submitted on forms provided by the Department; and  
4     (b) Provided separately for each of the facilities operated by  
5 the manufacturer or wholesale dealer.

6     5. In each report required by regulations adopted pursuant to  
7 subsection 1, the information required must be itemized so as to  
8 disclose clearly:

9     (a) The quantities of stamped and unstamped cigarettes to  
10 which the report applies; and

11     (b) The brand and style of cigarettes to which the report  
12 applies.

13     6. The reporting period for any reports required by  
14 regulations adopted pursuant to subsection 1 must be for a  
15 duration of not less than 1 month and not more than 3 months.

16     Sec. 19. 1. A person shall not accept an order for a delivery  
17 sale unless the person first obtains a license as a retail dealer.

18     2. A person who accepts an order for a delivery sale shall  
19 comply with all of the requirements of this chapter and chapters  
20 370A, 372 and 374 of NRS, and all other laws of this State  
21 generally applicable to sales of cigarettes that occur entirely  
22 within this State.

23     Sec. 20. 1. A person shall not cause the mailing or  
24 shipment of cigarettes in connection with an order for a delivery  
25 sale unless the person accepting the order first:

26     (a) Obtains from the prospective purchaser a certification  
27 which includes:

28         (1) Reliable confirmation that the purchaser is at least 18  
29 years of age; and

30         (2) A statement signed by the prospective purchaser in  
31 writing and under penalty of perjury which:

32             (I) Certifies the prospective purchaser's address and  
33 date of birth;

34             (II) Confirms that the prospective purchaser  
35 understands that signing another person's name to such  
36 certification is illegal and that sales of cigarettes to children under  
37 18 years of age are illegal under the laws of this State; and

38             (III) Confirms that the prospective purchaser desires to  
39 receive mailings from a tobacco company.

40     (b) Makes a good faith effort to verify the information  
41 contained in the certification provided by the prospective  
42 purchaser pursuant to paragraph (a) against any federal or  
43 commercially available database established for that purpose.

44     (c) Sends to the prospective purchaser, by electronic mail or  
45 other means, a notice which meets the requirements of subsection



1 *2 and requests confirmation that the order for the delivery sale*  
2 *was placed by the prospective purchaser.*

3 *(d) Receives from the prospective purchaser confirmation,*  
4 *pursuant to the request described in paragraph (c), that such*  
5 *person placed the order for the delivery sale.*

6 *(e) Receives payment for the delivery sale from the prospective*  
7 *purchaser by a credit or debit card that has been issued in that*  
8 *purchaser's name.*

9 *2. The notice required by paragraph (c) of subsection 1 must*  
10 *include:*

11 *(a) A prominent and clearly legible statement that the sale of*  
12 *cigarettes to children under 18 years of age is illegal;*

13 *(b) A prominent and clearly legible statement that the sale of*  
14 *cigarettes is restricted to persons who provide verifiable proof of*  
15 *age in accordance with this section; and*

16 *(c) A prominent and clearly legible statement that sales of*  
17 *cigarettes are taxable under this chapter, and an explanation of*  
18 *how the tax has been or is to be paid with respect to the delivery*  
19 *sale.*

20 *3. Persons accepting orders for delivery sales may request*  
21 *that prospective purchasers provide their electronic mail*  
22 *addresses.*

23 **Sec. 21.** *1. A person who causes the mailing or shipment of*  
24 *cigarettes in connection with an order for a delivery sale shall:*

25 *(a) Use a method of mailing or shipping that obligates the*  
26 *delivery service to carry out the provisions of section 23 of this act;*

27 *(b) Provide to the delivery service retained to deliver the*  
28 *delivery sale evidence that all taxes levied by this State with respect*  
29 *to the delivery sale have been paid to this State; and*

30 *(c) Include as part of the shipping documents:*

31 *(1) A copy of the retail dealer's license authorizing the*  
32 *delivery sale; and*

33 *(2) A clear and conspicuous statement providing as follows:*

34  
35 ***“DELIVERY SALE OF CIGARETTES: NEVADA LAW***  
36 ***PROHIBITS SHIPPING TO CHILDREN UNDER 18***  
37 ***YEARS OF AGE AND REQUIRES THE PAYMENT OF***  
38 ***ALL APPLICABLE TAXES.”***

39  
40 *2. A person who accepts an order for a delivery sale and*  
41 *delivers the cigarettes without using a third-party delivery service*  
42 *shall comply with all the requirements of section 23 of this act*  
43 *applicable to a delivery service.*

44 **Sec. 22.** *Not later than the 10th day of each calendar month,*  
45 *each person who has mailed, shipped or otherwise delivered*





1 *cigarettes in connection with a delivery sale during the previous*  
2 *calendar month, except a delivery service, shall create and*  
3 *maintain records containing the following information relating to*  
4 *every such delivery sale:*

5 *1. The name and address of the person to whom the delivery*  
6 *sale was made; and*

7 *2. The quantity and brands of cigarettes that were sold in the*  
8 *delivery sale.*

9 *↳ The records required by this section must be provided to the*  
10 *Department at the Department's request and must be retained for*  
11 *not less than 3 years after the date of the applicable transaction*  
12 *unless the Department, in writing, authorizes the records to be*  
13 *removed or destroyed at an earlier time.*

14 **Sec. 23.** *1. Except as otherwise provided in subsection 2, a*  
15 *delivery service shall:*

16 *(a) Before delivering a shipping container in connection with*  
17 *a delivery sale:*

18 *(1) Ensure that the shipping documents include the*  
19 *documents required by paragraph (c) of subsection 1 of section 21*  
20 *of this act; and*

21 *(2) Obtain the evidence required by paragraph (b) of*  
22 *subsection 1 of section 21 of this act regarding the cigarettes in the*  
23 *shipping container.*

24 *(b) When delivering a shipping container in connection with a*  
25 *delivery sale, require:*

26 *(1) The purchaser placing the order for the delivery sale, or*  
27 *an adult designated by that purchaser, to sign to accept delivery of*  
28 *the shipping container; and*

29 *(2) Proof, in the form of valid identification that was issued*  
30 *by a governmental entity and bears a photograph of the person*  
31 *who signs to accept delivery of the shipping container,*  
32 *demonstrating:*

33 *(I) That the person is either the addressee or the adult*  
34 *designated by the addressee; and*

35 *(II) If the person appears to be under 27 years of age,*  
36 *that the person is at least 18 years of age.*

37 *2. A delivery service is required to comply with the provisions*  
38 *of subsection 1 only if the delivery service:*

39 *(a) Is obligated to do so under a method of shipping;*

40 *(b) Delivers any container pursuant to shipping documents*  
41 *containing the statement described in paragraph (c) of subsection*  
42 *1 of section 21 of this act; or*

43 *(c) Delivers any container that the delivery service otherwise*  
44 *has reason to know contains cigarettes sold pursuant to a delivery*  
45 *sale.*





**Sec. 24.** *In addition to any other penalty authorized by law:*

**1. The Department may:**

**(a) Impose a civil penalty of \$1,000 on any person who knowingly:**

**(I) Omits, neglects or refuses to:**

**(I) Comply with any duty imposed upon him pursuant to the provisions of NRS 370.080 to 370.315, inclusive, and sections 15 to 18, inclusive, of this act; or**

**(II) Do or cause to be done any of the things required pursuant to those provisions; or**

**(2) Does anything prohibited by the provisions of NRS 370.080 to 370.315, inclusive, and sections 15 to 18, inclusive, of this act.**

**(b) Impose on each person who violates any of the provisions of sections 19 to 23, inclusive, of this act, a civil penalty of:**

**(1) Not more than \$1,000 for the first violation; and**

**(2) Not less than \$1,000 nor more than \$5,000 for each subsequent violation.**

**2. Any person who fails to pay any tax imposed pursuant to the provisions of NRS 370.080 to 370.315, inclusive, and sections 15 to 23, inclusive, of this act within the time prescribed by law or regulation shall pay a penalty of 500 percent of the tax due but unpaid, in addition to the tax.**

**Sec. 25. All fixtures, equipment and other materials and personal property on the premises of any wholesale or retail dealer who, with intent to defraud the State:**

**1. Fails to keep or make any record, return, report or inventory required pursuant to NRS 370.080 to 370.315, inclusive, and sections 15 to 23, inclusive, of this act;**

**2. Keeps or makes any false or fraudulent record, return, report or inventory required pursuant to NRS 370.080 to 370.315, inclusive, and sections 15 to 23, inclusive, of this act;**

**3. Refuses to pay any tax imposed pursuant to NRS 370.080 to 370.315, inclusive, and sections 15 to 23, inclusive, of this act; or**

**4. Attempts in any manner to evade or defeat the requirements of NRS 370.080 to 370.315, inclusive, and sections 15 to 23, inclusive, of this act,**

**↪ is subject to forfeiture pursuant to NRS 179.1156 to 179.119, inclusive.**

**Sec. 26. 1. It is unlawful for a person, with the intent to defraud the State:**

**(a) To fail to keep or make any record, return, report or inventory, or keep or make any false or fraudulent record, return, report or inventory, required pursuant to NRS 370.080 to 370.315,**



1 *inclusive, and sections 15 to 23, inclusive, of this act, or any*  
2 *regulations adopted for the administration or enforcement of those*  
3 *provisions;*

4 *(b) To refuse to pay any tax imposed pursuant to NRS 370.080*  
5 *to 370.315, inclusive, and sections 15 to 23, inclusive, of this act,*  
6 *or attempt in any manner to evade or defeat the tax or the payment*  
7 *thereof;*

8 *(c) To alter, forge or otherwise counterfeit any stamp;*

9 *(d) To sell or possess for the purpose of sale any counterfeit*  
10 *stamp;*

11 *(e) To have in his possession any counterfeit stamp, with the*  
12 *intent to use the counterfeit stamp, knowing or having reasonable*  
13 *grounds to believe the stamp to be a counterfeit stamp;*

14 *(f) To have in his possession any stamp which he knows has*  
15 *been removed from any cigarette package to which it was affixed;*

16 *(g) To affix to any cigarette package a stamp which he knows*  
17 *has been removed from any other cigarette package; or*

18 *(h) To fail to comply with any requirement of NRS 370.080 to*  
19 *370.315, inclusive, and sections 15 to 23, inclusive, of this act.*

20 *2. A person who violates any of the provisions of subsection 1*  
21 *is guilty of a category C felony and shall be punished as provided*  
22 *in NRS 193.130.*

23 **Sec. 27.** *1. It is unlawful for any person knowingly to sell*  
24 *or to possess for the purpose of sale any counterfeit cigarettes. The*  
25 *presence of counterfeit cigarettes in a cigarette vending machine*  
26 *is prima facie evidence of the purpose to sell those cigarettes.*

27 *2. A person who violates any provision of subsection 1 is*  
28 *guilty of:*

29 *(a) For the first offense involving less than 400 cigarettes, a*  
30 *misdemeanor.*

31 *(b) For each subsequent offense involving less than 400*  
32 *cigarettes, a category D felony and shall be punished as provided*  
33 *in NRS 193.130.*

34 *(c) For the first offense involving 400 or more cigarettes, a*  
35 *gross misdemeanor.*

36 *(d) For each subsequent offense involving 400 or more*  
37 *cigarettes, a category C felony and shall be punished as provided*  
38 *in NRS 193.130.*

39 **Sec. 28.** *A person who:*

40 *1. Knowingly violates any of the provisions of sections 19 to*  
41 *23, inclusive, of this act; or*

42 *2. Knowingly and falsely submits a certification pursuant to*  
43 *paragraph (a) of subsection 1 of section 20 of this act in the name*  
44 *of another person,*



1   ↪ *is guilty of a category C felony and shall be punished as*  
2   *provided in NRS 193.130.*

3   **Sec. 29.** NRS 370.001 is hereby amended to read as follows:

4   370.001 As used in NRS 370.001 to 370.430, inclusive, *and*  
5   *sections 2 to 28, inclusive, of this act*, unless the context otherwise  
6   requires, the words and terms defined in NRS 370.005 to 370.055,  
7   inclusive, *and sections 2 to 14, inclusive, of this act* have the  
8   meanings ascribed to them in those sections.

9   **Sec. 30.** NRS 370.015 is hereby amended to read as follows:

10   370.015 “Cigarette vending machine operator” means any  
11   ~~[person]~~ *retail dealer* licensed to sell only Nevada stamped  
12   cigarettes by means of coin-operated machines anywhere in Nevada.

13   **Sec. 31.** NRS 370.025 is hereby amended to read as follows:

14   370.025 “Contraband cigarettes” means any ~~[cigarettes~~  
15   ~~exported]~~ :

16   1. *Counterfeit cigarettes; or*

17   2. *Cigarettes:*

18   (a) *Exported* from or imported into this State , *or mailed,*  
19   *shipped, delivered, sold, exchanged, transported, distributed or*  
20   *held for distribution within the borders of this State* by any person  
21   in violation of any of the provisions of this chapter ; or ~~[which are,~~  
22   ~~in any way,]~~

23   (b) *In any way* held in the possession or constructive possession  
24   of any person not authorized under this chapter to possess or  
25   constructively possess ~~[these]~~ *the* cigarettes.

26   **Sec. 32.** NRS 370.033 is hereby amended to read as follows:

27   370.033 “Retail dealer” means any person , *whether located*  
28   *within or outside of the borders of this State*, who ~~[offers to sell~~  
29   ~~cigarettes at retail or who is engaged in selling cigarettes at retail.]~~  
30   *sells or distributes cigarettes to a consumer within the State.*
