

ASSEMBLY BILL No. 504—COMMITTEE ON TRANSPORTATION

MARCH 28, 2005

SUMMARY—Exempts owner or operator of motor vehicle that is used for transportation of passengers or property from provisions governing fully regulated carriers under certain circumstances. (BDR 58-1236)

AN ACT relating to motor carriers; exempting an owner or operator of a motor vehicle that is used for the transportation of passengers or property from the provisions governing fully regulated carriers under certain circumstances; requiring the Transportation Services Authority to issue a decal, sticker or other form of identification to the owner or operator of the motor vehicle under certain circumstances; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 706 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 ***1. An owner or operator of a motor vehicle that is used for
4 the transportation of passengers or property is not subject to the
5 provisions of this chapter governing fully regulated carriers if:***

6 ***(a) The owner or operator of the motor vehicle:***

7 ***(1) Holds a nonrestricted license and is a resort hotel;***

8 ***(2) Is not in the business of transporting passengers or
9 property;***

10 ***(3) Does not charge a fee for transporting passengers or
11 property; and***

1 (4) *Obtains and places on the motor vehicle a decal, sticker
2 or other form of identification in accordance with subsection 2;
3 and*

4 (b) *The use of the motor vehicle is related to the business for
5 which the nonrestricted license was issued.*

6 2. *An owner or operator of a motor vehicle specified in
7 subsection 1 must apply to the Authority for a decal, sticker or
8 other form of identification for placement on the motor vehicle in
9 the manner specified by the Authority. The Authority shall issue a
10 decal, sticker or other form of identification to the owner or
11 operator of the motor vehicle if the Authority determines that the
12 motor vehicle will be operated in accordance with subsection 1.
13 The decal, sticker or other form of identification is valid for 1 year
14 after the date of issuance. The Authority may impose a fee of not
15 more than \$50 for the issuance of a decal, sticker or other form of
16 identification pursuant to this subsection.*

17 3. *As used in this section:*

18 (a) *"Nonrestricted license" has the meaning ascribed to it in
19 NRS 463.0177; and*

20 (b) *"Resort hotel" has the meaning ascribed to it in
21 NRS 463.01865.*

22 Sec. 2. NRS 706.011 is hereby amended to read as follows:

23 706.011 As used in NRS 706.011 to 706.791, inclusive, **and**
24 **section 1 of this act**, unless the context otherwise requires, the
25 words and terms defined in NRS 706.013 to 706.146, inclusive,
26 have the meanings ascribed to them in those sections.
