AN ACT relating to homeless persons; making an appropriation to Clark County for various services to assist homeless persons; making an appropriation to the Interim Finance Committee to provide the matching state money for the Shelter Plus Care federal program; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** There is hereby appropriated from the State  
2 General Fund to Clark County for use by the Southern Nevada  
3 Regional Planning Coalition the sum of \$4,221,787 for the  
4 following projects and services:

5              Construction costs for a community assistance  
6              center.....\$50,000  
7              To fund a mobile crisis intervention team.....\$1,377,394  
8              To fund an intensive case management team.....\$1,219,393  
9              Purchase of a mobile locker room shower and  
10             trailer .....\$125,000  
11             Installation of a shower and restroom facilities at  
12             the Las Vegas Rescue Mission .....\$350,000

1           Storage facilities for personal belongings of  
2           homeless persons ..... \$100,000  
3           Housing for homeless families..... \$1,000,000

4       **Sec. 2.** 1. There is hereby appropriated from the State  
5       General Fund to the Interim Finance Committee the sum of  
6       \$360,823 to provide matching money for the Shelter Plus Care  
7       program in Washoe County and the remaining counties of the State,  
8       other than Clark County. Of the total amount appropriated, the  
9       Interim Finance Committee may approve allocation of not more  
10      than the following amounts for each region:

11       For Washoe County..... \$261,109  
12       For the remaining counties, other than Clark  
13       County..... \$99,714

14       2. An agency representing Washoe County or the remaining  
15      counties of the State, other than Clark County, may submit a request  
16      to the Interim Finance Committee for the allocation of all or part of  
17      the money appropriated and authorized for allocation pursuant to  
18      subsection 1. The request must include supporting documentation  
19      indicating that the requesting agency is authorized to administer the  
20      funding of the Shelter Plus Care program for the region, and any  
21      additional information required by the Interim Finance Committee.

22       3. Upon receipt of a request submitted pursuant to subsection  
23      2, the Interim Finance Committee shall determine whether to  
24      allocate all or any portion of the money appropriated and authorized  
25      for allocation pursuant to subsection 1. The Interim Finance  
26      Committee is not required to approve the entire amount requested or  
27      the entire amount appropriated or authorized for allocation.

28       **Sec. 3.** Any remaining balance of the appropriations made by  
29      sections 1 and 2 of this act must not be committed for expenditure  
30      after June 30, 2007, and must be reverted to the State General Fund  
31      on or before September 21, 2007.

32       **Sec. 4.** This act becomes effective on July 1, 2005.
