AN ACT relating to technology; extending the date for the reversion of a portion of the appropriation made by the 2003 Legislature to the Department of Administration for the digital microwave project; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Section 30 of chapter 327, Statutes of Nevada 2003,
2 at page 1836, is hereby amended to read as follows:
3 Sec. 30. **1.** The following sums are hereby
4 appropriated from the State Highway Fund for the purposes
5 expressed in this section for the fiscal years beginning July 1,
6 2003, and ending June 30, 2004, and beginning July 1, 2004,
7 and ending June 30, 2005:

20 **2. Any remaining balance of that portion of the appropriation**
21 **made by subsection 1 to the Department of Administration for**
22 **information technology projects which is designated for the digital**
23 **microwave project must not be committed for expenditure after**
24 **June 30, 2007, and must be reverted to the State Highway Fund**
25 **on or before September 21, 2007.**

26 **Sec. 2.** Section 48 of chapter 327, Statutes of Nevada 2003, at
27 page 1840, is hereby amended to read as follows:

28 Sec. 48. 1. Except as otherwise provided in sections
29 **30**, 44 and 60 of this act, unencumbered balances of the
30 appropriations made in this act for the Fiscal Years 2003-
31 2004 and 2004-2005 must not be committed for expenditure
32 after June 30 of each fiscal year. Except as otherwise
33 provided in subsection 2, unencumbered balances of these
34 appropriations revert to the fund from which appropriated.

35 2. Any encumbered balance of the appropriations made
36 to the Legislative Fund by section 10 of this act does not
37 revert to the State General Fund but constitutes a balance
38 carried forward.

39 **Sec. 3.** This act becomes effective upon passage and approval.
