AN ACT making appropriations for support of mental health services in Clark County; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Pursuant to the recommendations of the Legislative
2 Committee on Health Care, created by NRS 439B.200, the
3 following appropriations are made for the support of mental health
4 services in Clark County:

5 1. There is hereby appropriated from the State General Fund to
6 the Southern Nevada Adult Mental Health Services for support of
7 the continued operation of the mobile crisis teams in southern
8 Nevada:

9 For the Fiscal Year 2005-2006..... \$444,846
10 For the Fiscal Year 2006-2007..... \$452,623

11 2. There is hereby appropriated from the State General Fund to
12 the Southern Nevada Adult Mental Health Services for the operation
13 and staffing of the 28-bed inpatient annex in Building 1300 on the
14 Desert Regional Center Campus:

15 For the Fiscal Year 2005-2006..... \$618,652
16 For the Fiscal Year 2006-2007..... \$3,643,844

1 3. There is hereby appropriated from the State General Fund to
2 the Division of Mental Health and Developmental Services of the
3 Department of Human Resources for the recruitment of psychiatrists
4 for the Division:

5 For the Fiscal Year 2005-2006..... \$500,000
6 For the Fiscal Year 2006-2007..... \$500,000

7 4. There is hereby appropriated from the State General Fund to
8 the Division of Mental Health and Developmental Services of the
9 Department of Human Resources for psychiatry trainees at the
10 residency and fellowship training programs at the School of
11 Medicine of the University of Nevada:

12 For the Fiscal Year 2005-2006..... \$443,969
13 For the Fiscal Year 2006-2007..... \$1,043,969

14 5. There is hereby appropriated from the State General Fund to
15 the Division of Mental Health and Developmental Services of the
16 Department of Human Resources for medical screening at the
17 mental health hospital in Clark County:

18 For the Fiscal Year 2005-2006..... \$1,361,549
19 For the Fiscal Year 2006-2007..... \$6,609,885

20 **Sec. 2.** 1. Any balance of the sums appropriated by
21 subsections 1, 2 and 4 of section 1 of this act remaining at the end of
22 the respective fiscal years must not be committed for expenditure
23 after June 30 of the respective fiscal years and must be reverted to
24 the State General Fund on or before September 15, 2006, and
25 September 21, 2007, respectively.

26 2. The sums appropriated by subsections 3 and 5 of section 1
27 of this act are available for either fiscal year. Any balance of those
28 sums must not be committed for expenditure after June 30, 2007,
29 and must be reverted to the State General Fund on or before
30 September 21, 2007.

31 **Sec. 3.** This act becomes effective on July 1, 2005.
