

ASSEMBLY BILL NO. 550—COMMITTEE ON JUDICIARY

MARCH 29, 2005

Referred to Committee on Judiciary

SUMMARY—Makes various changes concerning offenses involving use of intoxicating liquor and controlled substances. (BDR 43-832)

FISCAL NOTE: Effect on Local Government: Increases or Newly Provides for Term of Imprisonment in County or City Jail or Detention Facility.
Effect on the State: Yes.

AN ACT relating to crimes; revising the provisions governing when one offense involving the use of intoxicating liquor and controlled substances occurs within 7 years of another offense; making admissible in certain criminal proceedings the results of blood tests administered by phlebotomists or persons with special knowledge, skill, training and education in withdrawing blood in a medically acceptable manner; making mandatory the use of ignition interlock devices by persons convicted of certain offenses; limiting the admissibility of certain affidavits or declarations in certain criminal proceedings; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** NRS 484.3792 is hereby amended to read as
2 follows:
3 484.3792 1. Unless a greater penalty is provided pursuant to
4 NRS 484.3795, a person who violates the provisions of
5 NRS 484.379:



1 (a) For the first offense within 7 years, is guilty of a
2 misdemeanor. Unless he is allowed to undergo treatment as
3 provided in NRS 484.37937, the court shall:

4 (1) Except as otherwise provided in subparagraph (4) or
5 subsection 6, order him to pay tuition for an educational course on
6 the abuse of alcohol and controlled substances approved by the
7 Department and complete the course within the time specified in the
8 order, and the court shall notify the Department if he fails to
9 complete the course within the specified time;

10 (2) Unless the sentence is reduced pursuant to NRS
11 484.37937, sentence him to imprisonment for not less than 2 days
12 nor more than 6 months in jail, or to perform not less than 48 hours,
13 but not more than 96 hours, of community service while dressed in
14 distinctive garb that identifies him as having violated the provisions
15 of NRS 484.379;

16 (3) Fine him not less than \$400 nor more than \$1,000; and

17 (4) If he is found to have a concentration of alcohol of 0.18
18 or more in his blood or breath, order him to attend a program of
19 treatment for the abuse of alcohol or drugs pursuant to the
20 provisions of NRS 484.37945.

21 (b) For a second offense within 7 years, is guilty of a
22 misdemeanor. Unless the sentence is reduced pursuant to NRS
23 484.3794, the court shall:

24 (1) Sentence him to:

25 (I) Imprisonment for not less than 10 days nor more than
26 6 months in jail; or

27 (II) Residential confinement for not less than 10 days nor
28 more than 6 months, in the manner provided in NRS 4.376 to
29 4.3766, inclusive, or 5.0755 to 5.078, inclusive;

30 (2) Fine him not less than \$750 nor more than \$1,000, or
31 order him to perform an equivalent number of hours of community
32 service while dressed in distinctive garb that identifies him as
33 having violated the provisions of NRS 484.379; and

34 (3) Order him to attend a program of treatment for the abuse
35 of alcohol or drugs pursuant to the provisions of NRS 484.37945.

36 ➤ A person who willfully fails or refuses to complete successfully a
37 term of residential confinement or a program of treatment ordered
38 pursuant to this subsection is guilty of a misdemeanor.

39 (c) For a third or subsequent offense within 7 years, is guilty of
40 a category B felony and shall be punished by imprisonment in the
41 state prison for a minimum term of not less than 1 year and a
42 maximum term of not more than 6 years, and shall be further
43 punished by a fine of not less than \$2,000 nor more than \$5,000. An
44 offender so imprisoned must, insofar as practicable, be segregated
45 from offenders whose crimes were violent and, insofar as



1 practicable, be assigned to an institution or facility of minimum
2 security.

3 2. An offense that occurred within 7 years immediately
4 preceding the date of the principal offense or after the principal
5 offense constitutes a prior offense for the purposes of this section
6 when evidenced by a conviction, without regard to the sequence of
7 the offenses and convictions. The facts concerning a prior offense
8 must be alleged in the complaint, indictment or information, must
9 not be read to the jury or proved at trial but must be proved at the
10 time of sentencing and, if the principal offense is alleged to be a
11 felony, must also be shown at the preliminary examination or
12 presented to the grand jury.

13 3. A person convicted of violating the provisions of NRS
14 484.379 must not be released on probation, and a sentence imposed
15 for violating those provisions must not be suspended except, as
16 provided in NRS 4.373, 5.055, 484.37937 and 484.3794, that
17 portion of the sentence imposed that exceeds the mandatory
18 minimum. A prosecuting attorney shall not dismiss a charge of
19 violating the provisions of NRS 484.379 in exchange for a plea of
20 guilty or nolo contendere to a lesser charge or for any other reason
21 unless he knows or it is obvious that the charge is not supported by
22 probable cause or cannot be proved at the time of trial.

23 4. A term of confinement imposed pursuant to the provisions
24 of this section may be served intermittently at the discretion of the
25 judge or justice of the peace, except that a person who is convicted
26 of a second or subsequent offense within 7 years must be confined
27 for at least one segment of not less than 48 consecutive hours. This
28 discretion must be exercised after considering all the circumstances
29 surrounding the offense, and the family and employment of the
30 offender, but any sentence of 30 days or less must be served within
31 6 months after the date of conviction or, if the offender was
32 sentenced pursuant to NRS 484.37937 or 484.3794 and the
33 suspension of his sentence was revoked, within 6 months after the
34 date of revocation. Any time for which the offender is confined
35 must consist of not less than 24 consecutive hours.

36 5. Jail sentences simultaneously imposed pursuant to this
37 section and NRS 482.456, 483.560 or 485.330 must run
38 consecutively.

39 6. If the person who violated the provisions of NRS 484.379
40 possesses a driver's license issued by a state other than the State of
41 Nevada and does not reside in the State of Nevada, in carrying out
42 the provisions of subparagraph (1) of paragraph (a) of subsection 1,
43 the court shall:

44 (a) Order the person to pay tuition for and submit evidence of
45 completion of an educational course on the abuse of alcohol and



1 controlled substances approved by a governmental agency of the
2 state of his residence within the time specified in the order; or

3 (b) Order him to complete an educational course by
4 correspondence on the abuse of alcohol and controlled substances
5 approved by the Department within the time specified in the order,
6 and the court shall notify the Department if the person fails to
7 complete the assigned course within the specified time.

8 7. If the defendant was transporting a person who is less than
9 15 years of age in the motor vehicle at the time of the violation, the
10 court shall consider that fact as an aggravating factor in determining
11 the sentence of the defendant.

12 8. *For the purpose of determining whether one offense*
13 *occurs within 7 years of another offense, any period of time*
14 *between the two offenses during which, for any such offense, the*
15 *offender is imprisoned, serving a term of residential confinement,*
16 *confined in a treatment facility, on parole or on probation must be*
17 *excluded.*

18 9. As used in this section, unless the context otherwise
19 requires:

20 (a) "Concentration of alcohol of 0.18 or more in his blood or
21 breath" means 0.18 gram or more of alcohol per 100 milliliters of
22 the blood of a person or per 210 liters of his breath.

23 (b) "Offense" means:

24 (1) A violation of NRS 484.379 or 484.3795;

25 (2) A homicide resulting from driving or being in actual
26 physical control of a vehicle while under the influence of
27 intoxicating liquor or a controlled substance or resulting from any
28 other conduct prohibited by NRS 484.379 or 484.3795; or

29 (3) A violation of a law of any other jurisdiction that
30 prohibits the same or similar conduct as set forth in subparagraph
31 (1) or (2).

32 (c) *"Treatment facility" has the meaning ascribed to it in*
33 *NRS 484.3793.*

34 **Sec. 2.** NRS 484.393 is hereby amended to read as follows:

35 484.393 1. The results of any blood test administered under
36 the provisions of NRS 484.383 or 484.391 are not admissible in any
37 hearing or criminal action arising out of acts alleged to have been
38 committed by a person who was driving or in actual physical control
39 of a vehicle while under the influence of intoxicating liquor or a
40 controlled substance or who was engaging in any other conduct
41 prohibited by NRS 484.379 or 484.3795 unless:

42 (a) The blood tested was withdrawn by a *person, other than an*
43 *arresting officer, who:*

44 (1) *Is a* physician, physician assistant, registered nurse,
45 licensed practical nurse, emergency medical technician or a



1 *phlebotomist*, technician, technologist or assistant employed in a
2 medical laboratory; *or*

3 *(2) Has special knowledge, skill, experience, training and*
4 *education in withdrawing blood in a medically acceptable manner,*
5 *including, without limitation, a person qualified as an expert on*

18 civil or criminal liability as a result of the administering of a blood
19 test when requested by a police officer or the person to be tested to

(a) Requiring the person to install a device in a motor vehicle which the person owns or operates would cause the person to experience an economic hardship; and

(b) The person requires the use of the motor vehicle to:

(1) Travel to and from work or in the course and scope of his employment;

(2) Obtain medicine, food or other necessities or to obtain health care services for himself or another member of his immediate family; or

(a) The court shall immediately prepare and transmit a copy of its order to the Director. The order must include a statement that a device is required and the specific period for which it is required. The Director shall cause this information to be incorporated into the records of the Department and noted as a restriction on the person's driver's license.

(b) The person who is required to install the device shall provide proof of compliance to the Department before he may receive a restricted license or before his driving privilege may be reinstated, as applicable. Each model of a device installed pursuant to this section must have been certified by the Committee on Testing for Intoxication.

4. A person whose driving privilege is restricted pursuant to this section shall:

(a) If he was ordered to install a device pursuant to paragraph (a) of subsection 1, have the device inspected by the manufacturer of the device or its agent at least one time during the period in which he is required to use the device; or

(b) If he was ordered to install a device pursuant to paragraph (b) of subsection 1, have the device inspected by the manufacturer of the device or its agent at least one time each 90 days,

➔ to determine whether the device is operating properly. An inspection required pursuant to this subsection must be conducted in accordance with regulations adopted pursuant to NRS 484.3888. The manufacturer or its agent shall submit a report to the Director indicating whether the device is operating properly and whether it



1 has been tampered with. If the device has been tampered with, the
2 Director shall notify the court that ordered the installation of the
3 device.

4 5. If a person is required to operate a motor vehicle in the
5 course and scope of his employment and the motor vehicle is owned
6 by his employer, the person may operate that vehicle without the
7 installation of a device, if:

8 (a) The employee notifies his employer that the employee's
9 driving privilege has been so restricted; and

10 (b) The employee has proof of that notification in his possession
11 or the notice, or a facsimile copy thereof, is with the motor vehicle.

The affidavit or declaration of a chemist and any other person who has qualified in the district court of any county to testify as an expert witness regarding the presence in the breath, blood or urine of a person of alcohol, a controlled substance, or a chemical, poison, organic solvent or another prohibited substance, or the identity or quantity of a controlled substance alleged to have been in the possession of a person, which is submitted to prove:

(a) The quantity of the purported controlled substance; or

(b) The concentration of alcohol or the presence or absence of a controlled substance, chemical, poison, organic solvent or another prohibited substance, as the case may be,

is admissible in the manner provided in this section.

2. An affidavit or declaration which is submitted to prove any fact set forth in subsection 1 must be admitted into evidence when submitted during any administrative proceeding, preliminary hearing or hearing before a grand jury. 3. The provisions of this section do not prohibit either party from producing any witness to offer testimony at ~~trial~~ **a preliminary hearing or hearing before a grand jury.**

4. The provisions of this section apply to any of the following offenses:

(a) An offense punishable pursuant to NRS 202.257, 455A.170, 455B.080, 493.130 or 639.283.

(b) An offense punishable pursuant to chapter 453, 484 or 488 of NRS.

(c) A homicide resulting from driving, operating or being in actual physical control of a vehicle or a vessel under power or sail while under the influence of intoxicating liquor or a controlled substance or resulting from any other conduct prohibited by NRS 484.379, 484.3795, subsection 2 of NRS 488.400, NRS 488.410 or 488.420.

(d) Any other offense for which it is necessary to prove, as an element of the offense:

(1) The existence of any alcohol;
(2) The quantity of a controlled substance; or
(3) The existence or identity of a controlled substance, chemical, poison, organic solvent or another prohibited substance.
