## ASSEMBLY BILL NO. 559—COMMITTEE ON WAYS AND MEANS

APRIL 28, 2005

## Referred to Committee on Ways and Means

SUMMARY—Provides for increases in salaries of certain employees of State of Nevada. (BDR S-1297)

AN ACT relating to state employees; making appropriations from the State General Fund and the State Highway Fund to the State Board of Examiners for increases in the salaries of certain employees of the State of Nevada; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     **Section 1.** 1. To effect increases in salaries of approximately  
2 5 percent, there is hereby appropriated from the State General Fund  
3 to the State Board of Examiners for the fiscal period beginning  
4 July 1, 2005, and ending June 30, 2006, the sum of \$3,119,314 to  
5 meet any deficiencies which may be created between the  
6 appropriated money of the respective departments, commissions and  
7 agencies of the State of Nevada, including the Judicial Branch,  
8 which receive part or all of their funding from the State General  
9 Fund, as fixed by the 73rd Session of the Legislature, and the  
10 requirements for salaries of the unclassified personnel of those  
11 departments, commissions and agencies, except those employees  
12 whose salaries have been retained, to become effective on July 1,  
13 2005.
- 14     2. There is hereby appropriated from the State General Fund to  
15 the State Board of Examiners for the fiscal period beginning July 1,  
16 2006, and ending June 30, 2007, the sum of \$6,312,746 to provide



1 the salary increase provided in subsection 1 and in addition a salary  
2 increase of approximately 5 percent for the unclassified employees  
3 described in subsection 1 to become effective on July 1, 2006.

4 3. To effect increases in salaries of approximately 5 percent,  
5 there is hereby appropriated from the State Highway Fund to the  
6 State Board of Examiners for the fiscal period beginning July 1,  
7 2005, and ending June 30, 2006, the sum of \$179,635 to meet any  
8 deficiencies which may be created between the appropriated money  
9 of the respective agencies of the State of Nevada which receive part  
10 or all of their funding from the State Highway Fund, as fixed by the  
11 73rd Session of the Legislature, and the requirements for salaries of  
12 the unclassified personnel of those agencies, except those employees  
13 whose salaries have been retained, to become effective on July 1,  
14 2005.

15 4. There is hereby appropriated from the State Highway Fund  
16 to the State Board of Examiners for the fiscal period beginning  
17 July 1, 2006, and ending June 30, 2007, the sum of \$362,733 to  
18 provide the salary increase provided in subsection 3 and in addition  
19 a salary increase of approximately 5 percent for the unclassified  
20 employees described in subsection 3 to become effective on July 1,  
21 2006.

22 5. The State Board of Examiners, upon the recommendation of  
23 the Director of the Department of Administration, may allocate and  
24 disburse to various departments, commissions and agencies of the  
25 State of Nevada, out of the money appropriated by this section, such  
26 sums of money as may from time to time be required, which when  
27 added to the money otherwise appropriated or available equals the  
28 amount of money required to pay the salaries of the unclassified  
29 employees of the respective departments, commissions and  
30 agencies.

31 **Sec. 2.** 1. To effect increases in salaries of approximately 5  
32 percent, there is hereby appropriated from the State General Fund to  
33 the State Board of Examiners for the fiscal period beginning July 1,  
34 2005, and ending June 30, 2006, the sum of \$16,445,270 to meet  
35 any deficiencies which may be created between the appropriated  
36 money of the respective departments, commissions and agencies of  
37 the State of Nevada as fixed by the 73rd Session of the Legislature  
38 and the requirements for salaries of the classified personnel of those  
39 departments, commissions and agencies, including the Judicial  
40 Branch of government, necessary under an adjusted pay plan, except  
41 those employees whose salaries have been retained, to become  
42 effective on July 1, 2005.

43 2. There is hereby appropriated from the State General Fund to  
44 the State Board of Examiners for the fiscal period beginning July 1,  
45 2006, and ending June 30, 2007, the sum of \$34,641,124 to provide



1 the salary increase as provided in subsection 1 and in addition a  
2 salary increase of approximately 5 percent for classified employees  
3 described in subsection 1 to become effective July 1, 2006.

4 3. The State Board of Examiners, upon the recommendation of  
5 the Director of the Department of Administration, may allocate and  
6 disburse to various departments, commissions and agencies of the  
7 State of Nevada, out of the money appropriated by this section, such  
8 sums of money as may from time to time be required, which when  
9 added to the money otherwise appropriated or available equals the  
10 amount of money required to pay the salaries of the classified  
11 employees of the respective departments, commissions and agencies  
12 under the adjusted pay plan.

13 **Sec. 3.** 1. To effect increases in salaries of approximately 5  
14 percent, there is hereby appropriated from the State Highway Fund  
15 to the State Board of Examiners for the fiscal period beginning  
16 July 1, 2005, and ending June 30, 2006, the sum of \$7,488,445 to  
17 meet any deficiencies which may exist between the appropriated  
18 money of the Department of Motor Vehicles, the Department of  
19 Public Safety and the Transportation Services Authority as fixed by  
20 the 73rd Session of the Legislature and the requirements for salaries  
21 of classified personnel of the Department of Motor Vehicles, the  
22 Department of Public Safety and the Transportation Services  
23 Authority necessary under an adjusted pay plan, except those  
24 employees whose salaries have been retained, to become effective  
25 July 1, 2005.

26 2. There is hereby appropriated from the State Highway Fund  
27 to the State Board of Examiners for the fiscal period beginning  
28 July 1, 2006, and ending June 30, 2007, the sum of \$15,319,843 to  
29 provide the salary increase as provided in subsection 1 and in  
30 addition a salary increase of approximately 5 percent for classified  
31 employees described in subsection 1 to become effective July 1,  
32 2006.

33 3. The State Board of Examiners, upon the recommendation of  
34 the Director of the Department of Administration, may allocate and  
35 disburse to the Department of Motor Vehicles, the Department of  
36 Public Safety and the Transportation Services Authority, out of the  
37 money appropriated by this section, such sums of money as may  
38 from time to time be required, which when added to the money  
39 otherwise appropriated or available equals the amount of money  
40 required to meet and pay the salaries of the classified employees of  
41 the Department of Motor Vehicles, the Department of Public Safety  
42 and the Transportation Services Authority under the adjusted pay  
43 plan.

44 **Sec. 4.** 1. To effect increases in salaries of approximately 5  
45 percent, there is hereby appropriated from the State General Fund to



1 the State Board of Examiners for the fiscal period beginning July 1,  
2 2005, and ending June 30, 2006, the sum of \$4,406,018 to meet any  
3 deficiencies which may be created between the appropriated money  
4 of the University and Community College System of Nevada as  
5 fixed by the 73rd Session of the Legislature and the requirements for  
6 salaries of the classified personnel of the University and Community  
7 College System of Nevada necessary under the adjusted pay plan,  
8 except those employees whose salaries have been retained, to  
9 become effective July 1, 2005.

10 2. There is hereby appropriated from the State General Fund to  
11 the State Board of Examiners for the fiscal period beginning July 1,  
12 2006, and ending June 30, 2007, the sum of \$9,064,490 to provide a  
13 salary increase as provided in subsection 1 and in addition a salary  
14 increase of approximately 5 percent for classified employees  
15 described in subsection 1 to become effective July 1, 2006.

16 3. To effect increases in salaries of approximately 5 percent,  
17 there is hereby appropriated from the State General Fund to the  
18 State Board of Examiners for the fiscal year beginning July 1, 2005,  
19 and ending June 30, 2006, the sum of \$13,598,352 to meet any  
20 deficiencies which may be created between the appropriated money  
21 of the University and Community College System of Nevada as  
22 fixed by the 73rd Session of the Legislature and the requirements for  
23 salaries of the professional employees of the University and  
24 Community College System of Nevada, except those employees  
25 whose salaries have been retained, to become effective July 1, 2005.

26 4. There is hereby appropriated from the State General Fund to  
27 the State Board of Examiners for the fiscal period beginning July 1,  
28 2006, and ending June 30, 2007, the sum of \$27,487,152 to provide  
29 a salary increase as provided in subsection 3 and in addition a salary  
30 increase of approximately 5 percent for professional employees of  
31 the University and Community College System of Nevada described  
32 in subsection 3 to become effective July 1, 2006.

33 5. The State Board of Examiners, upon the recommendation of  
34 the Director of the Department of Administration, may allocate and  
35 disburse to the University and Community College System of  
36 Nevada, out of the money appropriated by this section, such sums of  
37 money as may from time to time be required, which when added to  
38 the money otherwise appropriated or available equals the amount of  
39 money required to pay the salaries of the classified and professional  
40 employees of the University and Community College System of  
41 Nevada.

42 **Sec. 5.** 1. The money appropriated for Fiscal Years 2005-  
43 2006 and 2006-2007 in sections 1 to 4, inclusive, of this act is  
44 available for both Fiscal Years 2005-2006 and 2006-2007, and may  
45 be transferred from one fiscal year to the other with the approval of



1 the Governor upon the recommendation of the Chief of the Budget  
2 Division of the Department of Administration. Any balance of that  
3 money must not be committed for expenditure after June 30, 2007,  
4 and must be reverted to the fund from which it was appropriated on  
5 or before September 21, 2007.

6 2. Money appropriated in subsections 1 and 2 of section 1 and  
7 sections 2 and 4 of this act may be transferred among those sections  
8 with the approval of the Governor upon the recommendation of the  
9 Chief of the Budget Division of the Department of Administration  
10 to finance the 5 percent salary increase authorized on July 1, 2005,  
11 and the 5 percent salary increase authorized on July 1, 2006.

12 3. Money appropriated in subsections 3 and 4 of section 1 and  
13 section 3 of this act may be transferred among those sections with  
14 the approval of the Governor upon the recommendation of the Chief  
15 of the Budget Division of the Department of Administration to  
16 finance the 5 percent salary increase authorized on July 1, 2005, and  
17 the 5 percent salary increase authorized on July 1, 2006.

18 **Sec. 6.** 1. To effect increases in salaries of approximately 5  
19 percent, there is hereby appropriated from the State General Fund to  
20 the Legislative Fund for the fiscal year beginning July 1, 2005, and  
21 ending June 30, 2006, the sum of \$634,345 to meet any deficiencies  
22 which may be created between the appropriated money as fixed by  
23 the 73rd Session of the Legislature and the requirements for salaries  
24 of the employees of the Legislative Counsel Bureau and of interim  
25 legislative operations, except those employees whose salaries have  
26 been retained, to become effective July 1, 2005.

27 2. There is hereby appropriated from the State General Fund to  
28 the Legislative Fund for the fiscal year beginning July 1, 2006, and  
29 ending June 30, 2007, the sum of \$1,301,690 to provide the salary  
30 increase as provided in subsection 1 and in addition a salary increase  
31 of approximately 5 percent to become effective July 1, 2006.

32 3. The money appropriated for Fiscal Years 2005-2006 and  
33 2006-2007 in this section is available for both Fiscal Years 2005-  
34 2006 and 2006-2007 and may be transferred from one fiscal year to  
35 the other. Any balance of the money appropriated in this section  
36 must be carried forward for use in the next legislative session and  
37 does not revert to the State General Fund.

38 **Sec. 7.** This act becomes effective on July 1, 2005.
