AN ACT relating to state financial administration; extending the reversion date of the appropriation made in the 20th Special Session for distribution to the Fighting Aids in Our Community Today organization for expenses related to the provision of certain HIV/AIDS services; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 2 of Chapter 8, Statutes of Nevada 2003, 20th Special Session, at page 270, is hereby amended to read as follows:

Sec. 2. 1. There is hereby appropriated from the State General Fund to the Health Division of the Department of Human Resources the sum of \$250,000 for distribution to Fighting Aids in Our Community Today (FACT), a Las Vegas organization, for the provision of community outreach, testing, counseling and dissemination of information related to HIV/AIDS in the area of West Las Vegas.

2. Upon acceptance of the money appropriated by subsection 1, the Fighting Aids in Our Community Today organization agrees to:

(a) Use not more than 10 percent of the amount appropriated for administrative expenses.

1 (b) Prepare and transmit a report to the Interim Finance
2 Committee on or before December 15, ~~{2004,}~~ 2006, that
3 describes each expenditure made from the money
4 appropriated by subsection 1 from the date on which the
5 money was received by the Organization through
6 December 1, ~~{2004,}~~ 2006.

7 (c) Upon request of the Legislative Commission, make
8 available to the Legislative Auditor any books, accounts,
9 claims, reports, vouchers, or other records of information,
10 confidential or otherwise and irrespective of their form or
11 location, that the Legislative Auditor deems necessary to
12 conduct any audit of the use of the money appropriated by
13 subsection 1 and distributed to the Fighting Aids in Our
14 Community Today organization.

15 3. Any remaining balance of the appropriation made by
16 subsection 1 must not be committed for expenditure after
17 June 30, ~~{2005, and reverts}~~ 2007, and must be reverted
18 to the State General Fund ~~[as soon as all payments of money~~
19 ~~committed have been made.]~~ on or before September 21,
20 2007.

21 **Sec. 2.** This act becomes effective upon passage and approval.
