SUMMARY—Repeals certain provisions concerning money provided to counties which are unable to pay nonfederal share of expenses for institutional care of medically indigent persons pursuant to State Plan for Medicaid. (BDR 38-175)

AN ACT relating to public welfare; repealing certain provisions concerning money provided to a county which is unable to pay the nonfederal share of its expenses required by an interlocal agreement for the institutional care of medically indigent persons pursuant to the State Plan for Medicaid; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law creates the Fund for the Institutional Care of the Medically
2 Indigent in the State Treasury. The purpose of the Fund is to provide assistance to a
3 county that is unable to make a payment for the nonfederal share of its expenses for
4 the institutional care of medically indigent persons pursuant to the State Plan for
5 Medicaid as required by an interlocal agreement between the county and the
6 Department of Human Resources. (NRS 428.470, 428.490)

7 This bill repeals the provisions relating to the Fund for the Institutional Care of
8 the Medically Indigent including the provisions concerning the transfer of money
9 from the Fund to assist counties.

- 1 **Section 1.** NRS 428.410, 428.420, 428.430, 428.440, 428.450,
2 428.460, 428.470, 428.480 and 428.490 are hereby repealed.
3 **Sec. 2.** The State Controller shall transfer any balance in the
4 Fund for the Institutional Care of the Medically Indigent, created by
5 NRS 428.470, which has not been committed for expenditure on or
6 before October 1, 2005, to the State General Fund.
