
ASSEMBLY BILL NO. 63—ASSEMBLYMEN LESLIE, BUCKLEY,
GIUNCHIGLIANI, PARKS, ANDERSON, MCCLAIN AND OCEGUERA

FEBRUARY 16, 2005

Referred to Committee on Commerce and Labor

SUMMARY—Prohibits certain practices by health insurers with regard to injuries sustained while under influence of alcohol or controlled substance. (BDR 57-207)

AN ACT relating to insurance; prohibiting certain health insurers from denying a claim solely because the claim involves an insured who was injured while intoxicated or under the influence of a controlled substance; prohibiting certain health insurers from cancelling or refusing to issue a policy or contract of health insurance solely because an insured or applicant has made such a claim; repealing a section in the Uniform Health Policy Provision Law which allows certain health insurers to deny claims involving losses sustained by an insured while intoxicated or under the influence of a narcotic; providing penalties; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

- 1 Under existing law, certain health insurers may deny a claim because the
2 insured person was injured while under the influence of alcohol or drugs.
3 (NRS 689A.280)
4 This bill repeals that existing law. This bill further specifically prohibits certain
5 health insurers from denying a claim solely because the insured person was injured
6 while under the influence of alcohol or drugs. This bill also prohibits certain health
7 insurers from cancelling or refusing to issue a policy solely because an insured
8 person or a person eligible to apply for the policy has made such a claim.
9 Health insurers violating the provisions of this bill are subject to the general
10 penalty provisions that apply to all types of insurers and to any specific penalty



11 provisions that apply to particular types of health insurers. (NRS 679A.180,
12 695A.580, 695C.350, 695D.300, 695F.360)

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 689A of NRS is hereby amended by
2 adding thereto a new section to read as follows:

3 *An insurer shall not:*

4 1. *Deny a claim under a policy of health insurance solely*
5 *because the claim involves an injury sustained by an insured as a*
6 *consequence of being intoxicated or under the influence of a*
7 *controlled substance.*

8 2. *Cancel a policy of health insurance solely because an*
9 *insured has made a claim involving an injury sustained by the*
10 *insured as a consequence of being intoxicated or under the*
11 *influence of a controlled substance.*

12 3. *Refuse to issue a policy of health insurance to an eligible*
13 *applicant solely because the applicant has made a claim involving*
14 *an injury sustained by the applicant as a consequence of being*
15 *intoxicated or under the influence of a controlled substance.*

16 **Sec. 2.** NRS 689A.180 is hereby amended to read as follows:

17 689A.180 Except as *otherwise* provided in NRS 689A.040, no
18 such policy delivered or issued for delivery to any person in this
19 State may contain provisions respecting the matters set forth in NRS
20 689A.190 to ~~689A.280,~~ 689A.270, inclusive, unless the provisions
21 are in the words in which the provisions appear in the applicable
22 section, except that the insurer may, at its option, use in lieu of any
23 such provision a corresponding provision of different wording
24 approved by the Commissioner which is not less favorable in any
25 respect to the insured or the beneficiary. Any such provision
26 contained in the policy must be preceded individually by the
27 appropriate caption or, at the option of the insurer, by such
28 appropriate individual or group captions or subcaptions as the
29 Commissioner may approve.

30 **Sec. 3.** Chapter 689B of NRS is hereby amended by adding
31 thereto a new section to read as follows:

32 *An insurer shall not:*

33 1. *Deny a claim under a policy of group health insurance*
34 *solely because the claim involves an injury sustained by an*
35 *insured as a consequence of being intoxicated or under the*
36 *influence of a controlled substance.*

37 2. *Cancel a policy of group health insurance solely because*
38 *an insured has made a claim involving an injury sustained by the*



1 *insured as a consequence of being intoxicated or under the*
2 *influence of a controlled substance.*

3 *3. Refuse to issue a policy of group health insurance to an*
4 *eligible applicant solely because the applicant has made a claim*
5 *involving an injury sustained by the applicant as a consequence of*
6 *being intoxicated or under the influence of a controlled substance.*

7 **Sec. 4.** Chapter 689C of NRS is hereby amended by adding
8 thereto a new section to read as follows:

9 *A carrier shall not:*

10 *1. Deny a claim under a health benefit plan solely because*
11 *the claim involves an injury sustained by an insured as a*
12 *consequence of being intoxicated or under the influence of a*
13 *controlled substance.*

14 *2. Cancel participation under a health benefit plan solely*
15 *because an insured has made a claim involving an injury*
16 *sustained by the insured as a consequence of being intoxicated or*
17 *under the influence of a controlled substance.*

18 *3. Refuse participation under a health benefit plan to an*
19 *eligible applicant solely because the applicant has made a claim*
20 *involving an injury sustained by the applicant as a consequence of*
21 *being intoxicated or under the influence of a controlled substance.*

22 **Sec. 5.** Chapter 695A of NRS is hereby amended by adding
23 thereto a new section to read as follows:

24 *A society that provides health benefits shall not:*

25 *1. Deny a claim under a benefit contract solely because the*
26 *claim involves an injury sustained by an insured as a consequence*
27 *of being intoxicated or under the influence of a controlled*
28 *substance.*

29 *2. Cancel a benefit contract solely because an insured has*
30 *made a claim involving an injury sustained by the insured as a*
31 *consequence of being intoxicated or under the influence of a*
32 *controlled substance.*

33 *3. Refuse to issue a benefit contract to an eligible applicant*
34 *solely because the applicant has made a claim involving an injury*
35 *sustained by the applicant as a consequence of being intoxicated*
36 *or under the influence of a controlled substance.*

37 **Sec. 6.** Chapter 695B of NRS is hereby amended by adding
38 thereto a new section to read as follows:

39 *A medical services corporation that issues contracts for*
40 *hospital, medical or dental services shall not:*

41 *1. Deny a claim under such a contract solely because the*
42 *claim involves an injury sustained by an insured as a consequence*
43 *of being intoxicated or under the influence of a controlled*
44 *substance.*



1 2. *Cancel such a contract solely because an insured has made*
2 *a claim involving an injury sustained by the insured as a*
3 *consequence of being intoxicated or under the influence of a*
4 *controlled substance.*

5 3. *Refuse to issue such a contract to an eligible applicant*
6 *solely because the applicant has made a claim involving an injury*
7 *sustained by the applicant as a consequence of being intoxicated*
8 *or under the influence of a controlled substance.*

9 **Sec. 7.** Chapter 695C of NRS is hereby amended by adding
10 thereto a new section to read as follows:

11 *A health maintenance organization shall not:*

12 1. *Deny a claim under a health care plan solely because the*
13 *claim involves an injury sustained by an enrollee as a*
14 *consequence of being intoxicated or under the influence of a*
15 *controlled substance.*

16 2. *Cancel participation under a health care plan solely*
17 *because an enrollee has made a claim involving an injury*
18 *sustained by the enrollee as a consequence of being intoxicated or*
19 *under the influence of a controlled substance.*

20 3. *Refuse participation under a health care plan to an eligible*
21 *applicant solely because the applicant has made a claim involving*
22 *an injury sustained by the applicant as a consequence of being*
23 *intoxicated or under the influence of a controlled substance.*

24 **Sec. 8.** Chapter 695D of NRS is hereby amended by adding
25 thereto a new section to read as follows:

26 *An organization for dental care shall not:*

27 1. *Deny a claim under a plan for dental care solely because*
28 *the claim involves an injury sustained by a member as a*
29 *consequence of being intoxicated or under the influence of a*
30 *controlled substance.*

31 2. *Cancel participation under a plan for dental care solely*
32 *because a member has made a claim involving an injury sustained*
33 *by the member as a consequence of being intoxicated or under the*
34 *influence of a controlled substance.*

35 3. *Refuse participation under a plan for dental care to an*
36 *eligible applicant solely because the applicant has made a claim*
37 *involving an injury sustained by the applicant as a consequence of*
38 *being intoxicated or under the influence of a controlled substance.*

39 **Sec. 9.** NRS 695F.090 is hereby amended to read as follows:

40 695F.090 Prepaid limited health service organizations are
41 subject to the provisions of this chapter and to the following
42 provisions, to the extent reasonably applicable:

43 1. NRS 687B.310 to 687B.420, inclusive, concerning
44 cancellation and nonrenewal of policies.



- 1 2. NRS 687B.122 to 687B.128, inclusive, concerning
- 2 readability of policies.
- 3 3. The requirements of NRS 679B.152.
- 4 4. The fees imposed pursuant to NRS 449.465.
- 5 5. NRS 686A.010 to 686A.310, inclusive, concerning trade
- 6 practices and frauds.
- 7 6. The assessment imposed pursuant to NRS 679B.700.
- 8 7. Chapter 683A of NRS.
- 9 8. To the extent applicable, the provisions of NRS 689B.340 to
- 10 689B.590, inclusive, and chapter 689C of NRS relating to the
- 11 portability and availability of health insurance.
- 12 9. NRS 689A.035, 689A.410 and 689A.413 ~~H~~ *and section 1*
- 13 *of this act.*
- 14 10. NRS 680B.025 to 680B.039, inclusive, concerning
- 15 premium tax, premium tax rate, annual report and estimated
- 16 quarterly tax payments. For the purposes of this subsection, unless
- 17 the context otherwise requires that a section apply only to insurers,
- 18 any reference in those sections to “insurer” must be replaced by a
- 19 reference to “prepaid limited health service organization.”
- 20 11. Chapter 692C of NRS, concerning holding companies.
- 21 12. NRS 689A.637, concerning health centers.

22 **Sec. 10.** Chapter 695G of NRS is hereby amended by adding
23 thereto a new section to read as follows:

24 *A managed care organization shall not:*

25 *1. Deny a claim under a health care plan solely because the*
26 *claim involves an injury sustained by an insured as a consequence*
27 *of being intoxicated or under the influence of a controlled*
28 *substance.*

29 *2. Cancel participation under a health care plan solely*
30 *because an insured has made a claim involving an injury*
31 *sustained by the insured as a consequence of being intoxicated or*
32 *under the influence of a controlled substance.*

33 *3. Refuse participation under a health care plan to an eligible*
34 *applicant solely because the applicant has made a claim involving*
35 *an injury sustained by the applicant as a consequence of being*
36 *intoxicated or under the influence of a controlled substance.*

37 **Sec. 11.** NRS 287.010 is hereby amended to read as follows:

38 287.010 1. The governing body of any county, school
39 district, municipal corporation, political subdivision, public
40 corporation or other local governmental agency of the State of
41 Nevada may:

42 (a) Adopt and carry into effect a system of group life, accident
43 or health insurance, or any combination thereof, for the benefit of its
44 officers and employees, and the dependents of officers and
45 employees who elect to accept the insurance and who, where



1 necessary, have authorized the governing body to make deductions
2 from their compensation for the payment of premiums on the
3 insurance.

4 (b) Purchase group policies of life, accident or health insurance,
5 or any combination thereof, for the benefit of such officers and
6 employees, and the dependents of such officers and employees, as
7 have authorized the purchase, from insurance companies authorized
8 to transact the business of such insurance in the State of Nevada,
9 and, where necessary, deduct from the compensation of officers and
10 employees the premiums upon insurance and pay the deductions
11 upon the premiums.

12 (c) Provide group life, accident or health coverage through a
13 self-insurance reserve fund and, where necessary, deduct
14 contributions to the maintenance of the fund from the compensation
15 of officers and employees and pay the deductions into the fund. The
16 money accumulated for this purpose through deductions from the
17 compensation of officers and employees and contributions of the
18 governing body must be maintained as an internal service fund as
19 defined by NRS 354.543. The money must be deposited in a state or
20 national bank or credit union authorized to transact business in the
21 State of Nevada. Any independent administrator of a fund created
22 under this section is subject to the licensing requirements of chapter
23 683A of NRS, and must be a resident of this State. Any contract
24 with an independent administrator must be approved by the
25 Commissioner of Insurance as to the reasonableness of
26 administrative charges in relation to contributions collected and
27 benefits provided. The provisions of NRS 689B.030 to 689B.050,
28 inclusive, and 689B.575 *and section 3 of this act* apply to coverage
29 provided pursuant to this paragraph, except that the provisions of
30 NRS 689B.0359 do not apply to such coverage.

31 (d) Defray part or all of the cost of maintenance of a self-
32 insurance fund or of the premiums upon insurance. The money for
33 contributions must be budgeted for in accordance with the laws
34 governing the county, school district, municipal corporation,
35 political subdivision, public corporation or other local governmental
36 agency of the State of Nevada.

37 2. If a school district offers group insurance to its officers and
38 employees pursuant to this section, members of the board of trustees
39 of the school district must not be excluded from participating in the
40 group insurance. If the amount of the deductions from compensation
41 required to pay for the group insurance exceeds the compensation to
42 which a trustee is entitled, the difference must be paid by the trustee.



1 **Sec. 12.** NRS 287.04335 is hereby amended to read as
2 follows:

3 287.04335 If the Board provides health insurance through a
4 plan of self-insurance, it shall comply with the provisions of NRS
5 689B.255, 695G.150, 695G.160, 695G.164, 695G.170, 695G.173
6 *and section 10 of this act*, 695G.200 to 695G.230, inclusive, and
7 695G.241 to 695G.310, inclusive, in the same manner as an insurer
8 that is licensed pursuant to title 57 of NRS is required to comply
9 with those provisions.

10 **Sec. 13.** 1. Except as otherwise provided in subsection 2, any
11 provision in a policy or contract that conflicts with the provisions of
12 this act is void and must not be given effect to the extent that it
13 conflicts with the provisions of this act.

14 2. An insurer or other organization providing health coverage
15 under chapter 287, 689A, 689B, 689C, 695A, 695B, 695C, 695D,
16 695F or 695G of NRS may deny a claim involving an injury
17 sustained by a person as a consequence of being intoxicated or
18 under the influence of a controlled substance if the injury occurred
19 before October 1, 2005, and the denial of the claim is based on a
20 provision in a policy or contract that was in effect at the time of the
21 injury.

22 **Sec. 14.** NRS 689A.280 is hereby repealed.

TEXT OF REPEALED SECTION

689A.280 Intoxicants and narcotics.

1. There may be a provision as follows:

Intoxicants and Narcotics: The insurer is not liable for any loss sustained or contracted in consequence of the insured's being intoxicated or under the influence of any narcotic unless administered on the advice of a physician.

2. If the insurer includes the provision set forth in subsection 1, he shall also provide that such provision in no way affects benefits payable for the treatment of alcohol or drug abuse, as required by subsection 9 of NRS 689A.030.
