

ASSEMBLY BILL NO. 93—COMMITTEE ON WAYS AND MEANS

(ON BEHALF OF THE DEPARTMENT OF ADMINISTRATION)

SUMMARY—Makes supplemental appropriation to State Distributive School Account for unanticipated expenses for Fiscal Year 2004-2005 for providing health care subsidies to retired school district employees. (BDR S-1187)

AN ACT making a supplemental appropriation to the State Distributive School Account for unanticipated expenses for Fiscal Year 2004-2005 for providing health care subsidies to retired school district employees; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Section 189.28 of Chapter 5, Statutes of Nevada
2 2003, 20th Special Session, at page 244, is hereby amended to read
3 as follows:

4 Sec. 189.28. 1. There is hereby appropriated from the
5 State General Fund to the State Distributive School Account
6 in the State General Fund created pursuant to NRS 387.030:

7 For the 2003-2004 Fiscal Year \$637,789,627

8 For the 2004-2005 Fiscal Year \$767,086,697

9 2. The money appropriated by subsection 1 must be:

1 (a) Expended in accordance with NRS 353.150 to
2 353.245, inclusive, concerning the allotment, transfer, work
3 program and budget; and

4 (b) Work-programmed for the 2 separate Fiscal Years
5 2003-2004 and 2004-2005, as required by NRS 353.215.
6 Work programs may be revised with the approval of the
7 Governor upon the recommendation of the Chief of the
8 Budget Division of the Department of Administration.

9 3. Transfers to and from allotments must be allowed and
10 made in accordance with NRS 353.215 to 353.225, inclusive,
11 after separate considerations of the merits of each request.

12 4. The sums appropriated by subsection 1 are available
13 for either fiscal year or may be transferred to Fiscal Year
14 2002-2003. Money may be transferred from one fiscal year to
15 another with the approval of the Governor upon the
16 recommendation of the Chief of the Budget Division of the
17 Department of Administration. If funds appropriated by
18 subsection 1 are transferred to Fiscal Year 2002-2003, any
19 remaining funds in the State Distributive School Account
20 after all obligations have been met that are not subject to
21 reversion to the State General Fund must be transferred back
22 to Fiscal Year 2003-2004. Any amount transferred back to
23 Fiscal Year 2003-2004 must not exceed the amount originally
24 transferred to Fiscal Year 2002-2003.

25 5. Any remaining balance of the appropriation made by
26 subsection 1 for the 2003-2004 Fiscal Year must be
27 transferred and added to the money appropriated for the
28 2004-2005 Fiscal Year and may be expended as that money is
29 expended.

30 6. Any remaining balance of the appropriation made by
31 subsection 1 for the 2004-2005 Fiscal Year, including any
32 money added thereto pursuant to the provisions of
33 subsections 3 and 5, must not be committed for expenditure
34 after June 30, 2005, and **[reverts] must be reverted** to the
35 State General Fund **[as soon as all payments of money
36 committed have been made.] on or before September 16,
37 2005.**

38 **Sec. 2.** 1. There is hereby appropriated from the State
39 General Fund to the State Distributive School Account created by
40 NRS 387.030 in the State General Fund the sum of \$7,912,640 for
41 unanticipated expenses for Fiscal Year 2004-2005 for providing
42 health care subsidies to retired school district employees. This
43 appropriation is supplemental to that made by section 189.28 of
44 chapter 5, Statutes of Nevada 2003, 20th Special Session, at
45 page 244.

1 2. Any remaining balance of the supplemental appropriation
2 made by subsection 1 must not be committed for expenditure after
3 June 30, 2005, and must be reverted to the State General Fund on or
4 before September 16, 2005.

5 **Sec. 3.** The Department of Education shall, from the money
6 appropriated pursuant to section 2 of this act, make an allocation to
7 each school district in the proportion of its obligation to the total
8 obligation for all school districts.

9 **Sec. 4.** This act becomes effective upon passage and approval.
