ASSEMBLY CONCURRENT RESOLUTION—Urging the Commission on Economic Development to develop programs for economic development and stimulate employment within certain areas.

1 WHEREAS, The health, safety and welfare of the people of this
2 State are dependent upon a healthy economy and vibrant
3 communities; and

4 WHEREAS, The continual encouragement, development, growth
5 and expansion of private enterprise within the State requires a
6 cooperative and continuous partnership between government and
7 private organizations; and

8 WHEREAS, There are certain depressed areas in this State that
9 need the particular attention of government, business, labor and
10 residents of Nevada to help attract private investment into the area;
11 and

12 WHEREAS, Many older neighborhoods in urban areas including
13 the area designated as Assembly District 6, which includes the area
14 known as “Old West Las Vegas,” are currently in dire need of
15 economic development; and

1 WHEREAS, These areas are fully populated communities located
2 in this State that have not benefited from new growth or new
3 industry entering the State; and

4 WHEREAS, Many members of these communities have been
5 taxpayers in this State for 30, 40 and even 50 years, and a portion of
6 the revenue from their tax dollars should be used for revitalization
7 and economic development in those communities; now, therefore,
8 be it

9 RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE
10 SENATE CONCURRING, That the Legislature hereby urges the
11 Commission on Economic Development to establish a special
12 program of economic development for the older neighborhoods in
13 depressed areas of this State to stimulate business and industrial
14 growth and effect revitalization; and be it further

15 RESOLVED, That the Commission on Economic Development is
16 hereby encouraged to begin the special program of economic
17 development by focusing on providing economic development
18 projects and providing access to the type of financing needed to
19 stimulate the growth of businesses and industries in the area known
20 as "Old West Las Vegas" which will provide the high quality jobs,
21 increased property values and enhanced standard of living desired
22 by all Nevadans; and be it further

23 RESOLVED, That the Chief Clerk of the Assembly prepare and
24 transmit a copy of this resolution to the Commission on Economic
25 Development.
